We are having a serious case of ~38quot;Vinegar Syndrome~38quot; among some of our non-doc microforms, but we have been advised to weed as much as possible to reduce the chance of further deterioration/contamination. Also, some other sources may have different charateristics. We have a fairly comprehensive set of ASI fiche, which is a commercial publication and includes a lot of Census, and these seem to hold up better over time than the GPO Census fiche for some reason (but they are definitely not silver). Evaluatue your mircoforms carefully before making a final decision to keep or weed fiche or paper.
