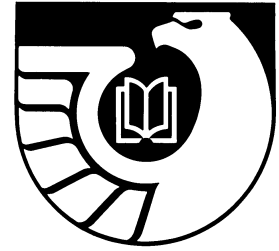

9:15 – 10:00 Government Documents Tell a Good Story Commonwealth

In spring of 2009 NMSU Library received an ALA/NEH grant (initiated by librarians Sylvia Ortiz and Mardi Mahaffy) to create programs related to the New Deal Writer's Project: "Soul of the People: Writing America's Story." Given the current economic climate, with the specter of the Great Depression looming large in the consciousness of the American people, this was a wonderful opportunity to look back at the project that employed hungry artists in the 1930s and contributed to the preservation of local history and oral tradition. For the opening event, a community-wide celebration of New Deal Writers, Dorothy Ormes, in her role as NMSU's new Government Documents Librarian, set out to glean interesting stories of Southern New Mexico. Using her skills as a professional storyteller she created a storytelling performance based on these tales. What she found was rich material that had been transcribed by the collectors of the day, some of whom were greeted less than enthusiastically by their subjects. She also found slave narratives from Texas online at the American Memory site. For the Community event, she produced a storytelling hour and had an opportunity to promote government documents as a living history resource. Dorothy will present an overview of the project and perform one of the stories from the event.

Depository libraries face challenges of staying in or perhaps leaving the federal depository program in part as a result of demands to reduce depository collection space due to severe budget cuts, limited staffing and the shortage of space. Mercer University's Jack Tarver Library depository recently initiated many reforms and changes in managing and maintaining its depository collections and services to cope with library-wide changes and reorganizations. This presentation will introduce practical strategies with an emphasis on identifying methods of changing a tangible collection into a more electronic collection without any disruption in service. The issue of reducing the tangible depository collection will be analyzed and steps to effectively combine weeding and dropping items will be discussed. Experience of seeking support from your library administrators through highlighting the value and benefits of participating in the FDLP program will also be shared. The future plan to promote the use of government information and to effectively manage the electronic collection will be provided.

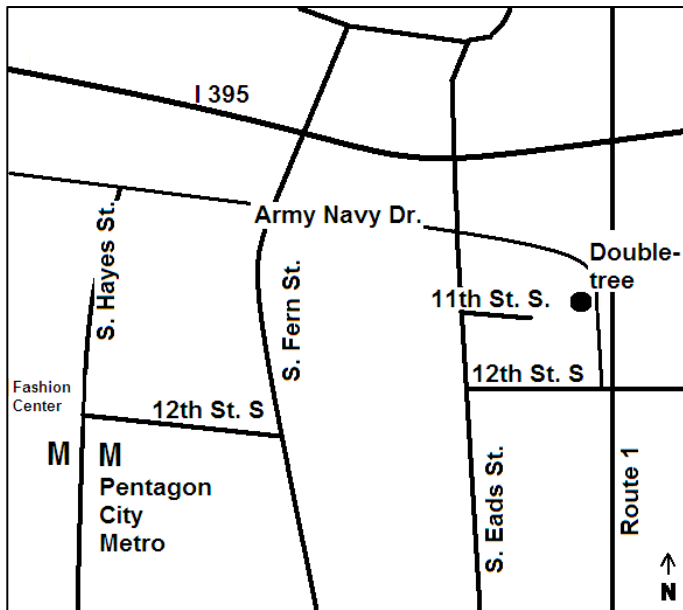
Getting to the Doubletree Hotel
