Amazing Fact #1

The definition of digital deposit is pretty straightforward. The how and what is dependent on which organizations are involved.



Amazing Fact #2

The FDL Community has been interested in Digital Deposit for nearly 2 decades!

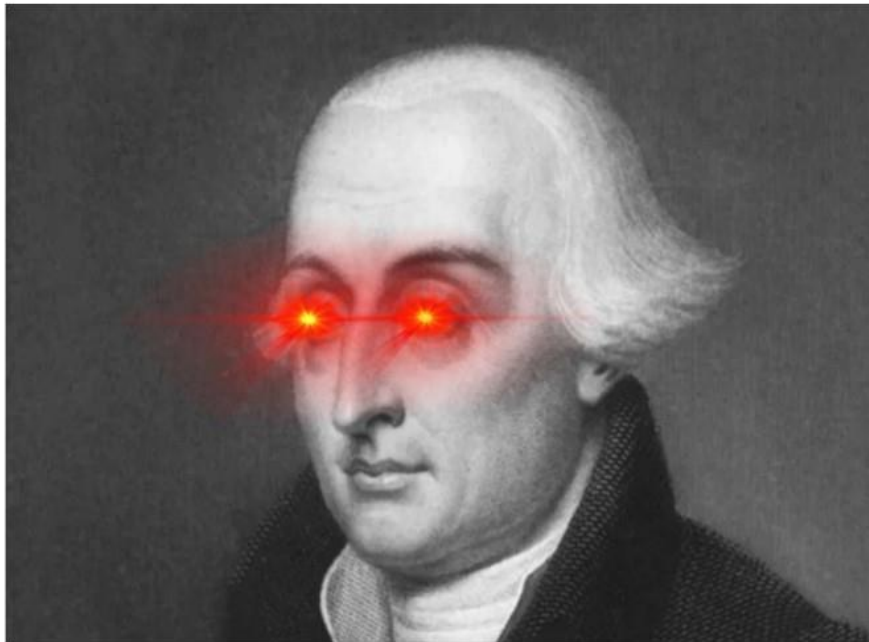
In 2005, responses to a Biennial Survey question showed 33% of respondents were interested in receiving digital files from GPO.





Digital Deposit Advocate: The government web grows exponentially every year.

The digital deposit novice:



“Between Fall 2016 and Spring 2017, the Internet Archive archived over 200 terabytes of government websites and data. This includes over 100TB of public websites and over 100TB of public data... This includes over 70 million html pages, over 40 million PDFs”

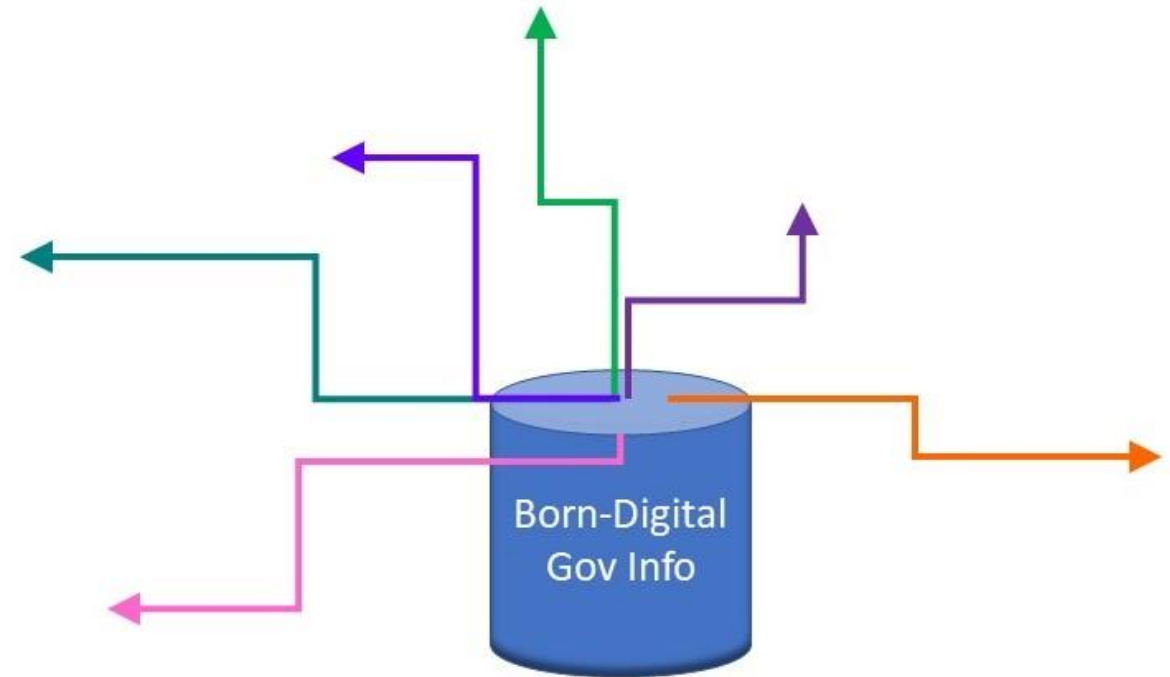

Digital Deposit is like the FDLP
we know and love, but with
born-digital assets instead of
tangible publications.

Digital Deposit can facilitate
distributed preservation and
widespread access to born-
digital government information.





Lots of Copies Keep Stuff Safe



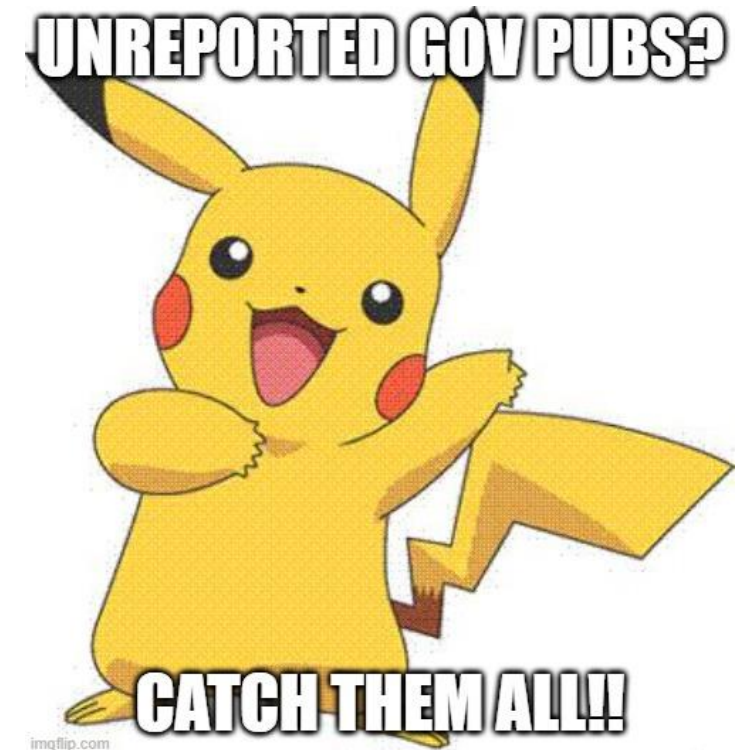
Amazing Fact #5

Redundancy is needed to ensure future public access and GPO will provide this capability, either by storage at multiple sites, by relying on preservation partners, or both mechanisms. (from the 2007 GPO white paper, *Digital Distribution*)

Amazing Fact #7
Hunting for uncataloged
publications can be exhausting
but it is valuable work

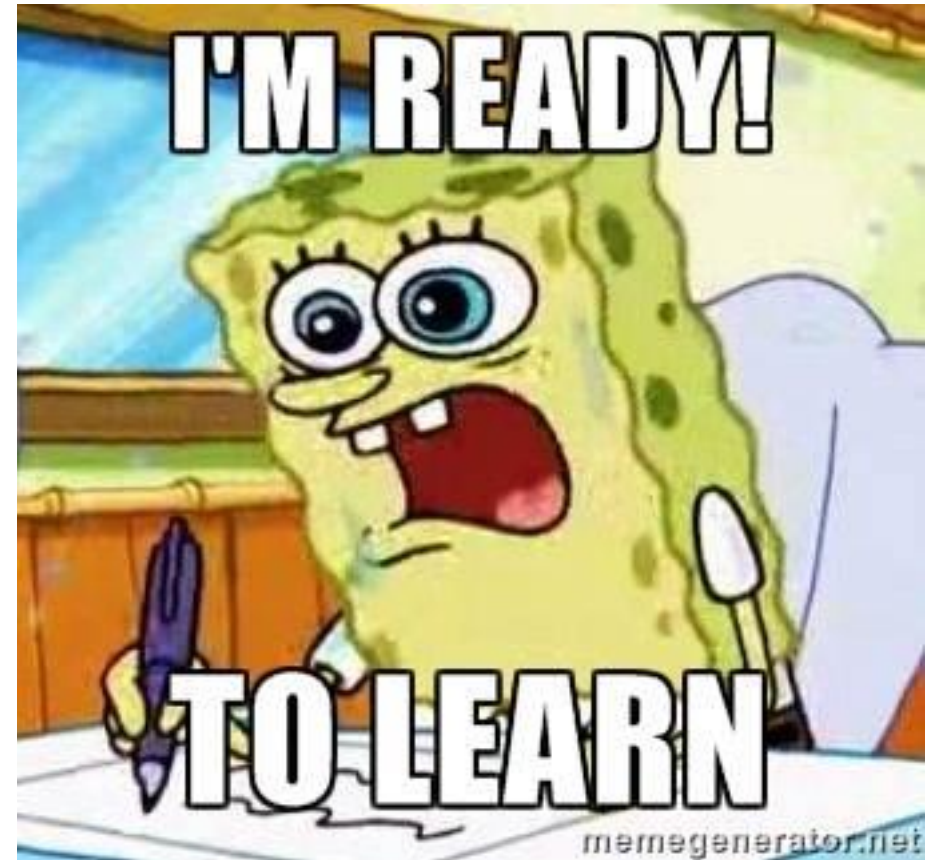
Congressionally Mandated
Reports Pilot volunteers spent
12,842 hours searching for
unreported publications



Amazing Fact #8
Pilot volunteers searched for
1049 publications.
Of these over half - 531 - are
still “lost,” 430 are now found,
and 88 were never lost



Amazing Fact #9
People want to learn how to search
for and report uncataloged /
unreported materials





Our focus groups support the use of askGPO for submitting unreported publications to GPO

Amazing Fact #10
askGPO is an effective tool for reporting uncataloged gov pubs





We interviewed librarians from ten different organizational use cases, and **all** were interested in the idea of digital deposit. They see it as valuable and feasible service, and most were eager to engage and participate in digital deposit.

Amazing Fact #11
Support for Digital Deposit is
strong regardless of library
type or size



Libraries were split on delivery models for receiving digital content through digital deposit (push and pull models, but also physical media delivery)

Recommendations to date

1. To accept the definition of digital deposit as the official GPO definition
2. Create an educational program to promote discovery and reporting of uncataloged publications
3. Recurring Biennial Survey question to gauge acceptance of digital deposit
4. Conduct a pilot project with a library to accept materials via digital deposit
 - a. Utilize GPO expertise to determine feasibility and process for testing digital deposit based on feedback from Visualizing Digital Deposit interviews
 - b. GPO will collaborate with pilot library to determine feasibility and mechanics of digital deposit
