# Biennial Survey of Depository Libraries: 2001 Results

## Introduction

The 2001 Biennial Survey of Depository Libraries was sent to nearly 1,300 depository libraries participating in the Federal Depository Library Program in October 2001. The survey was conducted online via World Wide Web. This report, a compilation of the results, is available at [http://www.access.gpo.gov/su\\_docs/fdlp/bisurvey/index.html](http://www.access.gpo.gov/su_docs/fdlp/bisurvey/index.html).

The optional questions on costs, as well as the individual free-text responses to fill-in-the blank questions, are not included in this report but are included in files on the Federal Bulletin Board site. The complete 1997 and 1999 responses can be found linked from the Biennial Survey of Depository Libraries homepage on the FDLP Desktop at [http://www.access.gpo.gov/su\\_docs/fdlp/bisurvey/index.html](http://www.access.gpo.gov/su_docs/fdlp/bisurvey/index.html).

The purpose of the Biennial Survey is to report on conditions in the depository libraries. Required by law (44 USC §1909), the Biennial Survey gathers data from all the depository libraries every 2 years, supplementing the more in-depth inspections or self-studies that are performed every 6 or 7 years.

Some responses were incomplete and could not be tabulated. Percentages may not add up to 100 in all cases because of rounding, answers left blank, and multiple answers. Six libraries indicated they did not intend to remain depositories and did not complete the survey. The final number of completed responses was 1286.

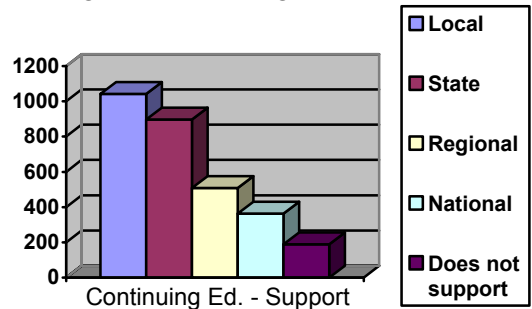
