Deborah Mongeau -> All Participants: Marie Concannon's suggestion of digitizing old microfiche would be a good idea. Microfiche is a very vulnerable medium and I don't see it surviving intact much beyond a few decades.

Carolyn Frenger -> All Participants: What about considering the establishment of a mentoring

program for library technicians who work with GPO depository documents about how to work on becoming FDLP coordinators if not in their current library positions, then in other GPO depository libraries.

Ashley Dahlen -> All Participants: Meet you back at 2:15 Eastern!

Mary Ann Ries -> All Participants: Besides the fiche, what about digital media that has out dated ~38quot;control software~38quot;; runs on old operating systems, etc.

Deborah Mongeau -> All Participants: On the topic of demographics, there's a lot of us who are going to retire in the next 5 to 10 years. I second the motion of having a central place to post techniques, tips, expertise where the senior librarians (in service, not age!) can transfer their knowledge to the next generation of experts.

Sarah Erikson -> All Participants: +1 Deborah. It seems many depository libraries rely on one person who ~38quot;knows that stuff~38quot; and do little to keep the machine working to the same capacity after that person has left.

Sarah Erikson -> All Participants: What can we do to help bring in more than the solo experts? We need more people getting intro level training in gov docs

Marion Scichilone -> All Participants: those currently providing intro level training sharing their tools and approaches

Asteria Ndulute -> All Participants: Yes to digitized Fiche and Yes to formulate a plan for fiche digitization

Sandy Himel -> All Participants: Read the wrong name... I second Kimberly Wirth on the update of older MARC records. Sorry. Also, yes on a plan for mentoring and training for new depository coordinators.

Aimee Quinn -> All Participants: Sarah Erikson - the best thing to do to bring more expertise is to bring your depository as a the research support to the other collections. For example, send links to add to subject and course libguides, ask to attend department faculty meetings with the subject library liaison so you may introduce government information that will help the faculty in their courses and in their research, especially undergraduate research and capstone projects, also introduce residence hall advisors and staff as well as gen ed faculty to government information which supports information literacy in their areas.

Beth Williams -> All Participants: Question for Amy Bunk: Any insight about the impact (if any) on the List of Sections Affected - either through this bill or in the future? I'm less concerned about the Federal Register Index than I am about the continuing publication of the LSA, which is a critical finding aid in using the FR with the CFR. Thanks!

Scott Matheson -> All Participants: Do we know if the ACOUS is interested in making something like eCFR an official version if they get the authority via this bill?

Kate Irwin-Smiler -> All Participants: I'm still worried about digital divide issues - both for people who don't have access and people who aren't good with computers.

Scott Matheson -> All Participants: Browsing codifications in print is still more efficient, especially for new users... they can understand the heirarchy better.

Kate Irwin-Smiler -> All Participants: +1 for ease of use. at least for the CFR.

John Olson -> All Participants: Concerns about future Government shutdowns. Keep it in print.

Kate Irwin-Smiler -> All Participants: I also want that language about gpo access updated before we start relying on it :)

Lisa Pritchard -> All Participants: I am at a very small rural library in an area with low educational attainment and having print versions of some important government documents can help our users understand the complexity, scope, and expertise that these documents contain.

They are often a way into the digital versions of the documents for an average citizen.

Tina Plottel -> All Participants: I agree with Cass

McKinley Sielaff -> All Participants: At times of gov. shutdowns, people come to library looking for paper since digital is not available, world doesn't stop when gov. does

Patricia Siska -> All Participants: I agree with Kate, Scott, and John

Aimee Quinn -> All Participants: I would like to see the print CFR as part of the Essential Titles for depositories for the reasons Cass and Jane express.

Andrea Craley -> All Participants: We are not a law library, but we have a strong accredited paralegal studies program which uses these resources. Right now we keep 2 years worth of print on the shelves, about all we have room for. I feel I need to get the input of our paralegal faculty on this, as they do stress their students coming over to use the print versions as well.

Kris A -> All Participants: Agree with concerns about future government shut downs and the ability of some users to navigate online version

Scott Matheson -> All Participants: sorry - ~38quot;administrative conference of u.s.~38quot;

Aimee Quinn -> All Participants: Agree with Scott and Kris along with other reasons for an internet interruption

Scott Matheson -> All Participants: Thanks!

Jennifer O'Brien -> All Participants: We use both print and digital copies, and given the tech available to our users can be affected by power outages, network updates, authentication concerns, etc., I would prefer to continue to receive print issues.

Kimberly Wirth -> All Participants: I also see value for keeping the print version for the reasons previously mentioned. We are not a law library, but have graduate students who need to do legal research and a government shutdown, without a print copy in house, makes it challenging for students to complete their assignments.

Suzanne Ebanues -> All Participants: There is currently 1 Preservation Steward for the Federal Register.

Aimee Quinn -> All Participants: Suzanne Ebanues - are there any preservation stewards for the CFR?

Sinai Wood -> All Participants: Notre Dame I believe.

Sarah Erikson -> All Participants: University of Florida legal information center is a center of excellence for the CFR. But I'm not sure if we've got a preservation steward.

Aimee Quinn -> All Participants: Thanks Sinai and Sarah!

Suzanne Ebanues -> All Participants: Aimee Quinn- there are currently 2 Preservation Stewards for the CFR

Aimee Quinn -> All Participants: Many thanks, Suzanne.

Kate Irwin-Smiler -> All Participants: My recollection is that the bulk of the cost is for the set up, and that the actual printing hardly adds to the cost. Do we have those numbers?

Kate Irwin-Smiler -> All Participants: Thanks!

Gwen Sinclair -> All Participants: It sounds like there are compelling arguments for continuing to print the CFR and FR, and the cost savings is minimal, so I believe the issue brief should make note of these points.

Aimee Quinn -> All Participants: +1 Gwen

Sarah Erikson -> All Participants: While the numbers of print subscriptions have exponentially decreased, do we have any info on participation in the regulatory process - those using systems like print FR vs regulations.gov?

Tina Plottel -> All Participants: not just government shut downs but weather events and natural disasters when internet isn't accessible.

Scott Matheson -> All Participants: Happy to hear about the improvements to agency ~38gt; OFR workflows!
