DLC Fall Recommendations

Laurie B. Hall, Superintendent of Documents & Managing Director of LSCM, GPO



Recommendation #1: Council recommends that GPO provide an update about the grant making authority proposal and study. We also recommend that GPO continue to monitor the possibility of a grant program for the future.

- Dec 2017 draft Title 44 bill included grant making authority
- LSCM investigated, worked with IMLS, earmarked funds
- H.R. 5305 eliminated grant making
- Investigative work ceased, funds on hold



Recommendation #2: Council recommends that GPO seek feedback regarding FDLPeXchange and commit to ongoing development and support. We recommend that GPO make submitted feedback publicly viewable and that GPO respond to feedback submitted via this public forum and report on the status of any fix requests.

- LSCM organizing virtual discussions – Feb 2019 and May 2019
- LSCM responsive to inquiries, shares feedback internally, Tips of the Week that reflect FAQs we receive
- Developing enhancement request form
 - Publicly-available Requirements Log & Known Issues Log
- Developing web pages for development news, public development calendar, analytics dashboard, enhancement form, release notes, & known issues and enhancements logs

Recommendation #3: Council recommends a working group to explore needs related to digital deposit - both dissemination of content and acceptance of content by GPO. At a minimum, two GPO staff, two DLC, and two FDLP community members should be appointed to serve on the Working Group for one year. Composition of the working group should be chosen by DLC in consultation with GPO staff. The Working Group should report findings and recommendations at the Fall 2019 FDLP annual meeting.

- LSCM submitted names of key GPO staff for working group; DLC approved.
- Preservation Services Pilot Strategies document released Dec 2018.
 - LSCM proposed the identification of a methodology for the collection of qualitative information from FDLs regarding the needs and expectations of “Digital Deposit” as a service of GPO.

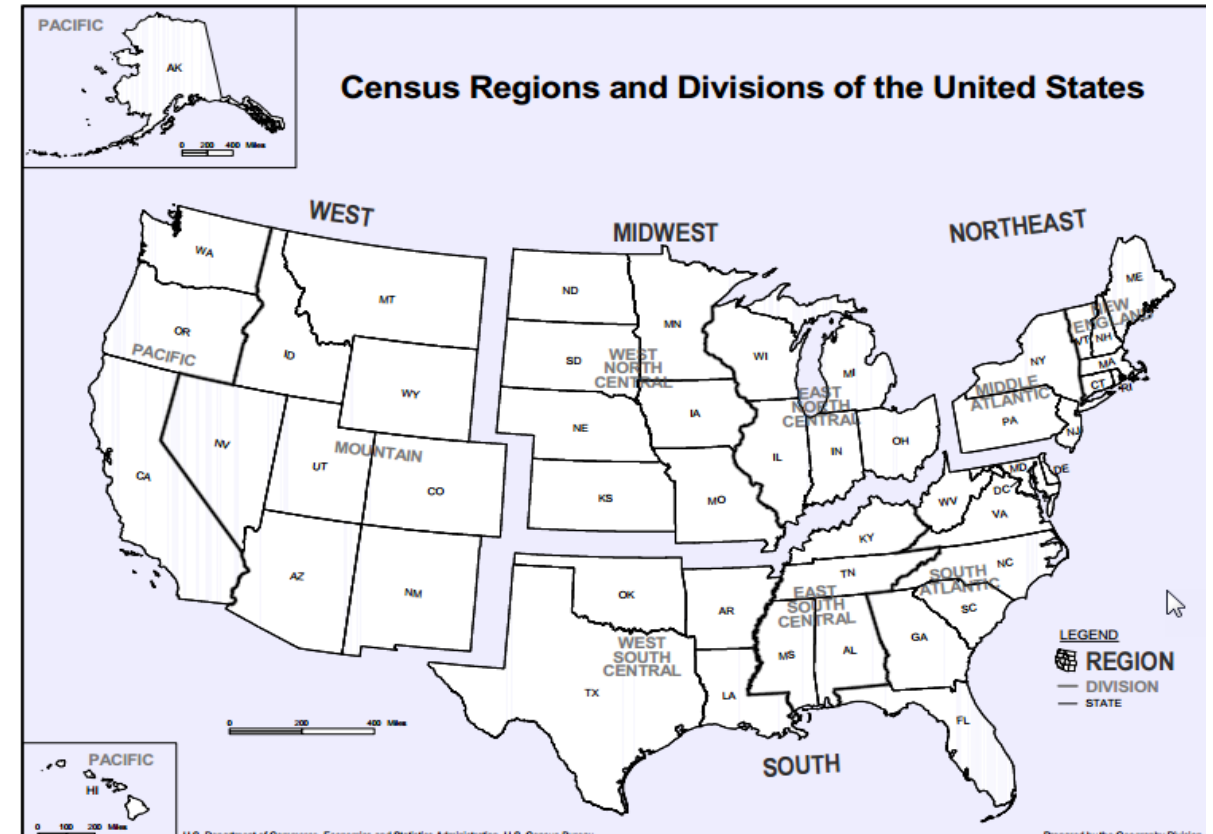
