CGP and LSCM Systems by the Numbers

- Nearly 29 million successful searches of the CGP in FY18
- Accessed by approximately 195 countries/entities, based on domain extensions
- Over a million CGP bibliographic records (over 186,000 have PURLs)

- ***New Titles Report Generator (NTRG) – FDLP Beta Version – CGP Tool***



Overview of CGP Tool

- The **New Titles Report Generator (NTRG) FDLP Beta Version** tool is a standalone Windows application developed in Perl/TK designed to process GPO MARC (.mrc) or MARC XML records and generate customized reports.
- It also has the option to match a set of records from the CGP against a file of a library's Item Selection Profile from DSIMS for a customized report and data set.



Overview of CGP Tool Use

FDL would need to download:

- Tool from *FDLP.gov File Repository*
- Item Selection Profile from *DSIMS*
- A CGP record set
 - From file repository or through CGP's Z39.50 service

Options for Reports:

- Report Formats:
 - CSV (Excel Compatible)
 - HTML
 - RTF formats
- Option for Title to be Hyperlinked to CGP Record
- Records format *
 - Electronic Only (EL)
 - Tangible Only
 - All Records

*If the option to match against the selection profile, the resulting data will also be limited by the option. For example, if there is a data set of both tangible and EL they are starting with, if EL only is chosen, both the resulting report and data set will be EL only.

CGP Tool – Call for Testers

- Phase 1 of internal testing - redevelopment of certain functionality (completed FY17)
- Discovered some functional issues due to changes in approaches to security and technology
 - Identified some known issues (FY18)
 - Determined the need for a Beta Test with the FDLP Community and began planning (FY18)
 - Developing a testing plan, test release, and training on the test tool (FY18 - present)
 - Formal Call for Testers (late 2018/early 2019)
 - Testing (2019)
- Review of feedback (FY19)
- Capture potential future enhancements or requirements communicated for future LSS (ongoing)



Beta Test of CGP Tool

Gauging Interest in Tool and Testing:

- Expressing interest is not making a commitment until the formal call for testers and the training plan is available.

Testers would:

- Be able to test the 64 bit version (is there a need for a 32 bit version?)
- Test
 - Use tool to generate report on data set
 - Use tool to limit report by item selection profile
 - Determine if there is a gap between what the tool reported and what should have been returned
- Capture and report issues, gaps, anomalies
- Suggest potential enhancements
- Provide comments or suggestions for a name for the tool
 - CGP TRDA (Titles Report and Data Application)
