





GPO's FDLP Academy is a free source for training opportunities, events, webinars, and webcasts for both the FDLP community and non-depository libraries. In FY 2019, the FDLP Academy hosted 35 webinars, with nearly 4,000 combined registrants. Training topics covered Government information resources such as data census gov, cataloging, collection and depository management, library marketing, and more. This year, 35 webcasts were produced by GPO staff on topics such as free catalog records available through the CGP on GitHub, how depository libraries can get usage statistics using the FDLP PURL Usage Report, **govinfo**, and FDLP eXchange. These recordings have been released via the FDLP Academy Training Repository. Additionally, more in-depth training was provided for selected depository library staff through two sessions of the FDLP Coordinator Certificate Program and the Regional Coordinator Program. 
