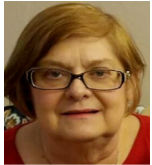

Prior to becoming an academic librarian, Ms. Sittel spent 9 years as Documents Coordinator for the Tulsa City-County Library where she was engaged state-wide in promoting and teaching the value and use of Government information.
