Legislative branch agency

- Work directly for Congress to track how taxpayer dollars are spent
- We do not "market" our work in the traditional sense
- Our work is widely used by the press and the public

Produce about 1,000 reports and testimonies each year

- CG appointments to Health Care review panels
- FraudNet

GAO Reports



GAO's Podcast



Overview

- Started in 2010
- Over 500 episodes
- Unscripted conversations with GAO experts about new work.





Formats



- Short, 5-7 min
- Covers 1 or 2 new reports



- Longer, 12-25 min
- Covers a portfolio of work or trending topic

How we make the podcast...

- Sit down with directors to discuss their reports, what they want people to know.
- Record 2 weeks before release
- 10-20 minute conversation = 5-6 minute podcast
- Aim for 5-10 episodes per month






Recent Podcasts

Listenership...

- About 1,000 listens each
- September had about 6,000 listens*
- Nearly 200,000 listens since we started current data collection approach
- 90% of listeners in the U.S.
