

Collaborate to provide:

- Permanent public access to electronic content.
- Access to services that allow Federal depository libraries to enhance their collections.
- Access to services and resources that connect the public to its Government's information.
- Access to resources that assist Federal depository libraries to manage their collections.
- Preserve tangible Federal depository collections.

LSCM Pilot Projects

- GPO does not have gift authority, but can carry out projects with libraries by providing resources and services on targeted initiatives
- Opportunity One: Closed October 15, 2021
 - Cataloging, item-level inventory, condition assessment, and digitization of between 200-300 monographs from the U.S. Department of War (formed 1789; dissolved 1947) Superintendent of Documents call number stem W or other warera temporary agencies.
- Opportunity Two: Closed April 15, 2022
 - Cataloging, item-level inventory, condition assessment, and digitization of a collection of 200-300 Federal Government print publications focused on a state, region, common theme, or topic, and preferably those without records in the Catalog of U.S. Government Publications.

Preservation

- As fewer copies of older material reside in libraries, it becomes more important to preserve/conserve what copies we do have

Outreach to Historically Black Colleges & Universities (HBCUs) & Tribal College Libraries

- Goal is to build upon the work library staff undertake supporting and serving their communities through:
 - Attendance and engagement at a variety of conferences, meetings, and workshops.
 - Direct communication with librarians at Tribal Libraries and HBCUs.
 - Recommending resources and collections of possible interest to the communities.
 - Tapping library staff for their expertise in identifying resources for inclusion in the FDLP
- GPO is monitoring library community discussions and developments in building diversity, equity, and inclusion (DEI)

The Coordinator

Responsibilities required of the depository coordinator:

- Serve as the point of contact with GPO, including emails, phone calls, surveys, recalls of publications etc.
- Participate in the Public Access Assessment of the depository collection.
- Maintain a thorough knowledge of the current legal requirements and Program regulations.

LRPR 31

Responsibilities that must be done, and are frequently handled by coordinator:

- Reading news & updates distributed via the FDLP News & Events email alert service (LRPR 4)
- Updating the Federal Depository Library Directory (LRPR 5)
- Biennial Surveys (LRPR 46)
- Item selection profile (LRPR 6)

The FDLP is changing (for the better)

A lot of energy has been directed at updating Title 44 of the USC.

We still aim to work with congress and the community to do that

But in the meantime - we are moving forward with re-interpreting the existing framework and enabling changes.

The 2015 JCP decision to permit regionals to weed material in certain circumstances, and the adoption of the Guidelines for Establishing Shared Regional Depository Libraries opened up a world of flexibility, enabling regionals to think at a larger level than just their local region.

Trends to look out for:

- Anything related to the National Collection
 - Fewer copies = increased scrutiny of what remains & increased collaborative efforts to manage it
 - Collaborative project opportunities are forthcoming as every cataloging, preservation, training, & digitization project ultimately ties in with the National Collection and the mission of the FDLP.
- New CGP ahead
- End of microfiche: It is the end of an era and a bit of a headache for those responsible for comprehensive collections
- LSS Library Services System
 - Bringing FDLP tools together
