Exploring the Durability of PURLs and their Alternatives Working Group

Working Group Charge Summary

Since March 1998, GPO has used Persistent Uniform Resource Locators (PURLs) to provide Federal depository libraries (FDLs) and other parties stable URL access to online Federal information. Due to changes in library collection policies, advances in technology, and an increase in the amount of born-digital and digital-only Federal information, along with an increased interest in some depositories becoming mostly or all digital depositories, Council created a working group to investigate the durability of PURLs and their alternatives and to present findings and recommendations to Council for consideration. Working Group Charge

“This working group will examine the practices, policies, and procedures enacted by FDLs since March 2020 as they adapted to the COVID-19 pandemic, and it will assess the long-term impact of these efforts at the institutional and national level. It will examine pandemic practices, policies, and procedures enacted by FDLs and the GPO relating to services, procedures, collections, staffing, etc., and it will assess whether such policies may or should continue into the post pandemic era.”

- Submit a final report by end of spring 2023
