FY 2022 was a year of transition in leadership at the U.S. Government Publishing Office (GPO). From May 2016 – October 2022, Laurie Hall served as both the Superintendent of Documents and the Managing Director of Library Services & Content Management (LSCM). In February 2022, Laurie informed GPO that she planned to resign as Superintendent upon selection of a successor and would continue to serve as the Managing Director of LSCM.

GPO Director Hugh Halpern enlisted the help of the executive search firm, JDG Associates, Ltd., and began the search for the next Superintendent in May 2022.

In September 2022, Director Halpern named Scott Matheson as the new Superintendent.

For the first time, this correspondence comes to you jointly, from two Superintendents of Documents.

LSCM OPERATIONAL UPDATES

LSCM organizational highlights in FY22 include the hiring of key personnel in Federal Depository Support Services (FDSS) and filling several vacancies for Technical Services Librarians. Top priorities for staffing continue to be improving customer services for our libraries and fulfilling our mandates for cataloging and indexing.

Additionally, with the organizational shift to greater flexibility in work-life balance for our LSCM staff, more options for full-time and routine telework allowed LSCM to condense our office footprint on the 5th floor of the GPO main headquarters building in Washington, D.C. The new, smaller workspace

enabled LSCM to continue to offer working areas to house all of our collections and processing needs, while offering new cubicle spaces for employees who come into the office on a situational basis to perform critical functions for the business unit. Overhead cost reductions and savings for the vacated space will be reallocated to key projects, such as digitization and systems migration.



THE NATIONAL COLLECTION OF U.S. GOVERNMENT PUBLIC INFORMATION

After a public comment period and resulting revisions, the final version of the *National Collection of U.S. Government Public Information Strategic Plan for FY 2023 – FY 2027* was released September 1, 2022. Thank you to all who provided comments on the plan. A [report on the public comments](#), and the [Depository Library Council's comments](#), are also available.

There are two organizational goals in the National Collection Plan:

- Create an organizational infrastructure that is “digital first.”
- Ensure LSCM has the necessary positions, and employees who have the necessary knowledge and skills to perform successfully, for a modern organization.

There are five National Collection goals:

- Enhance the customer experience.
- Increase access to Government information.
- Strengthen user confidence in online Government information.
- Increase services to Federal depository libraries.
- Increase interactions with Federal agencies and depository libraries.

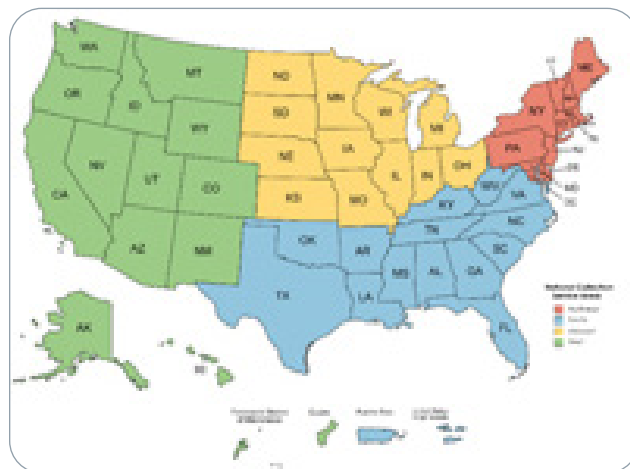
Thirteen of the 31 objectives are studies to be conducted or plans to be developed. These will be among the first to be undertaken as they will most assuredly result in additional objectives or actions to take. The National Collection Plan will be updated accordingly.

Our accomplishments from fiscal year to fiscal year will advance us toward our long-term goals, and ultimately, to realize our vision that “Federal Government information will be easily available when and where it is needed.”

In the meantime, the National Collection will continue to grow as partnerships increase and

LSCM enters into new collaborative relationships. As depository library coordinators weed their collections and use [FDLP eXchange](#), other depository libraries will provide new homes for publications offered. In addition, LSCM will obtain materials for digitization and ingest into GovInfo.

National Collection Service Areas (NCSAs) were defined in the National Collection Plan. They group Federal depository libraries into four regions of the country as a means of ensuring geographically-dispersed permanent public access to Federal Government information products, sharing resources among depository libraries, and receiving services from LSCM. The four geographic areas are Northeast, South, Midwest, and West.

FDSS librarians began meetings with the regionals in the NCSAs in March 2022. Meetings are now held quarterly.

FDSS is also developing a framework for staffing and providing services in the NCSAs; a plan to implement the framework will follow.

The National Collection is a strategic priority of the Superintendent of Documents. The importance of such a collection in a democratic society cannot be overestimated. It will allow current and future generations to have both physical and intellectual access to our Nation's history, as seen through the works of the Federal Government.

PARTNERSHIPS AND COLLABORATIONS

GPO Partnerships

Since 1997, GPO has developed strategic [partnerships](#) with Federal depository libraries, Federal agencies, and other institutions to increase public access to U.S. Government information.

Partnerships range from organizations that pledge to permanently preserve Government publications in their libraries, to organizations that make a commitment to retain and make publicly accessible, at no fee, digital resources within scope of the FDLP, to organizations that provide digital content to GPO for ingest into GovInfo, and more.

GPO's partner categories are:

- Preservation Steward (for historic, tangible content)
- Digital Preservation Steward
- Digital Content Contributor
- Digital Access Partner
- Cataloging and Metadata Contributor
- Other/Specialized

At the close of FY 2022, there were 74 official GPO partnerships:

- 46 Preservation Stewards
- 1 Digital Preservation Steward
- 7 Digital Content Contributors
- 7 Digital Access Partners
- 3 Cataloging and Metadata Partners

During FY 2022:

- 2,000 records for historic and borndigital legal reports from the Law Library of Congress were added to the Catalog of U.S. Government Publications (CGP).
- 266 records for Department of Interior, Office of Education publications held by the University of Minnesota Libraries were added to the CGP.

- 803 records for digital versions of U.S. Geological Survey (USGS) reports were added to the CGP through a partnership with Colorado School of Mines (CSM).
- Bibliographic records for 76 newly digitized titles on FRASER were added to the CGP (partnership with the Federal Reserve Bank of St. Louis).
- Utah State University became a Preservation Steward for Congressional material (historic and current) and publications from the Franklin D. Roosevelt administration.
- The following Preservation Stewards expanded the collections that they pledge to preserve:
 - Syracuse University Libraries: Statutes at Large and U.S. Code (historic and current).
 - Colorado School of Mines: Historic publications from the National Aeronautics and Space Administration (NASA), National Advisory Committee for Aeronautics (NACA), as well as the Trials of War Criminals Before Nuremberg Military Tribunals and MAGIC Background of Pearl Harbor.
 - University of Maine, Orono: Congressional material from STEM-related Congressional committees (current) and the Foreign Relations of the United States (historic and current).



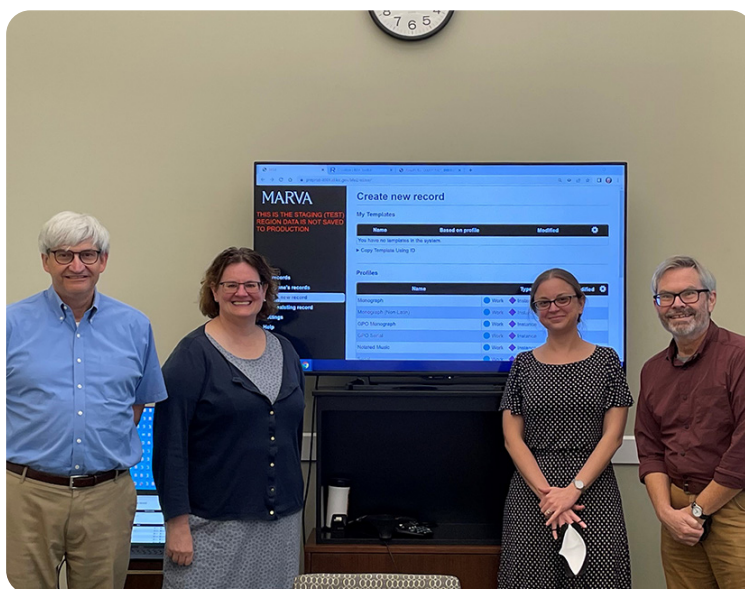

GPO Collaborations

In FY 2022, LSCM staff contributed to and collaborated with groups in support of the FDLP and C&I.

- GPO is continuing its collaboration with the Law Library of Congress to digitize and make accessible volumes of the [U.S. Congressional Serial Set](#) back to 1817. The Law Library of Congress is inventorying and digitizing the Serial Set, while GPO is focusing on metadata, the continued development of the GovInfo collection, and seeking any replacement volumes needed by the Law Library. Digitization began in fall 2019 and will continue for some time.
- In a collaboration with the Law Library of Congress, LSCM is cataloging *Global Legal Research Directorate Reports* to increase public access. In FY22, LSCM cataloged 1,109 of these reports.
- As a member of the Program for Cooperative Cataloging (PCC), LSCM is preparing to adopt the new iteration of the Resource Description and Access (RDA) cataloging standard. In FY 2022, LSCM began serving on the PCC's Task Group to Test the Official RDA Toolkit, which is assessing usability of the LC-PCC Policy Statements and Metadata Guidance Documentation. Results from the test will



be used to improve PCC documentation and develop PCC training.

- During the spring and summer of 2022, LSCM partnered with the Library of Congress to test the Library's BIBFRAME editor, Marva. LSCM staff members used Marva to catalog according to BIBFRAME, a new model created by the Library of Congress to serve as a replacement (or alternative) to MARC 21. LSCM gained firsthand experience with BIBFRAME and provided the Library of Congress with insight into Marva features needed by other institutions.
- LSCM is a partner in the [Library of Congress Cataloging in Publication \(CIP\) Program](#). The CIP Program provides cataloging records for books in advance of publication. The publisher then includes the record on the verso of the publication's title page. Through CIP, LSCM is creating pre-publication bibliographic records for publications from Federal agency publishers. LSCM has been a part of the CIP Program since 2015 and took on an additional role as a publisher in 2019. Staff submitted two titles through the publisher portal, cataloged 35 titles, and created 24 authority records in FY 2022. LSCM staff have created CIP records for GPO, the Combat Studies Institute, the Air Force Research Institute, the Smithsonian

Institution Scholarly Press, USGS, and the National Gallery of Art, to name a few.

- Beginning in 2015, LSCM began a partnership with the Colorado School of Mines (CSM). The partnership involves adapting CSM bibliographic records for items housed in their collection received from USGS. To date, 13,263 records have been added to the CGP as part of this cataloging partnership, with 572 new records added in FY 2022. The records cover five USGS series including: Bulletins, Water Supply Papers, Circulars, Water Resources Investigations, and Professional Papers. As an added service to the FDLP community, GPO's Library Technical Services (LTS) also cataloged the online versions for the same five series, when available.

LSCM Pilot Projects

LSCM embarked on an initiative in FY 2021, seeking Federal depository libraries to conduct [Pilot Projects](#) in support of the FDLP. LSCM is carrying out these projects in conjunction with libraries, providing resources and services to assist with targeted initiatives. Pilot projects address the areas of cataloging, condition assessment, inventory, and the conservation of Federal Government documents. Both regional and selective libraries are encouraged to apply.

These jointly-conducted projects are an opportunity for collaboration between LSCM and Federal depository libraries; they benefit the FDLP community and ultimately enhance access to the [National Collection of U.S. Government Public Information](#).

In FY 2021, Pilot Project Opportunity 1 was announced. It was scoped as follows:

- Cataloging, item-level inventory, condition assessment, and digitization of between 200-300 monographs from the U.S. Department of War (formed 1789; dissolved 1947) Superintendent of Documents call number stem W or other war-era temporary agencies.
 - The scope of the documents should be either the U.S. war years of WWI (1914-1918) or WWII (1941-1945).

Utah State University's Merrill Cazier Library was selected as the first LSCM Pilot Project participant. An inventory and collection assessment were conducted in spring 2022 on a small collection of documents within an Executive Branch War-time Agency. In FY22, work began on the cataloging of batches of documents, and preparation for digitization is underway.

The second pilot project opportunity, Pilot Project Opportunity 2, was scoped as follows:

- Cataloging, item-level inventory, condition assessment, and digitization of a collection of 200-300 Federal Government print publications focused on a state, region, common theme, or topic, and preferably those without records in the CGP.
 - a. Suggested collections may include, but are not limited to:
 - i. Publications issued by regional Federal offices or agencies.
 - ii. Publications in the areas of voting, civil rights, women's suffrage, or tribal rights.
 - iii. Publications on environmental or geographic region-based topics, such as waterways, land rights, energy sources, or establishment of national parks.

Pilot Project Opportunity 2 was open for submissions between March 1 - April 15, 2022, and the University of North Texas Libraries (UNT) was selected as

the second LSCM Pilot Project participant in [July 2022](#). The UNT pilot project proposed to focus on a selection of UNT's World War II-era military technical manuals. Since that time, the collaborative LSCM/UNT Libraries team has:

- Conducted a preliminary inventory of the selected World War II-era military technical manuals held at UNT.
- Drafted a project plan.

Pilot Project 2 goals include:

- Digitizing the War Department and Department of the Army titles that are the focus of this partnership effort.
- Ingesting digital surrogates into GovInfo and supplying digital surrogates to the UNT Digital Library team for ingest into their Digital Preservation Steward repository.
- Enabling discovery of the titles via the CGP.
- Supporting the permanent preservation of the titles in the tangible format by including them in the UNT Libraries Preservation Steward collections.

Work on Pilot Project 2 is expected to continue into FY24.

As authorized by Chapter 19 of Title 44, U.S.C., the mission of the FDLP is to provide for free, ready, and permanent public access to Federal Government information, now and for future generations. The vision of the FDLP is to provide U.S. Government information when and where it is needed in order to create an informed citizenry and an improved quality of life.

Through this historic U.S. Government program, GPO disseminates information products from all three branches of the Federal Government to over 1,100 libraries nationwide designated as Federal depository libraries, directly by law or as depositories designated by their Representatives and Senators. Federal depository libraries maintain and provide free public access to Federal Government information products and provide expert assistance in navigating those resources. Providing free online access to Government publications is provided under the authority of Chapter 41 of Title 44, U.S.C., via GovInfo.

Task Force on a Digital FDLP

To contribute to the continued evolution of the FDLP, in FY 2021, in response to a recommendation of the Depository Library Council (DLC), GPO Director Hugh Halpern established a Task Force to study the feasibility of a digital FDLP. The 23-member [Task Force](#) has representation from the DLC, depository libraries of different types and sizes, library associations, Federal agencies, and GPO.

The Task Force worked throughout 2022 to investigate whether a digital FDLP is possible, and if so, to define the scope of a digital depository program and make recommendations as to how to implement and operate such a program. The Task Force's purview included an examination of the current landscape in FDLs, of FDLP-related operations at the GPO, and of the dissemination of publications by Federal agencies.

The [draft report](#) of the Task Force was available for public comment from September 14 – October 14,

2022. Public comments were reviewed thoroughly by the Task Force and evaluated for inclusion in the final report, which was made available to the FDLP community in early FY 2023.

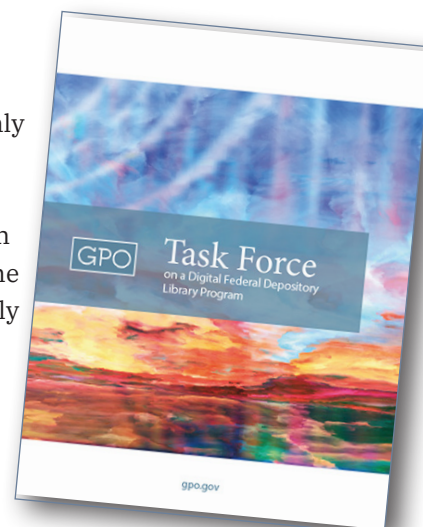
Shared Regionals

The depository libraries at Louisiana State University, Baton Rouge (LSU); Louisiana Tech University (LA Tech); and the University of Mississippi (UM) became the FDLP's newest shared regional depository libraries in FY22. Senator Bill Cassidy of Louisiana and Senator Roger Wicker of Mississippi approved the arrangement and made the shared regional designations. This regional agreement across state lines is the first between three libraries.

The Memorandum of Understanding (MOU) was signed by the library deans and became effective October 5, 2021. In accordance with the MOU, each retains full regional depository status in its relationship to the selective depositories in its state. Furthermore, the regional depositories will collaboratively and comprehensively collect and maintain publications of the FDLP according to agency and format designations outlined in their implementation plan, which was approved by the Superintendent of Documents.

GPO offers congratulations and thanks to regional depository library coordinators Hayley Johnson (LSU), Ashley Dees (UM), and Sue McFadden (LA Tech) for spearheading this effort.

As the needs of libraries and their users are evolving, LSCM is working to meet those needs by offering new models of service and encouraging collaboration among depository libraries. If you are interested in, or have ideas for, a collaborative regional depository

Discontinuation of Microfiche Distribution to FDLP Libraries

GPO began distribution of microfiche in the mid-1970s as a cost and space-savings measure for Federal depository libraries. The Superintendent of



Documents announced at the 2021 Fall Depository Library Conference that the microfiche format would be phased out. The Discontinuation of Microfiche Distribution to FDLP Libraries project kicked off in early FY 2022 to manage the transition away from the format.

Viability of microfiche as a distribution format has fallen in recent years due to a number of factors:

- Newer technology has superseded the benefits.
- Microfiche distributed to depositories is not of preservation quality.
- End-user format preferences have largely changed over the years.
- Microfiche distribution lags significantly behind paper distribution and online availability.
- The number of vendors performing microfiche conversion is shrinking.

GPO began this undertaking in late 2021 by reaching out to FDLs selecting the Code of Federal Regulations (CFR) or the CFR Index in microfiche format. Items for the CFR and CFR Index, in paper, were added to library item selection profiles, based on

discussions with libraries. Additionally, each CFR title was assigned a separate item number, allowing libraries to profile for only the titles of interest to their collections. Beginning in January 2022, GPO met with regional depositories to discuss the issue of format preferences in their FDLP regions.

In March 2022, the microfiche contract for the CFR and the CFR Index and Finding Aids ended. In April 2022, the microfiche contract for the House and Senate Journals, as well as documents with Y 1 and Y 4 SuDocs stems, ended. In September 2022, the microfiche contract for the bound Congressional Record ended. The daily Congressional Record, Federal Register, and List of CFR Sections Affected continued into FY 2023.

Through the year, LSCM staff continued to work with FDLs to assist in adding paper items to library item selection profiles, recruit Preservation Stewards and Print Selectors to ensure access to the titles, and encourage collection development collaboration among FDLs.

LSCM will continue to update the FDLP community through FDLP.gov’s [Discontinuation of Microfiche Distribution to FDLP Libraries](#) project page.

FDLP Distribution Services

At GPO’s Distribution Facility in Laurel, Maryland, the GPO staff continue to distribute publications, fulfill claims, and send special mailings of tangible items





to Federal depository libraries and international libraries participating in the International Exchange Service.

In FY 2022, the Depository Distribution staff distributed 4,371 titles, totaling 644,874 copies of materials, to FDLP libraries.

At GPO's Pueblo Distribution Center in Pueblo, Colorado, the staff distributes FDLP promotional items to FDLP libraries nationwide. As of the end of FY 2022, the Pueblo staff managed the inventory and dissemination of 27 different types of FDLP handouts and promotional items.

Superintendent of Documents: Open & Transparent

The Superintendent of Documents seeks comments from the depository library community, interested stakeholders, and the general public on various documents, including draft policies, through FDLP.gov's [Open Requests for Comments](#) and [Closed Requests for Comments](#) pages. When comments are sought, an entry is added to the Open Requests page for the duration of the comment period. The Closed

Requests page serves as a record of the comment process, providing an entry for any document for which a call for comments was made. An entry includes a link to the comments received.

FDLP Academy

Since its inception in 2012, the goals of the [FDLP Academy](#) have been to support the FDLP community's education and training needs and to advance U.S. Government information literacy.

The FDLP Academy enhances U.S. Government information knowledge through events, conferences, webinars, and webcasts coordinated by GPO that



cover a variety of Government information topics. Many sessions are presented by GPO staff; other sessions are presented by staff from various Federal agencies and from members of the FDLP community, as recruited and hosted by GPO. At the close of FY22, the FDLP Academy hosted over 600 webinars with over 78,000 combined registrants and produced almost 175 webcasts.

In FY 2022 alone, the FDLP Academy hosted 45 webinars with nearly 6,000 combined registrants and produced almost 20 recorded webcasts.

Also in FY 2022, LSCM hosted over 1,400 participants at the fall 2021 Federal Depository Library Conference and the spring 2022 Depository Library Council Virtual Meeting.

FDLP Coordinator Certificate Program

The [FDLP Coordinator Certificate Program](#) (CCP) presents an opportunity for GPO to educate FDLP coordinators on managing depository collections in compliance with the *Legal Requirements & Program Regulations of the Federal Depository Library Program*. The certificate program is free to participants and is conducted virtually through the FDLP Academy. At the conclusion of the program, participants are able to demonstrate knowledge of basic competencies of managing a Federal depository collection.

The series of eight online classes, held over a nine-week period, is led by GPO personnel from LSCM's FDSS. Class size is limited in order to facilitate discussion and interaction throughout the program.



In spring 2022, LSCM hosted a session of the CCP, with 47 people completing the program.

Since its inception in 2015, LSCM has

hosted eight CCP sessions, and 318 FDLP community members have completed the program.

FDLP Events

LSCM hosted two FDLP special events in FY 2022.

2021 Federal Depository Library Conference

The Federal Depository Library Conference is a multi-day event targeted to Federal depository library staff and other U.S. Government information professionals; the conference is the largest annual gathering devoted to U.S. Government information librarianship in the country.

From October 18 - 20, the GPO held its [Fall 2021 Federal Depository Library Conference](#), chaired by Will Stringfellow (DLC Chair, Federal Depository Coordinator, Vanderbilt University Central Library). Thirteen Council members and more than 850 participants were in attendance.

The conference began with opening remarks by GPO Director Hugh Halpern and Superintendent of Documents Laurie Hall, as well as Keynote Speaker,

Mr. Crosby Kemper, Director of the Institute of Museum and Library Services. During the kickoff session, the annual Federal Depository Library of the Year award was [presented to](#) the Government Publications Library at the University of Minnesota - Twin Cities.

During the conference, the DLC met to discuss topics impacting the FDLP. Conference educational programs included presentations by Federal depository community members, GPO staff, and other U.S. Government information professionals.

The event included two virtual meeting rooms with over 25 sessions. Some other great features included virtual poster and exhibitor galleries and ‘Snacks with Council,’ interactive, daily, conversational sessions with open discussion.

GPO also live-tweeted the event, and anyone can view the photos and tweets by searching #FDLConference on Twitter.

2022 Depository Library Council Virtual Meeting

On April 11 and 12, the DLC held its [Spring 2022 DLC Virtual Meeting](#) chaired by Will Stringfellow (DLC Chair, Federal Depository Coordinator, Vanderbilt University Central Library). There were over 600 participants in attendance from across the depository library community and other Government information stakeholders.

The two-day event began with opening remarks by GPO Director Hugh Halpern and Superintendent of Documents Laurie Hall. The meeting included six sessions on the future of the CGP, digital information, and more. During his opening remarks, Director Halpern spoke about the recently-released draft of the GPO strategic plan, introduced five new DLC members, thanked Laurie Hall for her service as the Superintendent of Documents, and briefly discussed the search for the next Superintendent.

There was an Open Forum during the final DLC session of the Meeting to discuss the impact of staffing and staffing levels; necessary library staff skills and training; and library services and operations. The Forum exchange provided valuable insight into how libraries are managing staffing and training challenges and allowed libraries to share strategies and methods to improve services and operate effectively in our changing environment.

GovInfo

Enhancing Content in GovInfo

LSCM has worked closely with GPO’s Office of Programs, Strategy, & Technology (PST) throughout the development and ongoing enhancement of [GovInfo](#). Released as a beta in February 2016, GovInfo was launched to modernize its predecessor website, GPO’s Federal Digital System (FDsys). In January 2022, GPO achieved the milestone of nine billion retrievals of Government information since the agency started publishing information online in 1994.

Continuing to add to the collections currently available on GovInfo is of the highest priority, with a goal of offering complete and historic holdings to its collections.

Notable additions in FY22 include:

- The Law Library of Congress and GPO continue to collaborate on digitization of the [U.S. Congressional Serial Set](#). Since the initial public release, 115 additional volumes have been added to the GovInfo collection.
- Ability to [browse the U.S. Congressional Serial Set by topic](#).
- [Monthly Catalog browse page](#) updated to include entry numbers and index contents.
- Over 800 historic [Congressional hearings](#).

- New publications from Digital Content Contributor [Boise State University](#).
- [Public Papers of the Presidents of the United States: Barack Obama \(2016, Books I and II\)](#).
- [2021 Government Manual](#).
- [2020 US Code \(United States Code, 2018 Edition, Supplement 2\)](#).
- [Statutes at Large Volume 128 \(113th Congress, 2nd Session\)](#).
- [Federal Register Index, 2021](#).
- [Code of Federal Regulations Index and Finding Aids, 2021](#).
- [Congressional Pictorial Directory: 117th Congress](#).
- [Railroad Retirement Board publications](#).
- Seven new courts opted into publishing to the [U.S. Courts Opinions](#) collection, bringing the total number of courts participating in the program to 156.

In May 2022, LSCM [made available](#) a suite of new educational webcasts on the U.S. Congressional Serial Set. The new tutorials focused on basic and advanced searching, browsing by topic and congress, searching by citation, searching for maps, and Serial Set documents in other collections.

GPO is actively digitizing, and current needs are posted to the [GPO Digitization: GPO Needs Lists LibGuide](#). Offering weeded depository material to GPO supports the National Collection of U.S. Government Public Information and increases public access to Government publications.

Trustworthy Digital Repository Audit and Certification of GovInfo

GPO worked to become the first Federal agency to be named as a Trustworthy Digital Repository (TDR)



for Government information through certification of GovInfo under ISO 16363:2012 for several years.

Certification of GovInfo from an accredited certifying body validates GPO's commitment to standards-based digital preservation practices and activities across 109 criteria in the areas of Organizational Governance, Digital Object Management, and Infrastructure and Security Management.

TDR certification has been a key GPO strategic initiative and a joint effort of LSCM and Programs, Strategy, and Technology (PST) business units since 2015. Certification under ISO 16363 provides assurance to GPO stakeholders, including the FDLP community, that GovInfo is a standards-compliant digital archive in which Government information shall be preserved, accessible, and usable well into the future.

On December 28, 2021, the ISO 16363 certification committee determined that GPO successfully completed its annual surveillance audit required to maintain certification status. The surveillance audit included two stages of assessment, including a documentation review and virtual audit by the auditors.

In 2022, GPO announced that the organization would be pursuing completion of [CoreTrustSeal](#) repository assessment in addition to maintaining its ISO 16363 certification. CoreTrustSeal offers, to any interested data repository, a core level certification based on the DSA–WDS Core Trustworthy Data Repositories

Requirements catalogue and procedures. By participating in the CoreTrustSeal process, GPO may be better positioned to engage with other Federal institutions that have data and information repositories that may have difficulty navigating the ISO 16363:2012 standard and turning its requirements into actionable procedures. GPO's application for certification under CoreTrustSeal was submitted June 28, 2022.

askGPO

[askGPO](#) is the public website to use when submitting questions to any area of GPO.

LSCM continued to enhance the askGPO site for improved customer service to Federal depository libraries and all GPO customers throughout FY 2022.

FY 2022 highlights include:

- December 2021:
 - Automated anniversary reminder emails were sent to depository coordinators based on designation date.
 - The FDLP Network page was updated to add FDL numbers and display the regional depository library for all states.
- February 2022:
 - A new inquiry form for three inquiry submission categories was introduced, allowing the user to better specify individual publications and associated metadata, or to submit a general inquiry.
 - Cataloging/Metadata (Policy & Records)
 - Classification and Item Numbers
 - PURLs (Persistent Uniform Resource Locators)
- June 2022:
 - Depository coordinators were given access to edit the Coordinator fields in the Federal Depository Library Directory.
 - The Depository Highlights and National Collection Service Area fields were added to each library's page and to all search and export functionality.

askGPO is the primary way to communicate with LSCM or any other GPO business unit and is also used for submitting forms, viewing and editing the Federal Depository Library Directory, and finding the answers to frequently asked questions.

Regular releases occur approximately every six weeks, and release notes are available on the [askGPO project page](#). The new releases have incorporated suggestions and feedback from customers and GPO staff and have continued to improve the site's usability and functioning. To assist user groups with the askGPO platform, training resources for [Federal depository libraries](#) and [Federal agencies](#) are available.

FDLP LibGuides

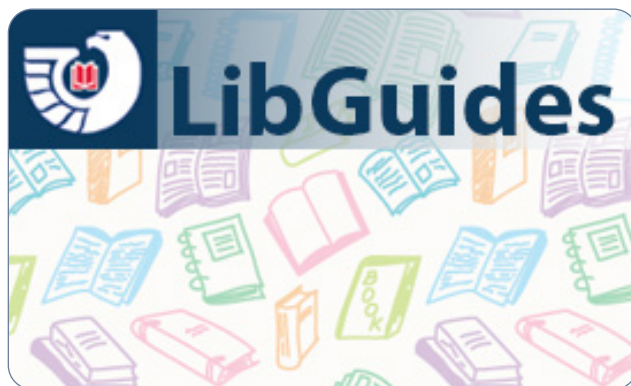
[FDLP LibGuides](#) is a service provided by GPO for depository libraries and the public. Guides are created by LSCM staff on a variety of topics, including those requested by the FDLP community. All guides are available for free use. Libraries and agencies can also submit their own guides for inclusion on the [FDLP LibGuides Community page](#).

LSCM staff members review the site and make enhancements to the look and content on a continuous basis.

During FY 2022, LibGuides had 57,855 views to the 166 Guides offered.

As of October 1, 2022, current, published LibGuides totaled:

Library Technical Services Information Portal LibGuide

In June 2022, LSCM launched the a new FDLP LibGuide, the [LSCM LTS Information Portal](#). The resource provides information and news about the ongoing work of LSCM's LTS staff, their initiatives, projects, and major developments in the cataloging/metadata field that impact access to U.S. Federal Government publications. Reviews and edits will take place periodically to continually enhance the LibGuide.

Biennial Survey of Federal Depository Libraries

The Biennial Survey of Depository Libraries is the means by which depository libraries report their conditions to GPO; it is administered every two years, and response is required by law.

The Superintendent of Documents, under the direction of the GPO Director, is responsible for administering the survey as required by 44 U.S.C. §1909. Data from the survey is used to administer the FDLP, to identify new trends, and to evaluate the conditions and services of Federal depository libraries.

The 2021 Biennial Survey of Federal Depository Libraries launched in early 2022.

Recommendations & DLC Documents

At the conclusion of the fall 2021 Federal Depository Library Conference, the DLC began developing formal [recommendations and commendations](#) for GPO. On December 10, 2021, one recommendation and one commendation were presented to GPO. In conjunction with the recommendation and commendation, the DLC sent a [formal request](#) to Director Halpern to approve the creation of a working group to explore the needs, challenges, and solutions related to Tribal, Historically Black College and University, small, and other Federal depository libraries which have unique challenges or primarily serve underserved populations.

At the conclusion of the spring 2022 DLC Virtual Meeting, the DLC began developing formal recommendations and commendations for GPO once again. On August 19, 2022, [two recommendations and one commendation](#) were presented to GPO.

Much work of the DLC is accomplished in their working groups. This year the Digital Deposit Working Group completed its investigation, its final report was submitted to the DLC, and the Working



Group was sunset. A new working group, Unique Challenges, Underserved Populations, and Federal Depository Libraries, was established and began its work. And three others continued their work:

- Collection and Discovery Services.
- Exploring the Durability of PURLs and Their Alternatives.
- Long-term Implications for Federal Depository Libraries of the COVID-19 Pandemic.

Limited Offers

Continuing in FY 2022, limited offers were made available to FDLP libraries from GPO. LSCM was able to acquire a limited quantity of various interesting publications to distribute freely to depository libraries. FY 2022's limited offers were:

- Keeping America Informed: The U.S. Government Publishing Office, A Legacy of Service to the Nation, 1861 – 2016

The titles acquired through limited offers are not subject to the same retention requirements as tangible materials distributed to depository libraries through item selection. However, libraries may choose to house these publications with other depository materials.

Library Shelfie Day

Wednesday, January 26, 2022, was Library Shelfie Day, and GPO featured FDLP librarians and staff via GPO social media and FDLP.gov. LSCM received photos from 18 Federal depository libraries celebrating the day.

National Library Week

National Library Week was April 3 – 9, 2022. LSCM created downloadable images for Federal depository libraries to use on their websites and on social media to commemorate the observances. LSCM also featured the FDLP via GPO social media and FDLP.gov.

Constitution Day

Federal depository libraries across the Nation celebrated Constitution Day on September 17, 2022, with events, contests, giveaways, displays, and more. Over 29,000 free Pocket Constitutions from GPO were shared with library patrons across the country.

FDLP.gov's 'Celebrating Constitution Day' gallery showcases photos and details of 2022 celebrations at Federal depository libraries, as well as celebrations from past years.

Special Selection Offers

Historically, Federal depository libraries were required to select two item numbers for publications of critical importance that were distributed to all depositories. In order to support libraries that wished to transition to digital collections and no longer receive tangible materials, the two mandatory item numbers were discontinued in 2014.

In 2019, LSCM initiated the [Special Selection Offer](#) process as a means of allowing libraries that did not select the item number for a significant specific publication to have a one-time opportunity to request and receive an individual title in tangible format. The special selection becomes part of the library's depository collection and is subject to regular FDLP retention rules.

LSCM continued its Special Selection Offers initiative in FY 2022.

Special Selection Offers available in FY22 were:

- National Debate Topic, 2021 – 2022
- Women in Congress, 1917 – 2020
- Not Yet Imagined: A Study of Hubble Space Telescope Operations
- A Century of Honor: A Commemorative Guide to the Tomb of the Unknown Soldier
- 50 Years of Solar System Exploration: Historical Perspectives

FDLP eXchange

Launched in June 2018, the [FDLP eXchange](#) established an automated process to support the exchange of depository publications nationwide and to facilitate communication among Federal depository libraries.

GPO provides access to a variety of [training and informational resources](#) on the tool.

In FY 2022, 443,791 offers and 18,937 needs were posted in FDLP eXchange. At the close of FY22, there were 83 libraries offering in 27 regions.



Web Archiving

The [FDLP Web Archive](#) provides point-in-time captures of U.S. Federal agency websites while preserving the functionality of the sites to the extent possible. The aim is to provide permanent public access to Federal agency web content. GPO harvests and archives the websites with Archive-It, a subscription-based web harvesting and archiving service offered by the Internet Archive.

LSCM continues to harvest digital publications and websites in order to advance FDLP collection development efforts. In FY22, efforts concentrated on recrawls of existing websites, while also adding new sites such as the Federal Judicial Center and America250.

Through the close of FY22:

- LSCM increased the size of the FDLP Web Archive collection to 44.5 TB, with over 454,000,000 URLs.
- There were 215 website collections available on the FDLP Web Archive on Archive-It and 269 records available through the CGP.

FDLP Web Services

FDLP.gov

FDLP.gov is the FDLP community’s one-stop site for the tools, information, and resources needed to manage a Federal depository library. Collection tools, requirements, guidance, educational opportunities, and more are available. FDLP.gov saw 182,032 user sessions in FY22 (470,668 page views).

- **FDLP.gov Modernization** – In FY 2022, work continued toward re-platforming FDLP.gov to migrate FDLP content to an updated infrastructure. In December 2021, LSCM launched the beta instance of the updated FDLP.gov, and the new site went live in early 2022. The new platform offers performance and visual improvements, such as:
 - Refreshed visual design.
 - FedRAMP compliant server infrastructure.
 - Improved search.
 - Improved layout for phones and devices.
 - Improved security.
 - Reorganized database.
 - Improved maintenance panel for WEBTech Notes.
- **Historic Publications Feature** – LSCM continues to feature [Historic Publications](#) on FDLP.gov each quarter. Fall 2022 marked the 15th installment of the feature and highlighted many contributions from GPO partners. New installments are announced via [FDLP News & Events](#).
- **Homepage Features** – LSCM continues to refresh the FDLP.gov homepage content with “snacks.” Snacks are added on a regular basis. They feature FDLP updates, new LSCM initiatives, news offerings from other agencies, and Government publications that complement recent holidays and observances. These snacks are great to repurpose and feature on library social media pages. In FY22, the homepage featured 113 different snacks.

Ben’s Guide to the U.S. Government

[Ben’s Guide to the U.S. Government](#) is a free, educational website from GPO that is designed to inform students, parents, and educators about the U.S. Government. Ben’s Guide content is divided into three learning levels:

- Apprentice (ages 4 – 8)
- Journeyman (ages 9 – 13)
- Master (ages 14+)

Ben’s Guide users go on “learning adventures” on topics such as the branches of Government, how laws are made, the election process, historical documents, and more. Interactive games, as well as printable activities such as crosswords and word searches, make learning fun.

In FY 2022, Ben’s Guide saw 413,967 user sessions and 958,469 page views.



CATALOGING & INDEXING PROGRAM (C&I)

Under the requirements of sections 1710 and 1711 of Title 44, U.S.C., GPO is charged with cataloging a comprehensive index of public documents issued or published by the U.S. Government that are not confidential in character. The goals of the C&I Program are to:

- Develop a comprehensive and authoritative national bibliography of U.S. Government publications.
- Increase the visibility and use of Government information products.
- Create a premier destination for information searchers.

This undertaking serves libraries and the public nationwide and enables people to locate desired Government publications in all formats. The main public interface for the access of cataloging records is the [CGP](#).

Discontinued Subject Headings: Aliens and Illegal Aliens

In late 2021, the Program for Cooperative Cataloging's Subject Authority Cooperative Program (SACO) confirmed replacement of Library of Congress Subject Headings (LCSH) containing the terms "aliens" and "illegal aliens." This change was the result of years-long advocacy by libraries and other communities to eliminate dehumanizing and outdated language from the LCSH vocabulary.

The official LCSH were changed as follows:

- *Aliens* is replaced by *Noncitizens*.
- *Illegal aliens* is replaced by a combination of two headings, *Noncitizens* and *Illegal immigration*.
- All other LCSH containing the term "aliens" were also updated accordingly.

As a SACO member, beginning in December 2021, LSCM made the decision to catalog newly-acquired Government information products using the new authorized headings. The existing subject headings in bibliographic records were retroactively replaced.

CGP and MetaLib Enhancements

In January 2022, LSCM announced newly redesigned and enhanced CGP Help pages and an updated CGP About page.

The redesigned and enhanced CGP Help pages feature:

- Updated and expanded content including:

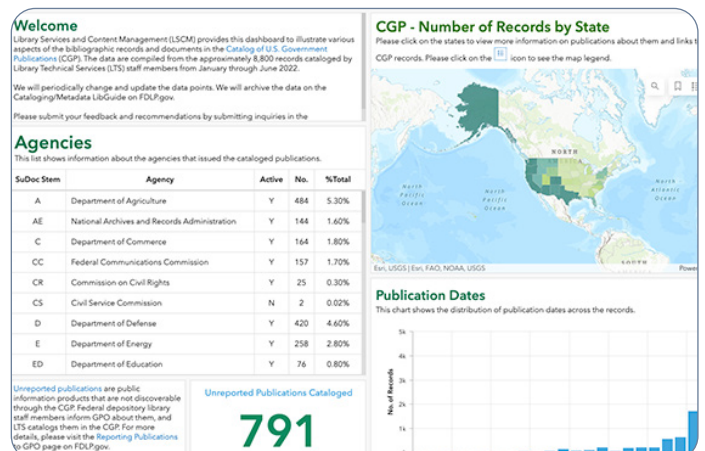
CGP Data Dashboard

In March 2022, LSCM launched a new dashboard to visualize various aspects of the bibliographic records for Federal Government information products in the CGP. The [CGP Data Dashboard](#) is the start of LSCM's exploration of the CGP as a data set. LSCM's plan was to use CGP data to tell stories about Government information and the FDLP and to represent LSCM's work. LSCM's FDSS and LTS collaborated on the planning, design, and implementation of the dashboard.

For the launch of the tool, LTS extracted the following data points from the 7,703 records cataloged by LTS staff members during the period of July through December 2021:

- Geographic coverage
 - Based on the geographic area codes in the MARC 043 fields
- Chronological coverage
 - Based on the publication dates in the MARC 264 fields
- Issuing agencies
 - Based on the Superintendent of Documents Classification Agency classes in the MARC 086 fields
- Unreported publications (public information products that are not discoverable through the CGP)
 - Based on the codes in the MARC 922 fields

LSCM is periodically refreshing the data and may replace the current categories of information with different data elements.

Catalog Records on GitHub

The [CGP on GitHub](#) is LSCM's central repository of sets of bibliographic records that users may download at no charge.

In April 2022, LSCM posted a new set of all MARC bibliographic records (1,022,882) in the CGP as of March 30, 2022, on GitHub. Brief bibliographic records are not included in the files. The records are available in UTF-8 in the [cataloging-records-all-cgp-utf8 repository](#) and in MARCXML in the [cataloging-records-all-cgp-marcxml repository](#).

In combination with the monthly files in the [CGP_MARC_Records collection](#), these files essentially represent the entire CGP. LSCM will periodically post new snapshots of the entire CGP.

The total size of the UTF-8 files was 1.87 GB, and the total size of the MARCXML files was 5.4 GB. The records in the files are not organized in any particular manner. The UTF-8 repository had 26 files, each of which contained approximately 40,000 records. The MARCXML repository had 102 files, each of which contained approximately 10,000 records.

Cataloging Record Distribution Program

The [Cataloging Record Distribution Program](#) (CRDP) provides GPO-produced catalog records to participating Federal depository libraries, at no cost to the libraries, through a contract with MARCIVE, Inc. Each participating library may acquire all newly-created catalog records, or the new records plus changed records, with item numbers that match their library's item number selection profile. Libraries add the records to their own library catalogs, enhancing public access and awareness of U.S. Government publications.



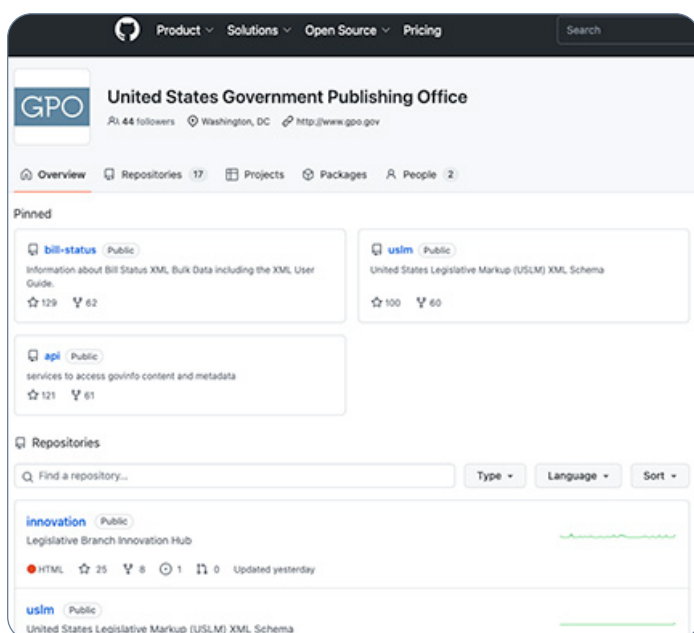
The CRDP began in 2009 and has expanded each year. In FY 2022, LSCM served 256 Federal depository libraries (23% of all depositories) through the CRDP.

Congressional Research Service Reports



In September 2018, LC launched a [website](#) for Congressional Research Service (CRS) reports. The site met the requirements of Public Law 115-141 to make these reports available to the public. In October 2018, in an agreement with the Library, LSCM's LTS staff began cataloging CRS reports for the CGP and OCLC. Because these reports are frequently updated, GPO has cataloged each report title as an integrating resource.

At the close of FY 2022, LTS staff cataloged over 8,191 separate, unique CRS report titles. This is approximately 78% of all reports available on the site.





MARC records cataloged through September 16th for downloading and a records display with links to the publications and the records. This CGP expert mode search [wlts=lclawlib](#) retrieves all records for the reports.

RDA/3R Project

In FY 2022, LSCM continued to prepare for adoption of a new iteration of the RDA cataloging standard. The RDA/3R Project, created by LTS, helps GPO catalogers learn new RDA concepts and gain familiarity with the updated RDA Toolkit.

Although the new RDA became official in December 2020, as of the close of FY 2022, it had not yet been adopted by the PCC, of which LTS is a member.

Cataloging Historical Legal Reports

The Law Library of Congress and GPO are collaborating on a multi-year project to catalog thousands of digitized and born-digital historical legal reports. The Law Library of Congress is digitizing the reports, and GPO's LTS is cataloging the reports that will be made available online.

The Law Library of Congress wrote these reports on foreign, comparative, and international law issues for Congress and other Federal agencies. The Law Library of Congress posted a description of the project and the reports on their blog, [In Custodia Legis](#).

In August 2022, LTS surpassed the 2,500-record milestone for the project. At the close of FY 2022, 2,360 reports had been cataloged. LTS created the [Law Library of Congress Reports Collection](#) in the CGP on GitHub repository. The collection provides files of the 2,275

Through Spring 2023, LTS is participating in the PCC's [Task Group to Test the Official RDA Toolkit](#). This task group developed a test to assess the usability of the redesigned LC-PCC Policy Statements and newly created Metadata Guidance Documents. LTS will utilize the completed documentation and training materials to make the switch to the new RDA along with PCC. Currently, the switch is expected to occur in FY 2024.





Cataloging Congressional Committee and Commissions Websites

In FY 2022, GPO's LTS cataloged the websites of the House, Senate, and joint committees and commissions. By the end of June 2022, LTS staff members completed the records for the 57 current committees and commissions. They cataloged 49 new records and adapted eight OCLC records. Most of the records contain a PURL to the live site and a PURL to the National Archives & Records Administration's (NARA's) [landing page of harvests](#) conducted at the end of the 109th Congress (2006) through the 116th Congress (2020).

FDLP PURL Usage Report Expanded

In response to feedback from the FDLP community, the [PURL Usage Reporting Tool](#) was enhanced in early 2022. FDLP library users have many different networks and IP addresses used to access PURLs found in catalog records and online finding aids. Up to 10 IP Address ranges were initially allocated for each library's PURL Usage Report, but LSCM received numerous requests to increase the number of IP addresses/Hostname patterns. The enhancement allows for up to 25 IP addresses/Hostnames that can be saved for the creation of custom library PURL usage reports.

Cataloging of the Historic Shelf List

LSCM began a new contract in October 2021 to catalog the approximately 66,000 to 88,000 remaining [Historic Shelf List](#) cards into MARC 21 format for inclusion in the CGP. A staff of four are working through the remaining cards, and each bibliographic record is being enhanced by adding one Library of Congress Subject Heading and one corporate name authority. As part of the cataloging, holdings and item records for continuing resources are also being created and serial issues checked in.

In the [expert search mode](#) of the CGP, you can use a local field search to retrieve all of the records: `wlts=COMMSWEB`.

Cataloging Video Hearings of the House Select Committee to Investigate the January 6th Attack on the U.S. Capitol

In July 2022, LSCM cataloged the streaming videos of the eight hearings held by the House Select Committee to Investigate the January 6th Attack on the United States Capitol. The records can be retrieved in the CGP by this search in the [expert mode](#): `wau=House Select Committee to Investigate the January 6th Attack on the United States Capitol` and `wfm=vm`.

INTERNATIONAL EXCHANGE SERVICE

As authorized by Section 1719 of Title 44, U.S.C., and pursuant to an international treaty establishing the exchange of official publications, GPO distributes tangible Government publications to foreign governments in an exchange program managed by LC. Those foreign governments agree to send to the United States similar publications of their governments for LC collections. The following statistics reflect IES activity for FY 2022.

- Microfiche Copies Distributed: 100,188

BY-LAW PROGRAM

LSCM administers the distribution of certain tangible publications as specified by Public Law. Under various provisions of Title 44, U.S.C., GPO is required to provide copies of publications to certain Federal agencies and others as directed by Congress. Two or more copies of every publication printed are provided to LC, even if those publications are not distributed to Federal depository libraries. In addition, NARA receives up to three copies of every publication GPO prints. On behalf of the Department of State, LSCM distributes copies of publications to foreign legations. LSCM maintains mailing lists for By-Law distribution of specific publications.

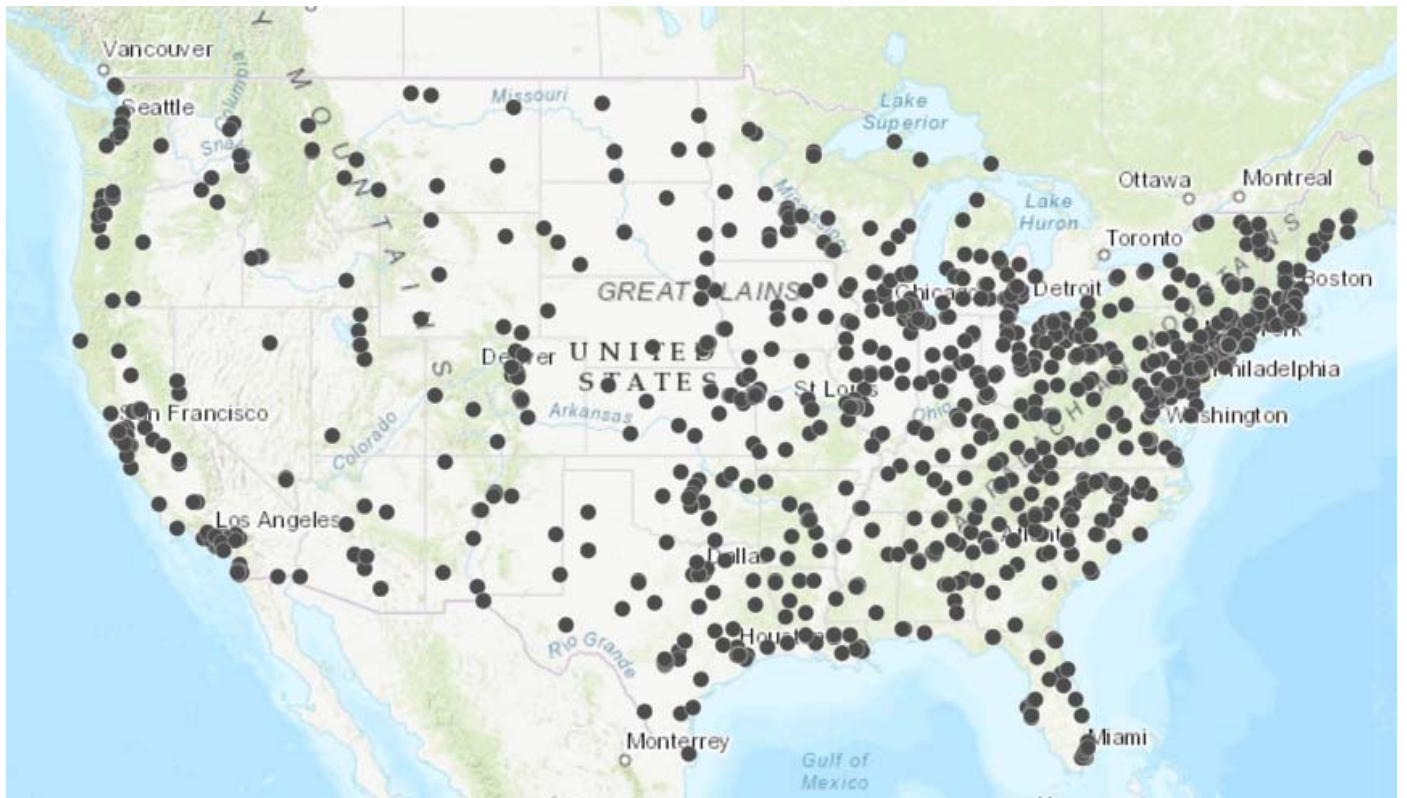
