### **Bibliographic Instruction: Are Government Documents Being Included? Or Overlooked?**

This poster presents the results of a study on the inclusion of government documents in bibliographic instruction in academic libraries. Who is providing the information, what is being covered, and which classes are receiving it? Answers to the 2012 survey surprised both the instruction and government information librarians at the University of Arkansas at Little Rock when over 230 colleagues responded.

### **Blueprint for Collaboration: The University of Florida Storage Documents Project**

Cataloging U.S. Government Documents is in and of itself a daunting task. When the University of Florida embarked on the "StoDocs" project to catalog pre-1976 Federal documents, they discovered additional challenges that increased the difficulty dramatically: Most staff doing the cataloging were unfamiliar with documents and had never heard of the Superintendent of Documents Classification System; the Government Documents staff who curate the collection and the indexes used to verify Superintendent of Documents call numbers were 5 miles away; the catalogers at GPO offer monographic and serial records for the same items; and all items, small and large, had to be barcoded to the specifications of a high-density storage facility. The StoDocs team came up with creative solutions to overcome these seemingly impossible difficulties and bonded in the process.

### **Re-examining Core Collections for the FDLP**

The Suggested Core Collections Lists consist of recommended core titles in all subject areas for academic, public, and law libraries acting as depository libraries. The lists, first disseminated in the *Federal Depository Library Manual* in 1993, were last reviewed and updated in 2007, and are currently archived as Appendix A of the *Federal Depository Library Handbook*. Agency publication practices have changed over the years, with new titles created and older ones having ceased. Additionally, FDLP regulations and guidance have been updated. It is time for the community to review these lists again and make any necessary changes that will keep them relevant and useful in the current FDLP environment.
