Terminology

PDT = Print Distribution Titles

The only paper format titles that will be distributed to depository libraries.

PDTs are distributed in three quantities:

- 20 copies = Titles are distributed to 20 libraries across the country.
- 50 copies = Titles are distributed to 50 libraries across the country.
- Unlimited quantity = Titles are distributed to any FDL that selects these item numbers on their item selection profiles. There are 7 titles in this category.

- NCSAs are the 4 geographic areas of the country, with one copy being deposited in each NCSA: West, Midwest, South, Northeast.

Timeline of New PDT Framework

Sept 2023

 Meetings held to introduce the limited Print Distribution Titles (PDT) list and framework to the FDLP

Nov 2023

- 4 meetings held with the NCSAs (Midwest, Northeast, South, and West) to discuss criteria needed to allocate print copies within the NCSAs
- Questionnaire sent out to all libraries in the 4 NCSAs to determine criteria which will be used to allocate print copies of PDT
- Criteria was weighted and an allocation formula developed

Dec 2023

- PDT Questionnaire sent out to all FDLs with a due date of 12/22/23
- 731 responses recorded

Timeline of New PDT Framework

Jan 2024

- LSCM determined allocations and sent to DLC for feedback and review
- On January 17, LSCM notified libraries receiving allocations and asked them to confirm and acknowledge the PDT retention requirements and commitment to holding the tangible materials going forward.

Feb 2024

- The final PDT allocations list was shared with the FDLP community via News Alert.
- February was a transition month for distribution, as LSCM began limited distribution of the new PDTs.
- Item selection profiles were updated to reflect PDT allocations on February 22.

March 2024

- Bulk updates pivoting List of Classes entries to digital format were completed on March 24.
- Work began on the public PDT distribution framework report.

April 2024

- Further List of Classes updates are currently underway.
- NCSA Steering Committees met on April 17 for orientation. Committees for each NCSA will begin work in late April and May.
- Continued work on the public PDT distribution framework report

GPO and LSCM

- Updated shipping list template to reflect all entries are PDT - unless otherwise noted with a ^ symbol in the title field
 - **^ entries are old model distribution**, and regular FDLP weeding/retention rules apply.

- PDT shipments (not specifically marked in shipping lists) have new retention requirements:
 - Retain for first 5 years and no supersession or electronic substitution during that period
 - After 5 years, commit to offer nationally in FDLP eXchange
 - Commit to catalog print receipts and make discoverable

Impacts of the PDT Implementation

Federal depository libraries

 Should only receive PDT and Special Selection Offer (SSO) content

- Will **no longer receive shipping lists** if your library does not get a publication on that shipping list
- Should periodically check their item selection profiles
- Will note a simplified Depository Selection Information Management System (DSIMS) interface
- May have to contact your catalog record vendor to update your record profile

Overall Plans
