The purpose of this poster will be to demonstrate the usefulness of geographical information systems in analyzing attendance statistics from the bilingual webinars presented by Jane Canfield for GPO. This information can be used to target audiences more effectively and efficiently, thereby aiding GPO and the FDLP to optimize their spread of information and provide possibilities to reach new audiences.

Constitution Day Programming

Programming for Constitution Day can be a daunting prospect for libraries facing tight budgets, staff shortages, and space constraints. Examples of activities include: a cell phone recorded video of staff reciting the Preamble, post-it note comments on the Constitution, and a panel on amending the Constitution going forward.

Developing a Successful GIS Services Program

Alkek Library at Texas State University rolled out a new GIS Services program in August 2015. While Government Information had offered access to ArcGIS for some years, this is the first time we have offered Geographic Information Systems guidance. Located within Government Information and adjacent to print cartographic resources, GIS Services has been phenomenally successful this first year – with 170 consultations and a very well-attended GIS workshop series. Included in the poster will be marketing strategies, information on recommended hardware and software, graphs of consultations, workshops statistics and assessment results, and a guide containing recommended Federal, as well as example state & local, government sources for geospatial data.

HI to AZ: Why are so Many Federal Documents in Hawaii Loaned to Arizona Libraries?

Arizona State University and the University of Arizona accounted for 17% of interlibrary loans of Federal documents from Hawaii, and 26% of Greater Western Library Association ILL loans from Hawaii over a five-year period. Randall Library, at the University of North Carolina Wilmington, is a large selective depository. The Federal and state documents collections are provided much valuable space and have a large footprint within the library. With so much space afforded to the collections, it is increasingly important to make users aware of the broad range and scope of the resources available to faculty, staff, and students. At Randall Library, collections are advertised and promoted in many creative ways to explain what Government resources are, why we have them, and how they can be used to support student research. Through creative signage, targeted "Government Resource of the Month" emails, a variety of display areas, and more, Randall Library has increased awareness and use of these resources. This poster will highlight many of the easy and inexpensive ways that any library can promote Government resources.

From Print to Electronic: Digitization of Northwestern University Libraries' WPA Documents Collection

The poster describes the digitizing of a small collection of Government documents from the 1930s and 1940s produced by the Works Progress Administration (also known as the *Work Projects Administration*). The procurement and provenance of the collection is briefly explained, with the development, organization and activities surrounding the workflow and management of this initiative being the primary emphasis of the poster, while also highlighting some of the general issues pertaining to in-house digitization efforts.

Online Guide to U.S. Map Resources: A Call to Action

The Map and Geospatial Information Round Table (MAGIRT) of the American Library Association (ALA) will be updating the Guide to U.S. Map Resources with the help of Federal depository libraries. The goal is to bring the wealth of information found in the previous print edition of the Guide into a searchable online database that will include a map interface in order to easily locate map collections and their accompanying information. To update the Guide, a survey has been created to gather information about collections of Government-produced maps held by Federal depository libraries, as well as retention and deselection policies. The poster will provide information on the development and expected outcomes of the Online Guide to U.S. Map Resources as well as provide information on how Federal depository libraries can participate.

Providing Legal Information at Texas Tech for Non-Lawyers: Progress Made and Challenges

This updates a 2015 GPO Poster Presentation which described both increasing access to legal information for non-lawyers at the Texas Tech (TTU) and increasing legal reference knowledge for the TTU Library's personal librarians. Methods used include the depository librarian taking mini-legal research classes at the TTU Law Library, increasing legal information in both the Library's LibGuides and the Library's 1 hour credit course - Introduction to Scholarly Resources. Challenges of providing legal information without a J.D. are discussed.

Space Planning – Weeding, Moving and Providing Access to a Government Information Collection during an Academic Library “Refresh”
