

## **About the Depository Library Council**

The Depository Library Council (DLC or Council), established in 1972, serves as the advisory body to the Director of the Government Publishing Office (GPO) and the Superintendent of Documents. on policy and operational matters relating to improving public access to our Government's information through the Public Information Programs of the Superintendent of Documents:

- Federal Depository Library Program (FDLP);
- Cataloging & Indexing Program (C&I);
- GPO's System of Online Access, GovInfo; and
- National Collection of U.S. Government Public Information.

DLC is governed by a Charter and Bylaws and follows, as much as is practicable, the guidance provided by the General Services Administration for compliance with the Federal Advisory Committee Act.

The primary way in which the Council provides advice to the GPO is through the transmittal of recommendations to the GPO Director. The origin of recommendations varies. Some may be brought forward through the working groups or subcommittees, others from listening to needs expressed by the depository library community in numerous Council forums, and still others related to the GPO's work.

Council meetings are convened twice a year, during the spring and fall. The fall meeting is held in conjunction with the Federal Depository Library Conference. While prior to 2020, fall meetings were held as a hybrid, i.e., in-person and online, since then the meeting and conference have been held solely virtual. Another DLC meeting is held in the spring, and this has been virtual for many years. These DLC sponsored events facilitate the work of the Council and provide an opportunity for that work to be informed by and shared with the broader depository library community.

## Highlights of Council Year 2024-2025

Council has continued to respond to the transition to a digital FDLP. DLC representatives serve among the 32 Government information professionals from depository libraries appointed to the four National Collection Service Area (NCSA) Steering Committees. The NCSAs were established to facilitate discussion and collaboration among depository libraries in four geographically dispersed areas. The Steering Committees were each charged with creating a Limited Print Distribution Reallocation Process by the end of September 2024. Having accomplished that charge, an <u>overview of each of the approved reallocation plans</u> was shared during the Fall 2024 Federal Depository Library Conference.

Though each of the NSCA created similar processes, each model acknowledged the different print needs and requirements of the NCSAs. Steering Committees were also charged in drafting a Retention Commitment Processes for their areas and they continue that work.

Council also provided feedback for the Public Policy Statement, "<u>Print Distribution and Access to Government Publications in a Digital Federal Depository Library Program</u>" (SOD-PPS-7-2025). The purpose of the policy is to provide parameters for limiting print distribution and making Government public information accessible through a digital first Federal Depository Library Program. It became effective March 31, 2025.

With the unanticipated announcement that the <u>Cataloging Record Distribution Program</u> and MARCIVE, Inc. would cease operations in December 2024, Council discussed options for depository libraries concerned about cataloging and discovery of Federal depository resources. Several programs at the Fall 2024 Federal Depository Library Conference focused on different workflows for managing government document collections. Council appreciates GPO's efforts to address the community's concerns and for creating and updating related content on FDLP.gov.

An overarching theme in the past year has been the need for expanding communication and outreach in the depository community, as well as engaging those who work with government content but may not be depository coordinators, such as catalogers and metadata librarians. Council appreciates that its recommendation advocating for mentoring programs is supported by GPO. Council will collaborate with GPO to encourage depository coordinators to populate the existing "Depository Highlights" field in the FDL Directory with their collection strengths. We are also thankful that the 2025 biennial survey will include a question gauging how widespread mentoring interest is among the depository community.

## **Depository Library Council Meetings**

The Depository Library Council meets twice each year. As an advisory council of a Federal agency, all the Council meetings are open to the public and announced in the Federal Register. They are also announced through FDLP New Team email announcements. Those announcements are forward widely to library-related discussion lists. And there is always a banner on FDLP.gov from the time registration opens, through the day the meeting begins.

## Fall 2024

The Fall 2024 Meeting of the Depository Library Council was held October 21—23. in conjunction with the Federal Depository Library Conference. Chair Caro called the

meeting to order at 12:30 PM (Eastern Time). GPO's Director Hugh Halpern, Superintendent of Documents Scott Matheson, and Depository Library Council Chair Susanne Caro delivered welcoming remarks. This joint meeting of the Depository Library Council and the Federal Depository Library Conference drew 653 attendees — 63% of the registrants. ## Spring 2025

The Spring 2024 Meeting of the Depository Library Council was held May 1, 2025. Chair Caro called the meeting to order at 12:00 PM (Eastern Time). GPO's Director Hugh Halpern, Superintendent of Documents Scott Matheson, and Depository Library Council Chair Susanne Caro delivered welcoming remarks. There were 657 registrants for the one-day meeting and 67% (431) attended. We cannot determine how many people have watched the session recordings.

## Recommendations

## Depository Library Council Meeting, Fall 2024

The Fall 2024 meeting of the DLC resulted in three recommendations and a commendation. Recommendations were made for a mentoring program, the last COVID-19 questions for the 2025 Biennial Survey of Depository Libraries, and the development of resources to assist depository library coordinators adjust to the digital first FDLP and other programmatic changes. Additionally, Council issued a commendation to Laurie Beyer Hall on the occasion of her retirement after thirty-nine years of service at GPO, which included seven years as the Superintendent of Documents. ## **Council Work Between Meetings**

## Information Sharing Calls

Council members participate in monthly information sharing video calls with GPO staff. These calls allow a designated time to ask questions, seek clarification, and hear about important GPO initiatives. They also offer an opportunity to ask GPO for additional information about topics important to the Federal depository library community and the current work of Council. Through the information sharing calls, Councilors gain an understanding of the complexity of the FDLP, the technical issues involved in projects, and an awareness of the ways the program functions at different kinds of institutions. Finally, the calls provide the opportunity for Council members and GPO to share updates about local, state, regional, or national government information related activities.

## Subcommittees & Working Groups

Subcommittees, working groups, and DLC projects continue from term to term as their charge and work require, even as members cycle on and off Council. Working groups are sunset upon completion of their specific charges, while others, like the Collection and Discovery Services Subcommittee, and the Unique Challenges, Underserved Populations, and Federal Depository Libraries Subcommittee, are permanent in nature.

## Collection and Discovery Services Subcommittee

The Collection and Discovery Services Subcommittee (CDSS) conducted a survey to understand library practices, needs, and underlying issues to determine what actions to take to help depository libraries with digital collection development and management. CDSS submitted a report and recommendations, "Managing FDLP Digital Publications in Library Catalogs: Survey Findings" to Council at its Fall 2024 Business Meeting. Council accepted the report's recommendations in concept. They were subsequently revised and became one of Council's Recommendations submitted in December 2024 to GPO Director Halpern. In early 2025, CDSS discussed the depository community's concerns around locating and tracking missing online Federal information, as well as preserving information and data, and how the subcommittee could support the community. Additionally, feedback from the Spring Council meeting reflected that many in the community were interested and concerned about Generative Artificial Intelligence and its role in depository libraries and with government information. These issues are potential areas for CDSS to investigate in the upcoming year.

## Unique Challenges, Underserved Populations, and FDLs Subcommittee

The Unique Challenges, Underserved Populations, and Depository Libraries (UCUP) was established as a working group in January 2022 and became a subcommittee in July 2023. The UCUP charge is to study Federal depository libraries at affinity-focused institutions and other FDLs with unique needs and challenges that impact their ability to provide access to tangible and digital depository resources. And further, to determine possible solutions and provide recommendations that include ways in which the Government Publishing Office can better support these libraries.

UCUP reviewed responses from the 2023 Biennial Survey of Depository Libraries to the following questions:

- (Q5) What challenges or significant events have affected your FDLP operation in the last two years? Select all that apply.
- (Q6) What are your library's major plans for the depository operation in the next two years? Select all that apply.
- (Q17) What services do you provide for those who are not native English speakers? Select all that apply.

An outcome of the review was the decision to conduct focus groups, the topics of which were determined by the survey responses. Between May and September 2024, UCUP conducted eight focus groups on six topics: Budget & Administration; Digital Divide; Language Barriers; Mistrust of Government; Outreach; and Training. There were two focus groups for Outreach and for Training. Much was learned from the sessions. But, UCUP decided to leverage one of the "Snacks with Council" sessions during the Fall 2024 Depository Library Meeting/Federal Depository Library Conference to gather additional information on these topics. The focus group final report is forthcoming.

UCUP also sponsored a program during the fall 2024 conference, "<u>Understanding Government Mistrust and Enhancing Transparency</u>," which was well-received. The presenters were Paul Helmke, Director, Civic Leaders Center, Professor of Practice, O'Neill School of Public and Environmental Affairs, Indiana University; Jennifer Bryan Morgan, Government Information Librarian, Indiana University Maurer School of Law, Jerome Hall Law Library; and Amanda Dunn, Program Planner, Programs, Strategy, & Technology, GPO. The session was moderated by UCUP Co-chair Robert Mead, State Law Librarian, Washington State Law Library, Administrative Office of the Courts. As a follow-up to the session, a question related to mistrust of government information resources was submitted for inclusion on the 2025 Biennial Survey of Depository Libraries.

At the request of GPO's Federal Depository Support Services, UCUP reviewed and provided input for two new FDLP Resource Guides:

- <u>Then and Now Experiences of American Indians and Alaska Natives</u>
- Then and Now Experiences of Blacks and African Americans

## Long-term Impacts of COVID-19 on FDL Access, Collections, & Services Working Group

With the 2023 Biennial Survey data available, the COVID Working Group analyzed the responses to the COVID-related questions. The working group submitted a report and recommendations, "Second Report of the Depository Library Council's Working Group on the Long-Term Impacts of COVID-19 on Federal Depository Library Access, Collections, and Services" to Council at its Fall Business Meeting. Council subsequently accepted the report and approved the recommendations in concept. With editorial revisions, they were incorporated into the Council's Recommendations submitted in December 2024 to GPO Director Halpern. The COVID Working Group submitted, for the final time, two questions to GPO for inclusion in the upcoming 2025 Biennial Survey of Depository Libraries.

## **Statistics & Metrics Working Group**

The Statistics and Metrics Working Group (SMWG) was established in January 2024 to research and recommend options for how GPO can collect usage statistics from depository

libraries for digital and tangible Government information products. This year the SMWG conducted a survey of depository library coordinators from August 8 – September 16, 2024. The survey asked questions about collection usage statistics the libraries gather and barriers they face to collect data. The SMWG spent several months studying the data to discover any patterns that might emerge. A report of the survey findings was released in April 2025 and accepted by the Council at its Spring Business Meeting. It contains two recommendations that Council approved in concept at the same meeting; they were transmitted to GPO on July 1, 2025.

## Council and the NCSA Steering Committees

As part of the digital first FDLP and the National Collection Service Area (NCSA) framework, steering committees were established in each of the four National Collection Service Areas (NCSAs) — Midwest, Northeast, South, and West. Their purpose is to

facilitate discussion and collaboration among the Federal depository libraries in the NCSA and to coordinate NCSA-wide collection management and collaborative services planning. The Depository Library Council is represented on each steering committee with a voting member. This fosters open communication between steering committees, Council, and GPO for a better understanding of how the service framework is working and developing.
