



# Preservation Stewards

## What are Preservation Stewards?

Preservation Stewards make a commitment to retain specified tangible depository resources for the length of the partnership agreement. They also take on the additional responsibilities for preserving that material. This includes both preventive maintenance and conservation treatments.

## Who can serve as a Preservation Steward?

Both regional and selective Federal depository libraries are able to serve as Preservation Stewards. There are many selectives that have historical materials and collections that can contribute to the preservation effort by becoming a Preservation Steward and housing preservation copies of record. GPO also welcomes the opportunity for discussions and partnerships with interested parties from beyond the Federal Depository Library Program (FDLP).

## What material is eligible to be listed under a Preservation Steward agreement?

Publications within scope of the Superintendent of Documents Public Information Programs, that is, the FDLP, Cataloging & Indexing Program, and GPO's system of online access are eligible to be preservation copies of record. Materials that are classified for reasons of national security, or that have privacy concerns, are not eligible until they are declassified or the privacy considerations expire. Fugitive documents, though not distributed through the FDLP, can also be preservation copies of record. With few exceptions, commercial reproductions cannot be preservation copies of record.

## What are the incentives of serving as a Preservation Steward?

Preservation Stewards play an important role in ensuring the long-term access of U.S. Government resources that are valuable to their users and communities as well as to the whole Federal depository library community. GPO recognizes that access to the corpus of Government information for future generations is only possible through its preservation. To assist the efforts of Preservation Stewards, GPO plans to provide support services for carrying out this vital role. For example, GPO is paying postage for shipping materials to the Preservation Stewards from other libraries. Other support services GPO is considering are helping with cataloging, inventories, condition assessments, and contracting for conservation services.
