About the United States Reports

The cases of the [Supreme Court of the United States](#) are published officially in the United States Reports. The volumes are compiled and published for the Court by the Reporter of Decisions. A volume of the United States Reports also usually contains a list of Justices and officers of the Court during the Term; an allotment of Justices by circuit; announcements of Justices' investitures and retirements; memorial proceedings for deceased Justices; a cumulative table of cases reported; orders in cases decided in summary fashion; reprints of amendments to the Supreme Court's Rules and the various sets of Federal Rules of Procedure; a topical index; and a statistical table summarizing case activity for the past three Court Terms.

This collection includes volumes 2 through 501. Volumes 502 through present are available from the [U.S. Supreme Court](#). The early volumes were privately published by the reporter, so the name of the reporter who compiled the volume appears in the United States Reports citation. In addition to U.S. Supreme Court cases, volumes 2-4 contain cases from Pennsylvania, the U.S. Court of Appeals, and the U.S. Circuit Court. In this collection, the Pennsylvania cases are only available in the full volume. Volume 1 contains only Pennsylvania cases, so is not included in this collection. [Read More](#)

About the Congressional Serial Set - Browse by Topic

This topic-based browse allows users to explore the United States Congressional Serial Set based on topics organized by the first letter of the topic. The assignment and indexing of Library of Congress Subject Headings (LCSH) to documents included in the United States Congressional Serial Set collection, which was digitized by the Law Library of Congress, and is made publicly available through a partnership between the U.S. Government Publishing Office and the Law Library of Congress, makes browsing the content by topic possible.

LCSH are words or phrases that are used to indicate the topics of resources. They are used by most libraries in the United States. LCSH categorizes topics into logical arrangements and maintains consistency by controlling synonyms, variant spellings, and homographs. This allows all resources on a topic to be grouped together which allows users to find them easily. About the Congressionally Mandated Reports

Congressionally mandated reports are defined as those reports that are required by statute to be submitted by Federal agencies to the Senate, the House of Representatives, or to congressional committees or subcommittees. Agencies must now also submit these reports electronically to the U.S. Government Publishing Office (GPO) after first submitting to Congress, committees, or subcommittees as they do currently.

Not all congressionally mandated reports are required to be submitted to GPO for publication. The congressionally mandated reports in GovInfo are those that are in scope of Public Law 117-263, the James M. Inhofe National Defense Authorization Act for Fiscal Year 2023, sections 7241-7248, cited as the “Access to Congressionally Mandated Reports Act.”

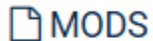

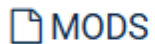

The agency's enabling statutes, the Railroad Retirement Act and the Railroad Unemployment Insurance Act, grant the RRB the authority to administer comprehensive retirement, survivor, and unemployment-sickness benefit programs.

Board Coverage Decisions (BCDs) are final agency decisions that determine employer and employee status under the Railroad Retirement Act and the Railroad Unemployment Insurance Act. For an employer these decisions determine whether it is required to pay taxes under the Railroad Retirement Tax Act and follow the RRB's rules and regulations. For employees these decisions determine whether their work history makes them eligible for benefits under the acts.

This is a curated collection of BCDs. Every available employer coverage decision is in the database, while only a select number of employee service decisions are included. The selected employee service decisions discuss and analyze classes of employees, rather than individual cases. If you require searching the entire collection, please contact the National Archives and Records Administration.

The Next Wave, Vol. 26, No. 1, 2025: AI Collaboration & Partnership



Artificial Intelligence (AI) has garnered significant attention in recent years, but its roots extend deep into the past. Fundamental AI concepts emerged in the 1950s, with the first neural network constructed from vacuum tubes in 1951 and the concept of training models from data defined in 1958. AI has always been an interdisciplinary field, integrating math, computer science, biology, psychology, engineering, and other areas. In 1985, logic programming and rule-based systems were the primary AI areas of study. Just a few years later, in 1991, neural networks regained prominence. AI and machine learning have continued to evolve over the past three decades, driven by advancements in computation speed and memory capacity. Today, AI technology is integrated into systems across all sectors of the economy and national security. As we witness creative proliferation of AI across many different missions, new threats and risks emerge. NSA provides cybersecurity guidance and standards for the US national security community and defense industrial base. It is critical to understand the risks that AI can introduce in order to prioritize and mitigate them. The complexity and dynamic variety of AI technologies necessitate partnerships across organizational and disciplinary lines. This issue of The Next Wave presents seven examples of such partnerships that span across NSA, national laboratories, academia, and industry. Each of these partnerships demonstrates how combining different perspectives and experiences contribute to results and progress against AI mission challenges.

About United States Government Policy and Supporting Positions (Plum Book)

Published by the Senate Committee on Homeland Security and Governmental Affairs and House Committee on Government Reform alternately after each Presidential election, the Plum Book lists over 7,000 Federal civil service leadership and support positions in the legislative and executive branches of the Federal Government that may be subject to noncompetitive appointment, nationwide. Data covers positions such as agency heads and their immediate subordinates, policy executives and advisors, and aides who report to these officials. The duties of many such positions may involve advocacy of Administration policies and programs and the incumbents usually have a close and confidential working relationship with the agency or other key officials.

The major categories of positions listed in United States Government Policy and Supporting Positions include:

- Executive Schedule and salary-equivalent positions paid at the rates established for levels I through V of the Executive Schedule;
- Senior Executive Service "General" positions and Senior Foreign Service positions;
- Schedule C positions excepted from the competitive service by the President, or by the Director, Office of Personnel Management, and other positions at the GS-14 and above level excepted from the competitive civil service by law, because of the confidential or policy-determining nature of the position duties.

The Plum Book is used to identify presidentially appointed positions within the Federal Government. The list originated in 1952 during the Eisenhower administration. For twenty-two years prior, the Democrats controlled the Federal Government. When President Eisenhower took office, the Republican Party requested a list of government positions that President Eisenhower could fill. The next edition of the Plum Book appeared in 1960 and has since been published every four years, just after the Presidential election.

Beginning in 2025, individual agencies are responsible for the accuracy, completeness, reliability, and up-to-date status of the information listed in the policy and supporting positions in the executive branch of the Federal Government and other Federal entities. This data is aggregated and made available by the [U.S. Office of Personnel Management](#)  consistent with the "PLUM Act of 2022" (5 U.S.C. 3330f; Pub. L. 117-263, div. E, title LIII, §5322(a)(1); (136 Stat. 3255)). GPO harvests online sources of the original hosting or authoring agency and may not reflect current policy. As Federal agencies add publications to their websites, or report new publications to GPO per statutory mandate (44 U.S.C. §§ 1710, 1902-1903), GPO ensures long-term preservation of and access to the content.
