Kathy Hale -> All Participants: National Digital Public Library (NDPL) and other digital repositories exist in many states

Paula Webb -> All Participants: We also provide free training to the local Native American Tribe, the Poarch Creek

Daniel Cornwall -> All Participants: +1 Freya - good point. Full disclosure, I am her coworker.

Jane Canfield -> All Participants: I reach out to school librarians in the area-Puerto Rico does not have a well-developed public library system so I go to individual schools and reach out to local school systems and do workshops for small groups of school librarians-free stuff from the government is very attractive

Daniel Cornwall -> All Participants: +1 Arlene - same in Alaska. Grants are available to libraries that collaborate.

Alison Griffith -> All Participants: Good point, Arlene! Same in MO

Susanne Caro -> All Participants: Our school librarians have a news letter and a conference- both are good ways to reach out and build relationships

Paula Webb -> All Participants: I have done a Help! Webinar. Very easy to work with.

Thomas Waters -> All Participants: I recommend visiting other depositories in your region, if you have the time and money. Not only do you notice things at other depositories that you can bring back to implement at your own, but their librarians can also point out some areas that you've been blind to when they visit at your library.

Jane Canfield -> All Participants: Our library staff participate in many of the GPO webinars -a selling point is the certificate of participation since we have do do portfolios every 5 years \

Daniel Cornwall -> All Participants: Building on Arlene, states are required to have LSTA plans and make

them public. Can review them to see where your collaboration might fit in.

Jane Canfield -> All Participants: If your library is also a state census data center, that is an easy collaboration for providing census training

Benjamin Aldred -> All Participants: In Northeastern Illinois we have a local group of documents librarians that meet twice annually, NIDL. It's very helpful to know the area resources and to share expertise.

Marianne Mason -> All Participants: GIO was a great collaborative effort but is in flux right now. Revival is in process.

Kathy Hale -> All Participants: Daniel, tell them about the GODORT lib guides and State Agency database

Virtual Speaker -> All Participants: Make sure that as you are chatting that your ~38quot;send to~38quot; field is going to ~38quot;All Participants~38quot; - otherwise, only panelsists are seeing your comments,

Marianne Mason -> All Participants: Maybe letting our U.S. Congressional Reps. know about the resources the share authenticated ~38quot;factual~38quot; information--Steve King is from Iowa

Andrea Stelljes -> All Participants: Minneapolis Central (Hennepin County) is a PTRC for the state of Minnesota. We have one expert librarian who will work with patrons by appointment and offers a patent searching workshop once a month. The rest of us try to help patrons get started using the uspto.gov website. Just FYI:(

Andrea Stelljes -> All Participants: that should be :)

Pat Behles -> All Participants: Is there any way to make the sound higher? I have my computer all the way up

Pat Behles -> All Participants: thank you

Marie Concannon -> All Participants: Our FDLP fiche is segregated from other fiche. Our FDLP fiche does not smell like vinegar. Our non-FDLP fiche does smell like vinegar.

kate Irwin-Smiler -> All Participants: yay barn raising!

Elizabeth Psyck -> All Participants: This is a silly, but serious question: should I be smelling my fiche? Are there certain periods of fiche that are worse than others? It sounds like FDLP fiche is ok but maybe non-FDLP fiche isn't?

Marie Concannon -> All Participants: The smell of vinegar can hit you as soon as you walk into a room with fiche stored in it

Susanne Caro -> All Participants: I've been testing mine, some that reacts does not smell

kate Irwin-Smiler -> All Participants: aside from smell, test how?

Marie Concannon -> All Participants: Maybe we got lucky with our FDLP fiche if it was stored in a less-humid room... I don't know. But sounds like there's a shelf life at any rate!

Susanne Caro -> All Participants: There are acid test strips you can buy that will indicate the level of acid present

Patty Andersen -> All Participants: I thought that for a while Library of Congress got paper when we all got MF.

kate Irwin-Smiler -> All Participants: thanks susanne.

Kate Tallman -> All Participants: we were always told to keep our diazo separate from our silver halide. is this old advice? I was told that it would cause a reaction and degrade the image

John Olson -> All Participants: Only our NASA and NACA fiche smell

Marianne Mason -> All Participants: Ulowa NASA fiche were degraded. Jelly like

Marie Concannon -> All Participants: Good to know

Susanne Caro -> All Participants: ERIC are the ones that appear to be more of an issue, and NASA

Susanne Caro -> All Participants: Marie, Jelly fiche? do you have images of this?

Marie Concannon -> All Participants: That was Marianne's

Marianne Mason -> All Participants: Nice catch Suzanne

Hugh Truslow -> All Participants: My biggest preservation concern is data on CD-Roms, especially older ones. Will that be within the scope of the obsolete media white paper?

Marie Concannon -> All Participants: Readex put a lot of FDLP materials on fiche and sold it commercially, FYI, because there may be another source for masters

Monica Dorame -> All Participants: At University of New Mexico we had early part of ASI, IIS, SRI fiche that had the vinegary smell and were really warped so we had to get rid of those years

William Kenz -> All Participants: What about the JPRS and FBIS fiche? Ours are discolored but don't smell

Susanne Caro -> All Participants: Does anyone know what the blue fiche is? Is it different from other fiche?

Marie Concannon -> All Participants: This all has huge implications for regionals, since some took fiche instead of paper copy (for example with Y4 docs)

Jane Canfield -> All Participants: We don't have a lot of GPO microfiche, but some. We had to discard some ERIC fiche which was actually purchased at some point and which was totally stuck together and getting eaten by bugs. Warning here is that if you live in a warm area, like Puerto Rico, bugs may also be a problem

Leigh Brown -> All Participants: Concerned about our Congressiona Record microfiche holdings (Proceedings and Debates and Index; Daily Digest).

Freya Anderson -> All Participants: We have a microfilming lab, and use silver halide microfilm for preservation for a lot of other, mostly non-federal, publications. It sounds like the concerns you have aren't with silver. Is that accurate?

Susanne Caro -> All Participants: I'm working on gettong photo's of ours and which ones are at risk

kate Irwin-Smiler -> All Participants: + Rich. Swatches even!

Sinai Wood -> All Participants: maybe post images or video clips

Marie Concannon -> All Participants: Yes, and how close do silver and diazo need to be in order to cause the reaction? In the same cabinet? In the same room?

Jane Canfield -> All Participants: How about having samples at the October conference also?

Yvonne Williams -> All Participants: i thnink that's a great idea.

John Olson -> All Participants: microfiche roadshow

Jane Canfield -> All Participants: good idea on bring fiche--I will start packing tonight

kate Irwin-Smiler -> All Participants: ~38quot; bring your variously gross fiche to DLC~38quot; LOL

Yvonne Williams -> All Participants: I was thinking that GPO could bring the samples.

Marie Concannon -> All Participants: I wanna see one that bugs ate!

Freya Anderson -> All Participants: Sounds like relatively good microform preservation conditions might be a silver lining to having weaker sun in Alaska!

William Kenz -> All Participants: Off topic a bit, but we still house a large collection of those Readex Serial Set Micro-Cards. They are still perfect, and I/ve been working with them for for 33 yrs here. Problem is, the readers are impossiblel to service so we have to be really careful. But the images are remarkabley still great

Susanne Caro -> All Participants: Anyone planning to digitize their fiche?

Beth Downing -> All Participants: When is the webinar?

Sandra McAninch -> All Participants: Does GPO or their contractor have the capability to digitize fiche?

Melissa Bernstein -> All Participants: I think that's sort of what I was asking (re: digitizing fiche).

Kirstin Krumsee -> All Participants: Susanne, very very slowly

Melissa Bernstein -> All Participants: Webinar is on May 9

Ashley Dahlen -> All Participants: The May 9 webinar will be announced shortly along with the registration. Stay tuned!

Sandra McAninch -> All Participants: + 1 regarding Readex microprint. It's holding up just fine.

Susanne Caro -> All Participants: I have computer reels (census), what can/should I do with those?

Jane Canfield -> All Participants: ok Marie, I will bring one that the bugs ate parts of

Susanne Caro -> All Participants: I don't know the history of the reels

Susanne Caro -> All Participants: Ithink they are from the 1980 census

Jane Canfield -> All Participants: yes, our census stuff is state data center, but it's the ERIC microfiche that got eaten by bugs

Vicki Tate -> All Participants: We also have reels of published population census 1790-1970 from Research Press.

Marie Concannon -> All Participants: computer data reels or microfilm reels?

Chris Brown -> All Participants: There is a significant percentage of microfiche that doesn't need to be preserved, since it was also distributed in print format or has otherwise been digitized. We probably need to do an inventory of what is only on fiche.

Daniel Cornwall -> All Participants: Chris - good point.

Gwen Sinclair -> All Participants: We have wood samples from Supreme Commander in Japan -- not depository item

Daniel Cornwall -> All Participants: Gwen - wow!

Mary Ann Ries -> All Participants: I disagree it provides info as to the env. in the past much like core samples

Aimee Quinn -> All Participants: Chris is correct. There is also the challenge that many fiche was sent to depository libraries which were added to depositiory collections but are not actually part of the FDLP because they came through a different depository system. They still need to be preserved and we should use the same preservation practices for them.

Jane Canfield -> All Participants: We have original long playing records of Puerto Rican artists in our Music Room-not depository but cool

Aimee Quinn -> All Participants: To my knowledge, a complete inventory of FDLP fiche has not been compiled.

Susanne Caro -> All Participants: Red, vinyl Somkey Bear LP

William Kenz -> All Participants: I only brought up the JPRS (Joint Publications Research Service) and FBIS IForeign Broadcast Information Service) fiche is that they provided excellent translations of foreign press and were very helpful for research. If one day they were available online, they'd prove really useful again.

Sandra McAninch -> All Participants: Many depositories have been told that they do not have to offer fiche that they want to discard. I see this as another real threat to the survival of unique titles on fiche. I hope the community will express concern about this practice.

Daniel Cornwall -> All Participants: Susanne - only you can prevent forest fires.
