Project Update

- Expansion of Pilot Project that began in August 2011
- A small task force was formed to work on project
- Outcome of work was presented at the Fall DLC Conference in October 2012
- Update on progress since then



Overview of Pilot Project

- Began partnership with Archive-It and use of Heritrix
- Teamed with IIPC partners for guidance (LC, UNT)
- Developed workflow to incorporate use of automated tool to capture entire websites in addition to existing workflow creating purls of individual publications
- Created MD using RDA (crosswalk DC ->MARC) and access in two locations
- 8 collections were publically released and presented at DLC

Update: Staffing & Procedural Improvements

- Overall effort to increase personnel resources, budget dependent
- Additional Librarians (Bibliographic Control) for workflow refinements and production increase
 - DC metadata
 - Cross walk of DC to MARC data for ILS records
- Additional support in harvesting sites and QA of archived sites and collections



Update: Content (Collections)

- More collections available through Archive-It
- Currently in process of ingesting additional content into the ILS, soon to be available in the OPAC (CGP)
- Since August 2011 we have archived over 18,800,000 files (images, pdfs, documents) and 1,900 GB of data



Future Endeavors

- Further increases to production and staff
- Possible inclusion of community in QA of archived sites (crowdsourcing)
- Revision of official policy
- Branded site on Archive-It

What is a NARA Affiliate Archive?

- A public or non-profit archive that holds – by written agreement with NARA – Federal records owned by NARA.
- Acts as NARA's agent, arranging, describing, preserving, and providing reference and access services for the Federal records.
- NARA retains legal custody for the records.
- NARA and the Affiliate work together to provide the public access to the Federal records placed in the Affiliated Archive.



Why are there Affiliated Archives?

- To provide enhanced access to Federal records and the information they contain through partnerships with premiere repositories nationwide.
- To ensure that NARA's responsibility is met to preserve, protect, and make accessible Federal records to the American people using the special resources and expertise of the Affiliated Archives.
- To ensure Government accountability to the American people.



Establishing an Affiliated Archive

- Application packet submitted
- Preliminary evaluation
 - To determine if the applicant meets all of the basic eligibility criteria
- Formal review
 - NARA Affiliated Archives Review Team (AART)
 - Repository visit and evaluation by NARA staff
 - Submission of any requested documentation
 - Staff interview(s) with AART



The Decision

- Demonstrated ability to provide enhanced public access to the records and the information in the records beyond what NARA is able to provide
- Demonstrated institutional commitment to the long-term preservation of the records
- Demonstrated capability to protect the information in the records
- Demonstrated ability and stated agreement to follow NARA reference, arrangement, description, preservation, and security guidance





Memorandum of Understanding

August 12, 2003

The Public Printer and the Archivist signed an MOU that established an affiliated relationship between GPO and NARA

June 16, 2006

An addendum to the 2003 MOU declared the University of North Texas Libraries an Affiliated Archive of NARA for the CyberCemetery

October 24, 2012

MOU revised to incorporate GPO's Federal Digital System (FDsys) content

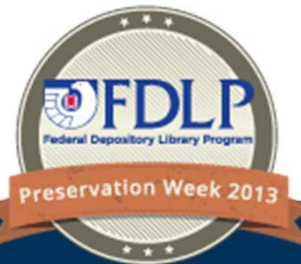

Partnership Update

- Continue to maintain partnerships with 15 depository libraries and 9 Federal agencies
- Renewed the agreement with the University of Illinois at Chicago for our participation in Government Information Online: Ask a Librarian
- Working on several new partnerships



Partnership Update

University of Montana: Cooperative Cataloging

- Added over 250 bibliographic records for Forest Service publications since October 2012
- Now over 740 records for historic Forest Service publications in the CGP
- Continue to process 50 records a month
- Keyword search: Cataloging Partner; University of Montana



Partnership Update

University of Florida

- Expanded to include 5 additional agencies
- Add record to the CGP for tangible version and create one for the digitized version
- Completed sample of records from the National Recovery Agency and Panama Canal

GPO's Federal Digital System

- FDsys became GPO's official system of record in November 2011 for authentic, published information from the three branches of the Federal Government
- Since launched in January 2009, the number of titles accessible from FDsys has expanded to include more than 800 thousand and FDsys has experienced more than 400 million document retrievals
- FDsys collections include:
 - Congressional Record
 - Congressional Bills and Hearings
 - Federal Register
 - Federal Budget
 - United States Code
 - U.S. Courts Opinions



New FDsys Content

- Administrative Office of the United State Courts
- Statutes at Large
- U.S. Department of the Treasury



Administrative Office of the United States Courts

- 2011 – Pilot to increase access to opinions from Federal appellate, district, and bankruptcy courts
- September 2012 – Judicial Conference of the US approved national implementation of access to all lower Federal court opinions through FDsys
- By the end of FY2013 opinions of the remaining 10 appellate, 75 district, and 87 bankruptcy courts will be added to the FDsys U.S. Courts Opinions collection
- Consistently in the monthly top 10 most used collections



Statutes at Large

- Early 2013 – Enhancements released for 1951 – 2002 Statutes on FDsys
 - Descriptive metadata for public laws, private laws, concurrent resolutions, and presidential proclamations
 - Added a lower level of granularity that improves searchability and access to this collection
- Digitization of and access to these historical documents is part of a partnership between GPO and the Library of Congress
- Full U.S. Statutes at Large collection on FDsys includes volumes 65–123, covering the 82nd –111th Congresses



U.S. Department of the Treasury

- Late 2012 – Pilot to make digitized content from the Treasury Library available on FDsys
- GPO is authenticating, archiving, and cataloging the Treasury Library's digital content
- Bibliographic records are in the Catalog of U.S. Government Publications (CGP)
- Titles available through this partnership are:
 - Treasury Reporting Rates of Exchange, 1956-2005
 - The Official Register of the United States: between the years of 1829 to 1959
 - An Account of the Receipts and Expenditures of the United States: between the years of 1793 to 1890



Forthcoming Treasury Titles

- Combined Statement of the Receipts and Expenditures of the United States: 1872-1983, which contains fiscal year receipts and expenditures of the Government by appropriations.
- Internal Revenue Cumulative Bulletins: 1919-2008, a consolidation of all items of a permanent nature published in the Internal Revenue Bulletins (IRB).
