

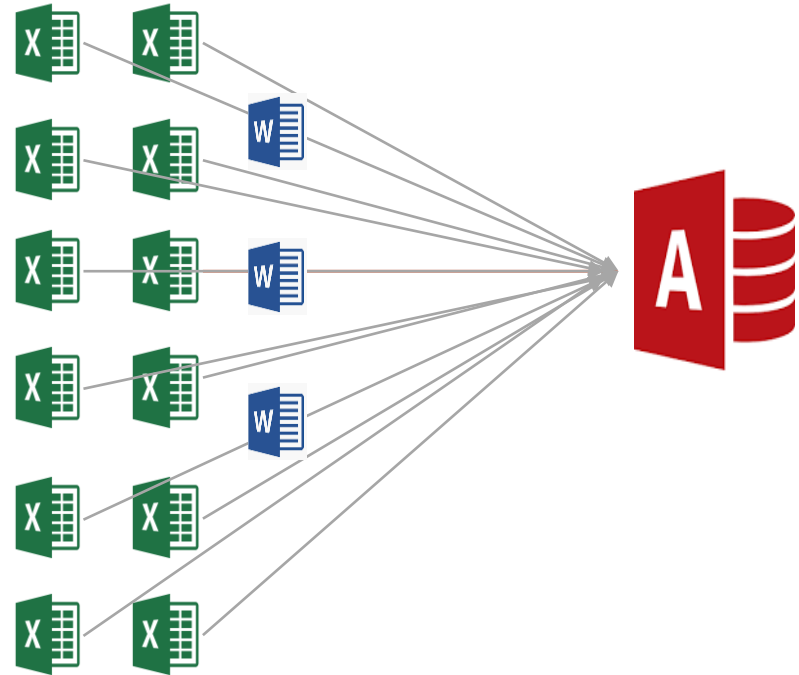
Software development cycle

The Law Library of Congress has been collecting foreign official gazettes since the mid-nineteenth century and maintains one of the largest collections of these sources in the world. Official gazettes are primary sources of law published by national governments to disseminate new legislation, regulations, and decisions of governmental bodies. These publications may also contain other information including the text of international agreements, court decisions, official announcements, and government notices. For countries with civil law systems, the official gazette often serves as the sole source of the authoritative texts of laws until updated codes are published. In most countries, a law enters into force on the date of publication in the official gazette.

The Law Library's gazette collection includes current, historical, and subnational jurisdictions. The two dashboards ([desktop](#) and [mobile](#)) on this page represent an interactive, geographic index of the gazette collection owned by the Law Library of Congress. Users can explore the collection via an interactive map, or use the dropdown menus to search and filter results. Each row represents a different record in the catalog and users can see specific holdings information by clicking on the Library Catalog link for that record. The collection represented in the dashboard is content owned by the Law Library of Congress meaning the "digital" filter in the search will yield only content that has been digitized by the Library and not gazettes in commercial databases or free online collections. Please refer to the [Guide to Law Online](#) for gazettes that are freely available online. The dashboards are updated regularly to edit records and add additional jurisdictions.

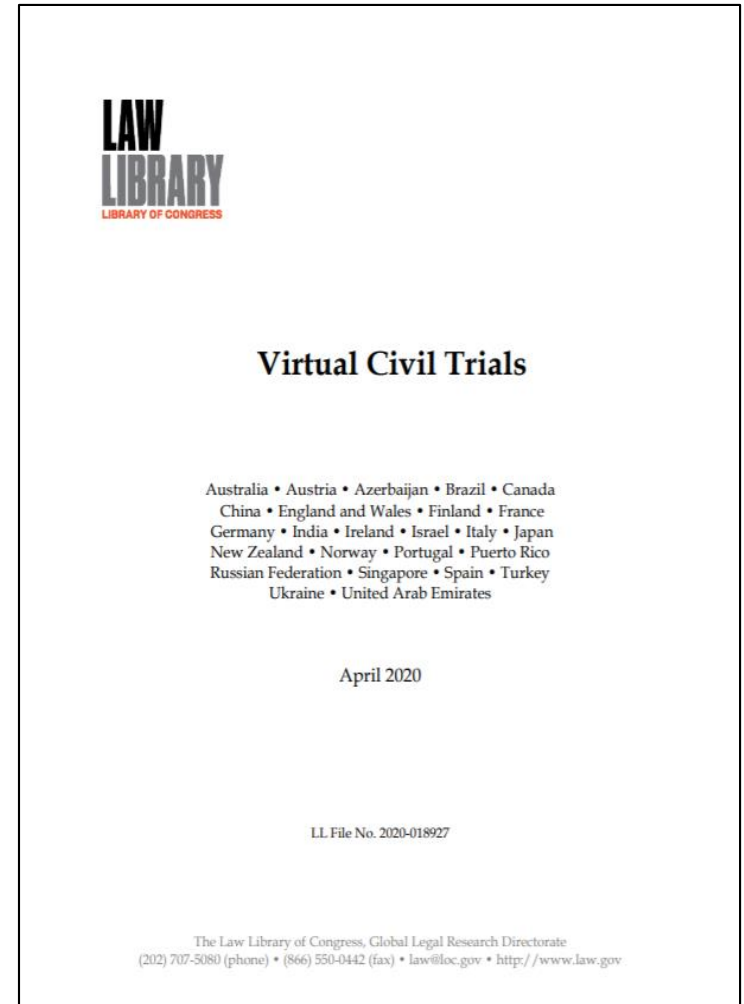

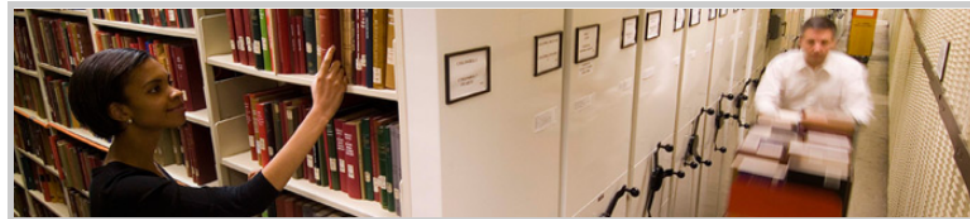

This multinational report on airport noise regulations surveys the laws of the European Union; six of its Member States (France, Germany, Italy, Portugal, Spain, and Sweden); and the United Kingdom. Noise thresholds typically vary between the surveyed jurisdictions as well as between individual airports, taking into account both geographic and commercial interests. All jurisdictions surveyed require that noise from airports be taken into account when planning and zoning new residential areas and airports. Other methods for limiting noise levels include the imposition of taxes or fines on airlines or airports that violate established noise thresholds. (Feb. 2020)

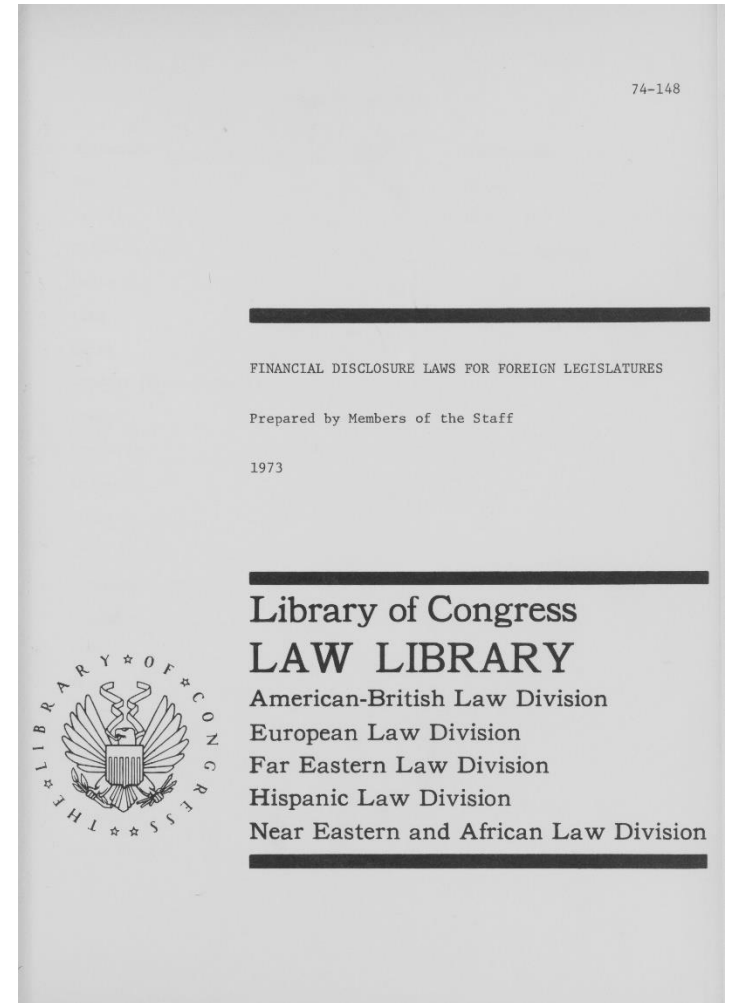

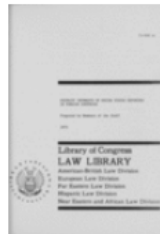

Performance Target: Increase discoverability of Law Library-generated research reports by preparing 2,000 reports (born-digital or digitized) for ingestion into CTS during FY20.

Quarter Milestone	Accomplishment
Q1: Prepare 350 reports for CTS ingestion.	369 reports were ingested in CTS.
Q2: Prepare 450 reports for CTS ingestion (800 total)	A total of 1,424 GLRD reports were ingested directly by LAW staff, or being prepared to ingest in CTS (via Digital Scan Center); 627 reports over the target of 800 reports.
Q3: Prepare 550 reports for CTS ingestion (1350 total)	A total of 2,687 GLRD reports were ingested directly by LAW staff or being prepared to ingest in CTS (via Digital Scan Center.) 1,337 reports over Q3 1,350 target. 687 reports over APG of 2,000.
Q4: Prepare 650 reports for CTS ingestion (2000 total)	A total of 2,698 GLRD reports were ingested directly by Law staff or being prepared to ingest in CTS (via Digital Scan Center.) 698 reports over the APG of 2,000.
