But marking the items that will be weeded will help in an upcoming RFID project for Tech Services folks, so they don't RFID tag items marked for weeding.

**Deborah Mongeau** -> All Participants: The planned large projects required several people to be on site which didn't happen so I worked on projects that I alone could work on.

**Susanne Caro** -> All Participants: We were able to have student work on a large inventory project from home

**MaryBeth Will** -> All Participants: Anything that required in-person was delayed. Since I was given remote Library wide tasks, the challenge will be to get back to Docs.

**Perveen Rustomfram** -> All Participants: Delayed some retrospective conversion projects and some shifting projects. Got caught up on cataloging of discards which we have made good progress on.

**Jennifer Morgan** -> All Participants: We are running out of space in our gov docs collection, but we don't weed, so I need to find out if IU's off-site storage facility will allow us to send more materials to them.

**Lucy Duhon** -> All Participants: Finally took the time to learn the FDLP eXchange platform and dedicate time to needs and offers backlog work.

**Yvonne Williams** -> All Participants: We postpone all Govdocs outreach projects, which personally is my passion.

**Reiley Noe** -> All Participants: Delayed retrospective cataloging and paper weeding because we were remote for part of the time and I was pressed into mostly instructional tech duties.

**Alice Sherwood** -> All Participants: Lack of volunteers forces us to slow down on some things **Alicia Kubas** -> All Participants: with all these weeding projects were there issues with weeding if your regional wasn't able to go in-person to check stacks for items?

**Bernadine Hoduski** -> All Participants: remember that agencies eliminate older docs from their web sites and may no longer be available. federal libraries often discard their own docs - so another source is gone.

Jenny Groome -> All Participants: Alicia I was wondering that too

**Ronnie Joiner** -> All Participants: Digitization Project. However, this is complicated because our digital managment system is out-of-date.

**Elissa Lawrence** -> All Participants: Alicia-- as the regional, yes, it has impacted me.

**Alice Sherwood** -> All Participants: Alicia, yes, since they can't physically see it due to traveling restrictions.

**Jennifer Morgan** -> All Participants: BTW, IU's offsite storage facility is a Federal Documents Light Archive -- Indiana has a state plan for the light archive.

**Elissa Lawrence** -> All Participants: It has been a great time for the selectives to work on weeding projects, but it has bogged the regional down since we are working primarily remotely.

**Lucy Duhon** -> All Participants: Made good use of the Cataloging Record Distribution Program (CRDP) to get access to more online records easily

**Jennifer Morgan** -> All Participants: My library wants to undertake a digitization project, but we are looking at Indiana state documents, might start with the Indiana Register.

**Simon Healey** -> All Participants: almost all projects where delayed or cancelled as we had two lengthy periods of working completely from home without even access to ILS system so no weeding / cataloging ... only projects have been emeranged disaster reaction to small flooding in both remote stacks and hidden stacks still in the 100+ year old Central library

Alicia Kubas -> All Participants: a lot of our projects were necessarily postponed but have just taken a

lot longer to accomplish as we've had to find so many workarounds

Alicia Kubas -> All Participants: \*weren't

**Alice Sherwood** -> All Participants: A lot of weeding takes longer since it takes regional longer to approve items once posting to FDLP Exchange

**Yvonne Williams** -> All Participants: Conversely, it has allowed our government documents to be highlighted as many documents came out that were immdiately highlighted more than once during the course of the pandemic, especially in rhe first few months.

Rick Mikulski -> All Participants: Genuine apologies to everyone for the poor audio

**Susan Woitte** -> All Participants: It's hard to run a search during a pandemic!

**Donald Sensabaugh** -> All Participants: Our retirements actually came before the pandemic, but it has kept us from hiring one of the positions.

**Alice Sherwood** -> All Participants: We have also lost staff since many main branch staff have to be sent to branch libraires to help with curbside, computer use and stuff like that due to hiring freeze once branch staff guit or retire.

**Andrea Cox** -> All Participants: I checked both Hiriing Freeze and Staffing has not changed because I was actually hired during the pandemic but then the position was frozen due to hiriing freeze, but I was ultimately hired later in the year

**Ashley Dahlen** -> All Participants: All - please be sure to chat to "All Participants" otherwise others cannot see your comments!

Martha Ballinger -> All Participants: We have had all of the staffing effects except layoffs.

Carl Olson -> All Participants: My employer has avoided furloughs/layoffs so far. Thank goodness.

**Elisabeth Garner** -> All Participants: We've done well with Enrollment Growth money, so our university has actually been advertising for new positions. About half of folks are still teleworking, but other half is back either full time in person, (like me), or in-person partially

Simon Healey -> All Participants: Jepody music for polls

**Sarah Dobransky** -> All Participants: A lot of these are time-dependent for us. First we froze hiring, then reduced hours, then went back but had retirements, then we filled open positions, not we're getting back to normal.

**Jennifer Morgan** -> All Participants: @Donald -- us too! We had three retirements right before COVID, and couldn't replace two positions due to University-wide hiring freeze.

**Sarah Dobransky** -> All Participants: \*now

**Kate Irwin-Smiler** -> All Participants: Some of our retirements are yet to come - one was postponed by a furlough (!), and happened in September; on is in June and one is.... TBD.

**Jenny Groome** -> All Participants: Need to add a question - do you know if it will be temporary or permanent?

**Elizabeth McDonald** -> All Participants: We did get to hire a couple of new librarians that we have not

**Vicki Tate** -> All Participants: Most of the time I am a department of one. But I do not believe this will be permanent.

**Bert Chapman** -> All Participants: Some faculty hiring has resumed.

**Louise Buckley** -> All Participants: Changing workflows and probably more cross-training

**Laura Tolliver** -> All Participants: A lot of new job duties.

**Jennifer Creevy** -> All Participants: We haven't lost anyone yet, but expect some reduction this fall/spring.

**Jennifer Morgan** -> All Participants: Staffing didn't change in the gov docs department, but 3 librarians retired right before COVID and only one was replaced, so that means more work for the rest of us, yay!

Laura Tolliver -> All Participants: I miss all our librarians who retired due to covid

Alicia Kubas -> All Participants: our cataloging/metadata team was decimated so we're currently hiring

3 catalogers, but we've had retirements across the libraries and are down 20% of our staffing **Paige Shank** -> All Participants: library has been closed to public for last year so loss of staff not felt as much. Furloughs were temporary

**Alice Sherwood** -> All Participants: Retirement incentive coming along the way due to new fiscal year finance issues

**Simon Healey** -> All Participants: Haven't lost anyone from the now very small Gov Pub section of 3 librarians and one LA ... overall the system has lost a lot of our younger librarians in the 45 branch system

**Margaret Sylvia** -> All Participants: Some changes may be temporary and some appear to be permanent. We don't seem to have a plan, or at least our administration hasn't communicated it to us.

**Jenny Groome** -> All Participants: I mean - we don't always know if you will be able to go back to previous staffing levels

**Rick Mikulski** -> All Participants: We have needed to really justify the need for a full-time govdocs cataloger/processor. We've had mixed success, as the docs tech was retained but given additional non docs duties.

**Chad Deets** -> All Participants: I would say it's been a strategic rethinking of vacancies. Some positions were moved from one area to another to address immediate needs. Hiring is slowly starting again, but will ramp up slowly.

**Jocelyn Baldwin** -> All Participants: We are on a staggard schedule now so we are not all in the building at the same time. We are hoping to keep the remote access.

**Rebecca Stockbridge** -> All Participants: Our hiring freeze was finally lifted and we are able to hire some new staff! So much relief!

**Yvonne Williams** -> All Participants: Positions were frozen during the pandemic. Slowly during the course some changes were made and people offered positions, generally speaking they had already interviewed for the position prior to the pandemic.

**Myles Robert** -> All Participants: Some shelving staff were temporarily furloughed. But the library admin used the time to regroup and hire some postions that had been open.

**Kate Irwin-Smiler** -> All Participants: We're hoping to be able to replace our first retirement (Please! I'm covering a lot of her duties!)

**Lisa Meyer** -> All Participants: Our circulation department is severely understaffed while the rest of the entire library, with the exception of the Government Documents Dept, works from home the majority of the time - - it has caused a great deal of morale challenges

**Beth Downing** -> All Participants: Some of our staffing changes were not necessarily due to COVID, but University budget issues, but it definitely did not help.

**Aimee Quinn** -> All Participants: Same as Rick - we need to justify each hire

**Valerie Glenn** -> All Participants: our university offered retirement incentives last year; we've received approval to replace the one person from my department who left (map cataloger)

Elizabeth McDonald -> All Participants: New faculty are not tenure track

**Paige Shank** -> All Participants: We are hiring and people are being moved to fill positions. Preparing to reopen May 4!

**Elizabeth McDonald** -> All Participants: Yes

**Evelyn Hurley** -> All Participants: Two librarians took buy-outs, but we were able to fill the positions... but we were down a few positions before 2020, so we haven't returned to the former staff levels.

**Janelle Breedveld** -> All Participants: I was hired into my role during the pandemic. Our systems librarian retired in Dec, and we've struggled to fill that role since.

Paige Shank -> All Participants: Furloughs were due to budgets as well.

**Alicia Kubas** -> All Participants: we're looking at a reorg which my library had already been thinking about but it's been more important to realign with less staff to cover areas

**Perveen Rustomfram** -> All Participants: We've had one resignation; there is a hiring hiatus and need to justify filling of positions; just been given permission to fill one of the vacant librarian positions.

**Andrea Craley** -> All Participants: All library staff have been able to keep their scheduled hours. It's just that we have a rotation of a low number of staff in the building at certain times, so some rotate in person and most are still teleworking. Staffing levels have not changed - still the same staff. Just our library open hours are reduced.

**Yvonne Williams** -> All Participants: We hippe we get back to the regular routine on hiring.

**Alice Sherwood** -> All Participants: Resignation happened quite a bit due to staff morale, lots of staff asked to work in busy branches as needed for a few days to few months at a time.

**Charity Park** -> All Participants: We are awaiting a decision about a resturcturing process for our university. We might lose a few staff positions.

**Jenny Groome** -> All Participants: Long term union agreements have been a blessing right now. It will mean many retirements next year

**Aimee Quinn** -> All Participants: Starting next year, all state employees will have mandatory furlough days

**Sarah Dobransky** -> All Participants: Funding has shifted towards "pretty" departments that do large online events (think major author visits) - it's hard to justify any gov doc assistance.

**Paige Shank** -> All Participants: Our library did a reorganization of positions and staff as well- though we have mixed feelings about things

**Simon Healey** -> All Participants: If not for Biden's American Rescue Plan, my city ~38amp; public library would have been facing disaster

**Greg Reynolds** -> All Participants: Our public library is only allowing internal transfers. No new hiring yet. Have to get approval for anyone who is promoting (moving to a higher salary). Quite a few people have retired over the last few months in various departments.

**Renée Bosman** -> All Participants: It's likely that our student budget will be permanently lowered **Patricia Willingham** -> All Participants: Our library has lost both the head of tech services and the head of public services and 2.5 out of 3 info lit librarians. That is the tip of an ugly and huge iceberg

Jocelyn Baldwin -> All Participants: Yes student budget will be smaller

**Yvonne Williams** -> All Participants: We anticipate some of the staffing changes to be permament; however, hopfully they will be positive.

**Ronnie Joiner** -> All Participants: We shifted staff around to fill in for shortages in other city departments. Some staff worked from home answering phones. Some of us worked at the Zoo part time during lockdown.

Jane Canfield -> All Participants: We are all doing more jobs and working more hours. Not being physically present helped to ease the situation somewhat. Our good news is that in August we will gain two professional librarian positions and two more in January to cover retirements and add one new position. We will recove assistant personnel when we return to in person hopefully bu July.

**Alice Sherwood** -> All Participants: We did temp checks when needed in city buildings and other city depts

**Margaret Adams** -> All Participants: our Educational Technologist retired, hiring freeze is in effect I am now covering her duties
