What is Knowledge Management (KM)?

Knowledge management is the process of capturing what we know and sharing it with others.







Why Use KM?

Knowledge can be reused or repurposed.



It means no one has to reinvent the wheel.





KM enhances the applicability and the impact of your publications by:

- capturing what you have learned
- structuring it in a reusable format
- sharing it with others





How do we use KM in the ECLKC?

- Structure and manage content based on the experiences of our audiences
- Present resources in a wide-variety of formats that meet the needs of our audiences



Content Development Process: Value



- Congruence with Head Start Program Performance Standards
- Correspondence with the Head Start Operations
- Support for professionals in the field



The Content Development Process: Structure & Quality Assurance



- Identify the relevant topics and subjects
- Identify the type and format for the information
- Parse the document
- Submit for quality assurance



The Content Development Process: Publish



•A final version of the resource is added to the selected topics and subjects

•A final review is conducted by the resource sponsor and core team





Getting Started

Identify a core team including a contact person from the Regional Office or Technical Assistance (TA) network, Subject Matter Expert (SME), a writer, content area work zone members of the Community of Practice, experts, consultants

Select a training material or resource that has potential value and benefit to Head Start and Early Head Start programs





- Is it consistent with HS Program Performance Standards and all other HS regulations? Are these cited within the resource?
- Are all attributions included? (Include references and citations that demonstrate validity and authenticity.)
- Is content and reading level appropriate for the intended target audience?





Criteria (continued)

- Cite scientifically-based research that promotes effective practice
- Determine and define the content area domain
- Apply quality assurance standards



Why Do We Have Style Standards?



Style standards ensure that content has a consistent look and feel.







Criteria (continued)

- Does the resource meet style Standards?
- Requirements of the ECLKC content are based on the:
 - Government Printing Office Style Manual,
 - Chicago Manual of Style 15th edition, and
 - Webster's Third New International Dictionary Unabridged





Criteria (continued)

- Are permissions signed for all photos, images and graphics?
- Are permissions for copyrighted materials included?
- All videos must have transcripts
- No materials can be included that are for sale





Now what happens?

 Submit the resource in electronic format to the SME who with other national contractors provides an initial review

 The reviewers make recommendations to the Office of Head Start regarding the potential of the resource to be included in the ECLKC

What happens next?

- The Federal Team Lead, SME, and other members of the core team consider the resource and the recommendation to prepare the resource for the ECLKC, following established Content Guidelines
- Post on the content area work zone for comment, invite input from other regions, cite programs with promising practices



What happens next?

- Review comments from Work Zone members and make recommended modifications that reflect the feedback
- Modify the resource based on Work Zone recommendations




