FDsys Gets Rave Reviews

GPO's Federal Digital System (FDsys), has been operating successfully for three months and the system is getting rave reviews from users. FDsys is a a world-class information management system developed to authenticate, preserve, version, and provide permanent public access to Government information. The system gives the American people a one-stop site to authentic, published government information, while enhancing the searching and browsing capabilities currently found on GPO Access. FDsys offers incredible search capabilities for users, such as: searching by Congressional Committee, Congress Member, keyword and date. All of the information available on GPO Access is being migrated into FDsys, with more than 154,000 documents currently available on FDsys and additional documents added daily. The migration of data will be completed on a collection by collection basis (i.e. the Federal Register, Congressional Bills, Congressional Record) and at present FDsys currently contains eight collections.

These collections include:

- Compilation of Presidential Documents
- Congressional Bills
- Congressional Documents
- Congressional Record
- Congressional Reports
- Federal Register
- Public and Private Laws

The expected completion date to migrate the remainder of the *GPO Access* content to FDsys is mid-2009. After a collection has been migrated, any new content added to that collection is available within both FDsys and *GPO Access*. Prior to the completion of the overall migration effort, FDsys and *GPO Access* will exist in parallel. FDsys is available at **www.fdsys.gov**. GPO Committed to Transparency

In a recent letter to President Barack Obama, GPO's Public Printer, Bob Tapella, detailed how GPO can help implement the White House's transparency and open government agenda. Tapella included five goals and planned actions for the President to review. Those goals are:

- **1. Goal:** Position GPO's Federal Digital System (FDsys) as the official repository for Federal Government publications. **Action:** Develop pilot concepts with the Administration's Open Government office.
- **2. Goal:** Enable and support Web 2.0 functionality through FDsys to support public comments on pending legislation. **Action:** Develop a pilot with the Open Government office to evaluate the process to collect comments on selected bills.
- **3. Goal:** Establish a demonstration project to apply Web 2.0 features to rulemaking documents. **Action:** Applying lessons learned, extend the demonstration project to the entire Federal Register on FDsys in a systematic way.
- **4. Goal:** Participate in and lead efforts to standardize electronic publishing formats. **Action:** Meet with the Office of Management and Budget (OMB) e-Government and Information Group to develop guidelines for extending StratML to other Federal publication types.
- **5. Goal:** Link the White House's Web site to FDsys for public searches of Government documents. **Action:** Contact and establish a working relationship between GPO's FDsys and the White House Web team. This would include creating a White House/GPO working group/Web team, providing a demonstration of FDsys for the White House Web team, and establishing a recurring meeting with the White House Web team for information exchange.

Major Capabilities by Release

Future releases of FDsys will continue to enhance the capabilities of the system. The major capabilities of FDsys by release are listed below.

Highlights of Release 1

- Search across multiple collections with a single search box
- Faceted search (filters)
- Descriptive and authenticity metadata available in MODS and PREMIS xml files
- A Digital preservation capabilities through manual format migration
- Authenticated documents with digital signatures
- Simple, advanced, and retrieve by citation search options
- Browse government publications
- Search within search results
- Suggested spelling for search terms
- Document in Context feature for Congressional Record, Federal Register and Compilation of Presidential Documents

First New Collection on FDsys – Daily Compilation of Presidential Documents

The online Daily Compilation will replace the printed Weekly Compilation of Presidential Documents. An archive of the Weekly Compilation of Presidential Documents is available on GPO Access. Like its predecessor, the Daily Compilation of Presidential Documents will contain formal Presidential orders and statements, remarks at press conferences, messages to Congress, agencies, and foreign leaders, as well as other materials released by the White House Press Secretary. Material appearing in the Daily Compilation is edited for accuracy and annotated with additional information to provide an authoritative record of the Presidency. As an FDsys Web publication, the Daily Compilation of Presidential Documents will reach a much broader audience and will be updated frequently, as information is released by the White House press office.

In the coming year, GPO and the OFR will launch new web services on FDsys. The *Daily Compilation* is just one aspect of the GPO/OFR partnership's commitment to provide state-of-the-art information services to the American people. •

Public Turns to FDsys for Stimulus Bill

GPO experienced high demand for The American *Recovery and Reinvestment Act of 2009*, more commonly known as the *Stimulus Bill*. The electronic version of the bill was authenticated by digital signature. The digital signature, viewed through GPO's Seal of Authenticity, assures the public that the document has not been changed or altered.

"GPO's Federal Digital System is the place to find authentic government Bob Tapella. "GPO is committed to providing Americans transparency on the workings of their government. Two key elements in managing federal documents on FDsys are versioning and authentication. Versioning lets the user know which version of a document is being presented and it is important when viewing legislation and draft documents. Authentication is necessary to maintain a chain of custody from author to end user." •

What's Coming in Release 2?

Release 2 of FDsys focuses on the submission of content from Congress into FDsys. FDsys will provide Congressional Content Originators with an interface to electronically submit Congressional Bills, letterhead,

envelopes, and other ephemeral material to GPO, along with metadata related to the content. FDsys will assemble this content into a submission package for ingest and approval and will perform automatic scope determinations based on the content, metadata, and business process information. Scope determinations may also be made based on the access rights and privileges assigned to the user submitting the content. For example, all Congressional Bills will be automatically considered in-scope based on either the metadata or the permissions given to the person submitting the Bills and content such as letterhead and envelopes will be automatically considered out-of-scope. Designated GPO employees will have access to all content and job information that is originally submitted to FDsys by a Congressional Content Originator, allowing them to create new renditions (i.e. text or PDF formats) of this content and add additional job information. GPO is also able to submit Congressional and Office of the Federal Register content to FDsys which was not originally submitted to FDsys by the content originator. Development on Release 2 is expected to be complete in late-2009. •

What is the GPO Seal of Authenticity?

AUTHENTICATED U.S. GOVERNMENT INFORMATION GPO

Many of the documents available on FDsys , including the recent *American Recovery and Reinvestment Act*, contain the GPO Seal of Authenticity. The GPO Seal of Authenticity provides assurance that an electronic document has not been altered since GPO disseminated it. The visible digital signatures on online PDF documents serve the same purpose as written signatures or traditional wax seals on printed documents. A digital signature, viewed through the GPO Seal of Authenticity, verifies document integrity and authenticity of online Federal documents, at no cost to the customer. GPO is currently signing Congressional Bills and Public and Private Laws within FDsys.

Challenges in the Digital Age

- Access to government published information is now widely expected to be electronic
- Digital information needs to be authentic and verified to be the correct version
- Digital information needs to be available for access almost immediately
- Information needs to be preserved, making it available for generations to come



GPO's Federal Digital System (FDsys)

- GPO's Federal Digital System (FDsys) is a customer-driven advanced digital information system.
- FDsys will automate the collection, management and dissemination of electronic information from all three branches of government.
- · Information will be:
 - Submitted directly into FDsys
 - Permanently available in electronic format
 - Authenticated and versioned
 - Publicly accessible for searching and downloading
 - Available for conventional and on-demand printing

What is FDsys?

- FDsys is a Content Management System
 - FDsys securely controls digital content throughout its lifecycle to ensure content integrity and authenticity
- FDsys is a Preservation Repository
 - FDsys follows archival system standards to ensure long-term preservation and access of digital content
- FDsys is an Advanced Search Engine
 - FDsys combines extensive metadata creation with modern search technology to ensure the highest quality search experience



FDsys and Submission

Content within FDsys will come from three sources:

- · Submitted directly into FDsys
- Harvested automatically from official Federal websites
- Converted from previously printed publications into digital files

FDsys and Access

The FDsys search philosophy:

- Provide simple search with advanced results
- Provide advanced search features so users can efficiently retrieve specific documents
- · Provide relevant results fast



FDsys and Authentication

Content authentication will ensure:

- Content has been approved by, contributed by, or harvested from an official source
- Content has been verified by GPO to be complete and unaltered

FDsys and Preservation

Digital preservation processes will:

- Safeguard digital content and relevant metadata
- Assess the condition and needs of collections of digital information
- Meaningfully render content despite continually changing technology



FDsys Implementation Approach

- Define major releases of FDsys
 - Build the foundational infrastructure and preservation repository, and replace current public access site (GPO Access)
 - Enable submission of content from additional sources
 - Extend FDsys functionality to interface with external systems
 - Automate preservation processes in FDsys preservation repository
 - Tailor FDsys to better meet individual user needs
- Enhance and improve functionality based on user feedback between major releases
 - Flexibility of enhancements based on expressed needs

FDsys is live!

- Release 1 launched to the public on January 15th
 - Compilation of Presidential Documents
 - Congressional Bills
 - Congressional Documents
 - Congressional Hearings
 - Congressional Record
 - Congressional Reports
 - Federal Register
 - Public and Private Laws
- Daily Compilation of Presidential Documents was released on January 20th

Release 2 Activities

- Focus on the submission of content from Congress into FDsys
- Provide Congressional Content Originators with an interface to electronically submit Congressional bills, letterhead, envelopes, and other ephemeral material to GPO, along with metadata related to the content
- Development on Release 2 is expected to be complete in late-2009



Advanced Interfaces to FDsys

- Position GPO's Federal Digital System as the official repository and access location for Federal Government publications
 - Develop pilot concepts with the Administration's Open Government office
- Participate in a Legislative Branch task force to study bulk data distribution and develop a recommendation to Congress

FDsys and COOP

- Plans are underway to establish an offsite backup for FDsys

 - COOP site planned to be operational in July 2009

Release 1 Beta Summary

- · Formal beta testing

 - Release 1 informal beta will continue until data migration is complete
