# NCSA Quarterly Meeting

# Updates

- ROLS policy update closed for comments on 9/9, awaiting revised policy statement
- Regional Discard policy update closed for comments on 10/8, awaiting revised policy statement
- With revised policies in place, the Superintendent of Documents may authorize regionals to deselect and/or to weed some material – at the NCSA level.



#### Agreement updates

- Print Selector agreements:
  - No new updates since last meeting in July
  - When ROLS PPS is finalized, we will be able to authorize new regional online selections in all 4 NCSAs, covering CFRs, Y1s, and superseding Y4s (depending on which NCSA agreements were signed in)
- Preservation Steward agreements:
  - Partnership team has been busy reviewing existing agreements, modifying existing agreements, and signing new agreements
  - Regional discard may be authorized (if eligible)
  - In particular, they have added "day forward" element to some of the agreements, which means ROLS may be authorized in the future (if eligible)
  - Update given at DLC Preconference: <u>FDLP Academy Training Repository</u>



# Microfiche wrapping up

- Last of the CFRs were shipped (contract expired on 3/31)
- Wrapping up distribution of Y 1s and Y 4s (contract expired on 4/30)
- Bound Congressional Record still in conversion (contract expired 9/30)
- FR and LSA editions will wrap up at end of calendar year
- Daily Congressional Record edition will wrap up at the end of the 117<sup>th,</sup> Second Session (Jan. 3, 2023)

As of early October - 82.5% of the MF content has been fully distributed



### Next steps

- Distributing last of microfiche, waiting two months (to ensure record distribution), and then inactivating item numbers
- Inactivation is on hold for now:
  - Serial content in microfiche format is treated differently
    - If the paper format serial record continues, cataloging rules say we cannot close out the microfiche format record
    - We are seeking an exception to close out the serial microfiche format records
  - When the ~ 278 serial microfiche records are closed off, we can wait, and then resume inactivating item numbers
    - If we inactivate the item number now, the closed out serial records will not distribute to libraries



# FDLP Data Manager (FDM)

- Will begin beta testing in FY 2023, Quarter 1
- Will show FDLs selecting item numbers by NCSA and state
- Will hopefully help FDLs understand what they are profiled for and in what format they are selecting
  - Many libraries think they are "EL only" but they are not
  - Will have training to go over FDM and DSIMS to help libraries update their selection profiles



# Quarterly checks

- Print Selectors are selecting per their agreement
- Preservation Stewards (day forward) are selecting per their agreement
- Regional copy selectors are selecting per their agreement (temp. via Regional Copy List of Classes, eventually via SHA for Regional Copies)
- Regionals are comprehensive in tangible selections (except where exempt due to ROLS authorizations or regional copies are under an agreement elsewhere)
