It manages the Federal Depository Library Program (FDLP), which ensures that government publications are available to the public through a network of participating libraries known as depository libraries. GPO's mission is to provide access to government information for the American public, keeping them informed about the workings of their government. The Depository Library Council (DLC): The DLC is an advisory committee composed of librarians and other information professionals. It was established to provide advice and guid

Jen` Kirk -> All Participants: ance to the GPO on matters related to the FDLP. The DLC's primary role is to provide recommendations to the GPO Director, who is also the Superintendent of Documents, on policy

matters, program improvements, and other issues that impact the depository library community. The Council also serves as a forum for communication and collaboration between the depository libraries and the GPO. In summary, the relationship between the DLC and the GPO is one of collaboration and partnership. The DLC serves as an advisory body to the GPO, helping to shape policy and improve the FDLP, while the GPO is responsible for the production and distribution of government information, as well as managing the FDLP. Together, they work to ensure that the American public has free and open access to government information through the network of depository libraries.
