GOOD AFTERNOON, EVERYONE. WELCOME TO THE FDLP ACADEMY, WE HAVE ANOTHER GREAT WEBINAR FOR YOU TODAY. TITLED DEMO AND Q&A FOR FDLP EXCHANGE RELEASE ONE POINT ONE. MY NAME IS JOE, OUTREACH LIBRARIAN AT GPO. I WILL BE HOSTING AND CO-PRESENTING WITH MY COLLEAGUE, DONALD IN OUR FEDERALLY DEPOSITED SUPPORT SERVICES, WE ARE THE MAIN POINTS OF CONTACT FOR THE DEPOSITORY LIBRARY IF YOU NEED ANYTHING, TRAINING WITH ANY PART OF THE EXCHANGE. WE ALSO HAVE IN ATTENDANCE, MY COLLEAGUE, LISA RUSSELL WHO HAS WORKED ON THE DEVELOPMENT OF THE FDLP EXCHANGE AND IS NOW THE TECHNICAL LEAD ON IT, SHE WILL BE ADDING COMMENTS TO THE CHAT AS SHE FEELS THE NEED TO. PLEASE CHECK THAT, LISA KNOWS EVERYTHING ABOUT THE EXCHANGE, SHE WILL HAVE SOME GOOD TOPICS, ALSO WITH ME IS MY CALLING -- COLLEAGUE, ASHLEY. TECH SUPPORT FOR THE WEBINAR, DONALD WILL BEGIN THE PRESENTATION.

THANK YOU, JOE. HELLO, EVERYONE. FDLP EXCHANGE ONE POINT ONE IS PRIMARILY A PLATFORM MIGRATION OF A FEW CHANGES. AS YOU CAN SEE IN THE SCREENSHOT ON THE SLIDE, THE DASHBOARD WILL REMAIN THE SAME. THIS PARTICULAR IMAGES OF THE DASHBOARD FOR A LIBRARY ADMIN AT REGIONAL. NOTE THAT THE CONTENTS SHOWN IN THE SCREENSHOT WILL SPAN TWO COLUMNS AS IT CURRENTLY DOES AN EXCHANGE. THERE ARE GOING TO BE SEVERAL CHANGES TO THE WAY THAT SPREADSHEETS ARE HANDLED AND EXCHANGED WITH THE 1.1 RELEASE. FIRST, SPREADSHEETS WILL BE LIMITED TO 250 LINES MAXIMUM. INSTRUCTIONS FOR CONVERTING THE FORMAT, THEY HAVE BEEN LINKED TO THE FDLP EXCHANGE INSTRUCTION PAGE AND SOMEONE WILL BE PUTTING THAT IN THE CHAT POD. IF YOU PUT THAT FOR TRAINING MATERIALS, DID YOU SEE THE INSTRUCTIONS ARE THE THIRD BULLET. THEN THE NEXT EXTRACTIONS WILL BE AVAILABLE ON THE UPLOAD SCREEN. THERE WILL NO LONGER BE A SHORT UPLOAD AND LONG UPLOAD OR EXCHANGE. BEFORE POSTING SPREADSHEETS, PREVIOUSLY, THE LIMIT ON THE SHORT UPLOAD WAS BASED ON FILE SIZE. THE NEW LIMIT WILL BE BASED ON THE NUMBER OF LINES IN THE SPREADSHEET. THE CHANGES TO THE UPLOAD SCREEN IS A LINK OF PROMOTING X OS X TO CSV FORMAT. IT WILL BE FOR CSV FORMAT, THE SCREENSHOT UNFORTUNATELY CUT THIS OFF BUT THERE HAS BEEN A MINOR REVISION TO THE INSTRUCTIONS IN THE TEMPLATE. NEXT, WE HAVE CHANGES THAT DATE FIELD IN THE SPREADSHEETS. MOVING FORWARD, NONE SHOULD BE USED WHEN THERE IS NO DATA AVAILABLE FOR A DATE FIELD SUCH AS WHEN A SPECIAL -- SHIPPING LIST IS UNAVAILABLE. DATE FIELDS MUST BE FORMATTED AS THE FOUR DIGIT YEAR, TWO DIGIT MUCH AND FOUR DIGIT YEAR, OR TWO DIGIT MONTH, TWO TO DAY, AND FOUR DIGIT DEAR. -- YEAR. OTHER FORMATS, SUCH AS 20 15 FEBRUARY WILL NO LONGER BE ACCEPTED. THE SHIPPING LIST/RECEIPT DATE WILL STILL NEED TO BE A FULL DATE, UNLESS NONE IS USED. THE DATA DICTIONARY WILL BE UPDATED TO REFLECT THESE CHANGES. HERE IS A SCREENSHOT OF THE REVIEW PANEL OPEN TO EDIT AND OFFER, THE PUBLICATION START DATE WHICH IS THE TOP RED CIRCLE IN THIS IMAGE. IS THE TWO DEBIT -- DIGIT MONTH AND THE TWO DIGIT YEAR, NONE IS SAFE FOR THE INSTITUTION. THE TEXT IN THE GRAY BOX BENEATH THAT FIELD AND THE DATE RECEIVED YIELD HAVE BEEN CHANGED. IF YOU LOOK CLOSELY, YOU WILL SEE THE TEXT SPECIFYING NONE INDICATES ACCEPTANCE OF THE LEGAL DISCLAIMER BELOW. THERE IS NO LONGER A CHECKBOX FOR YOU TO CLICK ON. SITE NOTIFICATIONS WILL NOT BE MIGRATED OVER TO THE NEW SITE, THEY WILL CONTINUE TO CLEAR AS THEY ARE REVIEWED AS WITH THE CURRENT SITE. ON THE NEW SITE, NOTIFICATIONS WILL CLEAR AFTER 30 DAYS OF A HAVE NOT BEEN VIEWED. THE REASON WE ARE MAKING THIS CHANGE IS THAT IT SHOULD ADDRESSED AN ISSUE CAUSED WHEN A USER HAD TOO MANY UNCLEAR NOTIFICATIONS PREVENTING THE DASHBOARD FROM LOADING AFTER LOGGING IN. AS PART OF MIGRATING THE PLATFORM, THERE WILL BE A BRIEF SHUTDOWN OF UP TO SEVEN DAYS THIS SUMMER, THE DATES ARE TO BE DETERMINED

BUT WE WILL BE SENDING OUT NOTIFICATIONS IN ADVANCE. THE SHUTDOWN WILL NOT STOP THE TIME IN THE REVIEW PERIOD BECAUSE OF THE SHUTDOWN, REGIONALS WHO USE EXCHANGE SHOULD CONSIDER INCREASING THE REGIONAL PHASE ONE, AND SELECTING PHASE TWO REVIEW PERIODS TO MAKE SURE NOTHING EXPIRES, ANOTHER OPTION IS POTENTIALLY TO ENCOURAGE THEIR SELECTIVE'S TO NOT SUBMIT ITEMS FOR A PERIOD OF TIME BEFORE THE SITE IS SUCKED -- SHUTDOWN COMMENCES, TO GO BACK TO THAT FIRST OPTION, PLEASE BE AWARE IF YOU LENGTHEN YOUR REVIEW PERIOD AND THEN YOU SHORTEN IT BACK DOWN, WHEN YOU SHORTEN IT BACK DOWN AGAIN, THE ITEMS ALREADY THAT WERE IN THERE FOR THE SHORTEN PERIOD OF TIME WILL AUTOMATICALLY ADVANCE TO THE NEXT STAGE. WHAT THAT MEANS IS IF YOU TAKE IT FROM 30 DAYS TO 45 DAYS AND THEN BACK DOWN FROM 45 DAYS TO 30 DAYS, ANYTHING THAT WAS ALREADY IN THE QUEUE FOR 31+ DAYS WILL AUTOMATICALLY MOVE ONTO THE NEXT STAGE AND THAT MIGHT BE AN UNINTENDED CONSEQUENCE, THAT MIGHT BE POTENTIAL. SORRY, DATES AND DETAILS ABOUT FDLP DEVELOPMENT WILL BE SHARED OVER EMAIL. FOR DETAILS ON RELEASE FORM POINT ONE, ONE .2 AND ONE .3. CHECK OUT THE DEVELOPMENT PAGE, THAT LINK WILL BE PUT IN THE CHAT FOR YOU ALL. I WILL NOW HANDED BACK TO JOE FOR THE DEMO AND TO ANSWER THE QUESTIONS WE RECEIVED IN REGISTRATION.

THANK YOU, DONALD. HERE WE GO, THIS IS, I'M GOING TO DEMO THIS. PROBABLY EVERYONE IN THE AUDIENCE HAVE DONE THIS, WE ARE DEMO IT ANYWAY IN CASE YOU NEED IT. I WILL SHARE, LET ME SEE IF I GET THIS RIGHT. WRONG THING, SORRY. I HAVE GOT TO GET THAT, HOLD ON A SECOND PLEASE. SORRY ABOUT THAT. CAN YOU SEE THAT, EVERYONE, CAN YOU RECEIVE THE SPREADSHEET? I HOPE.

WE SEE IT, JOE.

THANK YOU, HERE IS A BASIC SPREADSHEET THAT WE HAVE USED ALL. I'M USING WINDOWS, A REGULAR WINDOWS PC SO MAC MAY DIFFER. I'M NOT THAT FAMILIAR WITH MAX. CLICK THE FILE IN THE TOP LEFT, DO A SAVE AS. PICK A PLACE THAT YOU WANT TO PUT THIS, I WILL PUT THIS IN MY DOWNLOAD FOLDER. YOU CAN RENAME IT IF YOU WISH, I WILL HAVE THE FILE NAME THE SAME SO I WILL RENAME IT HERE. THEN CHOOSE FROM THIS LENGTHY LIST OF OPTIONS, THERE IS A COUPLE OF DOZEN OF OPTIONS. WHAT YOU WANT IS CSV COMMENT UNLIMITED, YOU DO A SAVE AND THAT DOES IT. IF I GO BACK TO MY DOWNLOAD FILE, I WILL SEE THE WHILE SITTING THERE. JUST USE THAT TO UPLOAD TO THE EXCHANGE. WE ARE ONLY GOING TO BE OFFERING THAT THAT -- EXCUSE ME. STOP SHARING, WE WILL ONLY BE OFFERING THE CSV FROM THE PLACE ON THE EXCHANGE WHERE YOU UPLOAD SPREADSHEETS. IN THE INSTRUCTION PAGE FOR THE FDLP EXCHANGE, THERE WILL BE XLSX TEMPLATES AND YOU CAN USE THOSE AND SAVE THOSE AS CSV IF YOU WISH. OKAY, THERE'S ALSO ONE OTHER THING. MY COLLEAGUE ASKED ME TO REMIND YOU OF THIS. THERE IS SOMETHING CALLED, SOME PEOPLE USE FORMULAS IN THE SPREADSHEETS WHICH KIND OF MESS UP THINGS A LITTLE BIT. IF YOU ARE DOING THAT, WHAT YOU WANT TO DO IS COPY THE SPREADSHEET AND PASTED INTO ANOTHER SPREADSHEET, XLSX AND PASTE AS SAVE AS VALUE, WHICH IT MIGHT BE THE SECOND PASTE OPTION THAT HAS NUMBERS ONE, TWO, THREE. JUST A LITTLE QUIRK, PROBABLY NOT A LOT OF PEOPLE DOING THAT. OKAY. LET'S GET ON TO THE QUESTIONS. WHAT WE LIKE TO DO IS RESTRICT QUESTIONS IF WE COULD. UNLESS WE HAVE AN AWFUL LOT OF TIME, AT FIRST, ANYWAY PLEASE RESTRICT QUESTIONS IN THE CHAT TO THIS NEW UPDATE THAT WE ARE DOING, THE 1.1. WE ARE GOING TO START BY LOOKING AT SOME OTHER QUESTIONS THAT WE RECEIVED, IN THE REGISTRATION FORM. SO, FIRST QUESTION, WHEN WILL THE SHUTDOWN TAKE PLACE? WE WILL HAVE A BRIEF SHUTDOWN UP TO SEVEN DAYS WHICH WILL TAKE PLACE SOMETIME IN EARLY SUMMER. EVERYONE WILL BE NOTIFIED BY A POST, WE WILL POST IT ON FDLP.GOV, WE WILL SEND A NEWS ALERT AND WE WILL ALSO SEND AN EMAIL TO ALL COORDINATORS WHO SHOULD IDEALLY HAVE ADMIN ACCOUNTS IN THE EXCHANGE.

OKAY, QUESTION TWO. DOES THIS STAY THE TIME OF ALL OFFERS DURING THE SHUTDOWN MEANING OF SOMEONE HAD THREE DAYS TO GO BEFORE THE SHUTDOWN, ONCE BACK UP AND RUNNING, DOES IT STILL HAVE THREE DAYS TO GO IN OFFERS. THE ANSWER IS NO. THE REVIEW PERIOD DOES NOT STOP DURING A SHUTDOWN. AS DONALD MOTIONED ON SLIDE EIGHT, IF YOU THINK THAT IS AN ISSUE AND YOU STATED, WE ASK FOR YOUR STATE, WE ASK YOU TO HAVE THE REGIONAL CONSIDER, THINK ABOUT WHETHER THEY WANT TO EXTEND THE REVIEW PERIOD OR NOT. YOU KNOW, THEY COULD BUMP IT UP, YOU COULD GO 0 TO 180 DAYS ON THE REVIEW PERIOD, THINK ABOUT THAT. QUESTION THREE, WHAT PROMPTED THE RELEASE? BASICALLY, AS THE SLIDE SAYS, THE PLATFORM REVISIONS ARE RELEASED PERIODICALLY AND THE EXCHANGE WAS DUE FOR A MIGRATION TO A NEWER RELEASE. QUESTION FOUR, WILL THERE BE A WAY TO BATCH UPDATE TITLES INTO THE 1.1 RELEASE? FOR EXAMPLE REMOVE AND DELETE MULTIPLE TITLES AT ONCE INSTEAD OF DELETING EACH INDIVIDUAL TITLE AT A TIME. NOT IN THE 1.1 RELEASE, BUT BOLT ACTIONS ARE AN ENHANCEMENT PLAN FOR OUR 1.2 RELEASE. QUESTION FIVE, WILL IT BE SOME SORT OF ARCHIVE OF DISCARD LIST? THAT IS, ARCHIVE FEATURE IS SOMETHING WE ARE INVESTIGATING FOR RELEASE ONE THREE. QUESTION SIX, WILL THERE BE A WAY TO CORRECT NUMBERS? THERE IS NO WAY TO CORRECT A SUDOC NUMBER, ONCE YOU ENTER IT, IT IS IN. IF YOU MADE A MISTAKE AND WANT TO KEEP IT FROM MOVING THROUGH THE SYSTEM, THERE'S A COUPLE OF WAYS YOU CAN STOP IT AND THEN RESUBMIT A GOOD SUBMISSION, HE OFFERING LIBRARY COULD CHECK MARKETS KEPT OR THE REGIONAL CAN CHECK, DISALLOW BEFORE THE END OF PHASE ONE REGIONAL REVIEW. TWO WAYS OF STOPPING, YOU CAN STOP IT AND THEN RESET IT A GOOD ENTRY. QUESTION SEVEN. IT DOES NOT RELATE EXACTLY TO THE 1.1 RELEASE, CAN YOU HAVE MORE THAN ONE ADMIN ACCOUNT? YOU CAN HAVE AS MANY ADMIN ACCOUNTS AS YOU NEED. YOU SHOULD HAVE AT LEAST ONE ADMINISTRATOR ACCOUNT, TYPICALLY THE COORDINATOR. USER ACCOUNTS ARE OPTIONAL, USER ACCOUNTS HAVE LESS PRIVILEGES. THAT IS EXPLAINED IN OUR INSTRUCTION PAGE, TIPS. IF YOU WANT A NEW ACCOUNT, SUBMIT AND ASK GPO QUERY, WE WILL WORK AND GET YOU THE ACCOUNTS THAT YOU NEED. SO, THAT IS THE END OF THE QUESTIONS FROM THE REGISTRATION FORM, IF YOU HAVE QUESTIONS, PLEASE PUT THEM IN THE CHAT, HERE IS CONTACT INFORMATION IF YOU WANT TO GET IN TOUCH WITH US, HERE IS DONALD AND MY CONTACT INFORMATION. PLUS WE ARE AVAILABLE FOR ANY TRAINING YOU MAY NEED, ONE-ON-ONE, MICROSOFT TEAMS OR RESUME IF YOU HAVE ZOOM PERIOD FOR YOUR STATE, YOUR INDIVIDUAL LIBRARY, INDIVIDUAL MULTIPLE STAFF, HOWEVER YOU WANT TO DO IT. YOU CAN ALSO, OUR PREFERRED WAY OF CONTACTING GPO IS THROUGH AND ASK GPO INQUIRY, SELECT A SUBJECT CATEGORY, FDLP EXCHANGE. THIS WEBINAR SLIDES, CHAT, ET CETERA RECORDING AND SLIDE, AND CHAT AND EVERYTHING WILL BE IN OUR TRAINING REPOSITORY, PROBABLY TOMORROW, MAYBE MONDAY. SO, I OPEN IT UP FOR A CHAT IF THERE IS ANY QUESTIONS IN THE CHAT.

SO, TO GET PEOPLE AN OPPORTUNITY TO PUT SOME QUESTIONS IN THE CHAT IF YOUR TYPING, I WAS GOING TO READ A FEW OF THE QUESTIONS THAT HAVE BEEN ALREADY ASKED AND THE ANSWERS THEY HAVE RECEIVED. I'M GOING TO START OFF WITH THERE ARE SOME QUESTIONS THAT SAY WILL FDLP EXCHANGE GIVE YOU AN ERROR MESSAGE IF YOU TRY UP -- UPLOADING A XLSX PRESS SPREADSHEET. THE ANSWER TO THAT IS YES IF YOU TRY TO UPLOAD A XLSX FILE, IT WILL GIVE YOU AN ERROR MESSAGE REMINDING YOU TO UPLOAD IN CSV. THE NEXT QUESTION WE HAVE STATES DOES THE DECREASE FROM 300 TO 250 ITEMS PER SPREADSHEET ALSO MEAN THAT THE NUMBER OF ITEMS ALLOWED TO BE IN REGIONAL REVIEW STATUS CONCURRENTLY IS ALSO BEING REDUCED? THE ANSWER TO THAT IS THE SYSTEM WILL NOT LIMIT THE NUMBER OF ITEMS IN REGIONAL REVIEW, YOU MAY WANT TO CHECK WITH THE REGIONAL TO SEE IF THEY LIMIT THE NUMBER OF OFFERS WITHIN A CERTAIN TIME PERIOD. SORRY, THIS CHAT IS MOVING FAST FOR ME, I'M TRYING TO GET TO THE NEXT QUESTION, IT IS KICKING ME BACK TO THE TOP. IF THERE IS AN UNPLANNED, EXTENDED DOWNTIME FOR THE TRANSITION, DO YOU HAVE ALTERNATE WAYS IN WHICH WE CAN KEEP SUBMITTING DISPOSAL

LISTS AND RECEIVING PERMISSION TO DISCARD? I AM CURRENTLY IN A MASSIVE LEADING PROJECT WITH A HARD DEADLINE OF AUGUST 2023. THE ANSWER IS WE DO NOT EXPECT EXTENDED DOWNTIME, PART OF THE REASON WE ARE NOT GIVING DATES IS BECAUSE YOU WANT TO MAKE SURE WE ARE READY TO GO LIVE WITHIN SEVEN DAYS OF TAKING THE SYSTEM DOWN, IT COULD BE LESS THAN SEVEN DAYS. I THINK THAT IS ALL THE ONES THAT I SEE HAVE ANSWERS.

ANY OTHER QUESTIONS, PLEASE PUT THEM IN THE CHAT.

JOE AND DONALD, I SEE A QUESTION FROM KARINA. I'VE ONLY ENTERED AROUND 200 OFFERS, THE IMAGE ON DONALD SLIDE WAS UNFAMILIAR TO ME. COULD YOU PUT IT INTO CONTEXT FOR ME?

YOU HAVE THE BALL, CAN YOU TAKE IT BACK TO SLIDE SIX? SO, THIS IS A SCREENSHOT OF THE REVIEW PANEL. IF YOU ARE GOING TO GO IN OUR OFFERS AND EXCHANGE, AND YOU HAVE TO EDIT THE OFFER TO SUBMIT IT. THIS IS WHAT YOU WOULD SEE AND SO, I THINK THAT IS THE CONTEXT YOU WERE LOOKING FOR. THIS IS IF YOU HAVE TO EDIT THE OFFER.

I SEE ANOTHER QUESTION, DIRECTLY RELATED TO, IT JUST JUMPED ON ME TOO. FROM JANEL, IS THERE A PLAN FROM THE FUTURE TO ADD A COLUMN WITH THE LIBRARY'S NAME ON THE REGIONAL REVIEW PAGE OF OFFERS?

I BELIEVE THE ANSWER TO THIS QUESTION IS NOT CURRENTLY, BUT I WOULD DEFER TO LISA ON THAT QUESTION IF SHE PUTS AN ANSWER IN THE CHAT.

I WILL KEEP MY EYE OUT FOR LEASES RESPONSIVE SHE HAS ONE. SHE'S PROBABLY LOOKING AT THE RELEASE SCHEDULE. FOR ALYSSA, WILL THIS RELEASE FIX ISSUES OF ITEMS NOT SORTING CORRECT ME WHEN TRYING TO SORT BY POSTED DATE? THE SYSTEM DOES NOT COOPERATE WHEN I WENT TO SEE THE ITEMS IN ORDER STARTING WITH THOSE EXPIRING SOONEST.

SO, TO MY KNOWLEDGE THE ANSWER TO THAT QUESTION IS ALSO NO. THAT MAY BE SOMETHING THAT YOU WOULD BE LOOKING INTO FOR FUTURE RELEASE, IT IS NOT PART OF THE 1.1 RELEASE AS FAR AS I'M AWARE, I WOULD AGAIN DEFER TO LISA ON THAT.

IT LOOKS LIKE LISA RESPONDS SHE WAS NOT AWARE OF THE ISSUE, PLEASE SUBMIT SOMETHING IN ASK GPO. I BELIEVE WE HAVE GONE THROUGH ALL OF THE QUESTIONS . I THINK AT LEAST, I HOPE. WE HAVE ONE FROM JENNY, I COULD BE WRONG BUT I THINK THE LATEST FDLP TRAINING VIDEO IS IN 2018, WILL LEAD BE DOING A NEW VIDEO WITH THE NEW RELEASE?

THE ANSWER TO THIS QUESTION IS -- I WILL LET JOE TAKE OVER.

THAT IS GOING TO HAPPEN, WE WILL HAVE TO WORK ON THAT, YET TO BE DETERMINED ON WHO AND HOW THE WORK WILL BE PARCELED OUT, I THINK. THE VARIOUS INSTRUCTIONS WILL BE UPDATED.

THANK YOU, JANEL. SHE ADDED IN APPARENTLY I DID GET CONFUSED, SHE SAYS IS THERE A PLAN FOR ADDING A COLUMN WITH THE OFFERING LIBRARY'S NAMES ON ALL THE OFFERS FOR THE REVIEW PAGE FOR REGIONALS? LISA SAYS MOST OF THE TIME IT WILL BE THE SAME, WE WILL ONLY BE DOING -- SHE'S RESPONDING TO THE VIDEOS. LISA SAYING WE WILL BE ONLY BE DOING NEW VIDEOS FOR THINGS THAT HAVE SIGNIFICANTLY CHANGED, THAT IS TO SPREADSHEETS. LORI ASKS, WILL THE RESPONSE TIME

IMPROVE THE 1.1 RELEASE, THE EXCHANGE RESPONSE IS VERY SLOW WHEN REQUESTING ITEMS FROM A LONG LIST.

JUST GIVE US A SECOND, WE ARE PROMOTING YOU TO A PANELIST. THERE WE ARE.

I WAS JUST ANSWERING THE QUESTION ABOUT THE RESPONSE TIME. THE RESPONSE TIME IS SOMETHING WE NEED TO LOOK INTO THAT MAY ACTUALLY BE MORE RELATED TO THE SERVER THAN THE FIVE. THAT IS SOMETHING THAT WE ARE GOING TO NEED TO LOOK INTO. AND LET'S SEE, I THINK I SEE FROM JANEL, SHE SAYS THE QUESTION YOU DID NOT HEAR, SHE ASKED IF THERE WAS A PLAN TO ADD A COLUMN WITH THE OFFERING LIBRARY'S NAMES ON ALL THE OFFERS FOR THE REVIEW PAGE FOR REGIONALS. DONALD HAD DEFERRED TO ME ON THAT. I DON'T THINK, I DON'T THINK THERE WAS A PLAN TO DO THAT. YOU CAN ACTUALLY FILTER MY LIBRARY IF YOU NEED TO DO THAT, IF YOU ARE REGIONAL REVIEWING OFFERS. ONE OF THE PROBLEMS WE HAD, IF THE OFFERING LIBRARY IS SOMETHING YOU NEED IN PANEL VIEW, THE LIST VIEW, WE CAN LOOK AT ADDING THAT. ONE OF THE THINGS WE HAVE TO CONSIDER THERE IS THE AMOUNT OF REAL ESTATE THAT'S AVAILABLE. ADDING THAT MIGHT MEAN TAKING AWAY SOMETHING ELSE. I THINK WE PROBABLY DECIDED NOT TO INCLUDE IT BECAUSE WE HAD THE FILTER BY LIBRARY THERE. IT WILL SHOW, IT DOES NOT NECESSARILY SHOW ONLY WHEN YOU'RE FILTERING BY LIBRARY. THE DROP-DOWN LIST WILL SHOW ALL OF THIS ELECTIVES IN YOUR REGION AND NOT JUST THE ONES THAT HAVE ITEMS IN THERE. KEEP THAT IN MIND IF YOU DECIDE TO USE THAT. WAS THERE -- ANOTHER QUESTION I WANTED TO RESPOND TO. THE TRAINING VIDEOS, SINCE THERE IS NOT A LOT OF CHANGE IN THIS ONE, A LOT OF THE DASHBOARD AND SO ON ARE PRETTY MUCH THE SAME. A LOT OF THOSE WILL NOT BE UPDATED AT THIS TIME, WE WILL BE UPDATING THEM WHEN WE DO 1.2. WHAT WE WILL BE DOING NOW IS NEW VIDEOS FOR ANYTHING THAT IS NEW, THINGS LIKE CONVERTING TO PDF, I'M SORRY NOT PDF. I'M TRYING TO TALK TO YOU GUYS, CONVERTING FROM XL TO CSV. EDIT OFFER, I'M NOT SURE WHAT THE QUESTION IS ABOUT EDITING THE OFFER. CURRENTLY, IF SOMEONE WHO HAS A LIBRARY ADMIN ENTERS SOMETHING, IT GOES INTO REVIEW QUEUE, I'M SORRY LIBRARY REVIEWS ENTER SOMETHING, IT GOES INTO A LIBRARY REVIEW QUEUE AND LIBRARY ADMIN HAS TO APPROVE IT, YOU CAN EDIT THOSE. ONE OF THE PROBLEMS WITH EDITING ITEMS IS THAT IT GETS A LITTLE BIT TRICKY FIGURING OUT WHAT YOU CAN EDIT AND WHERE, WHERE ARE YOU SUBSTANTIVELY CHANGING YOUR OFFER IF YOU WERE TO CHANGE THE TITLE OR THE SUDOC AFTER YOUR REGIONAL REVIEWED IT, AT WHAT POINT ARE YOU CHANGING ENOUGH THAT IT MIGHT ACTUALLY LOOK LIKE A DIFFERENT ITEM? THAT WAS ONE OF THE REASONS THAT THERE'S NOT A LOT OF EDITING AVAILABLE IN THE SYSTEM. ARE THERE ANY OTHER QUESTIONS THAT I HAVE MISSED?

I DON'T BELIEVE SO. DO WE HAVE ANY OTHER QUESTIONS?

I LIKED THE COMMENT ABOUT -- ACTIONS. I KNOW THAT HAS BEEN A BIT THING PEOPLE HAVE BEEN ASKING FOR, WE ARE LOOKING FORWARD TO BEING ABLE TO PROVIDE THAT. ONE OTHER THING I DON'T THINK WE MENTIONED IS THAT THE 1.2 ENHANCEMENTS ARE ALREADY IN DEVELOPMENT, SO HOPEFULLY IT WILL NOT BE A LONG WAIT FOR THOSE. THE THINGS WE HAVE CURRENTLY LISTED AS 1.3 ARE THINGS WE ARE TENTATIVELY PLANNING AT THIS POINT, THAT PART IS UNDER REVIEW BECAUSE IT'S BEEN A WHILE SINCE WE CAME UP WITH THOSE REQUIREMENTS. IF THERE'S ANYTHING THAT YOU DON'T SEE THAT YOU WOULD LIKE TO SEE, WE WOULD CERTAINLY LOVE TO GET THAT INPUT. IF THERE IS ANYTHING IN THERE THAT YOU REALLY THINK IS VERY IMPORTANT, PLEASE LET US KNOW THAT AS WELL. SO WE CAN ACCOUNT FOR YOUR NEEDS.

I DON'T KNOW IF YOU SAW IT, WE HAVE TWO MORE QUESTIONS I CAME IN. WHEN CAN WE EXPECT TO HEAR MORE NEWS ABOUT THE 1.2 UPDATE?

WE EXPECT TO HEAR MORE ABOUT THAT PROBABLY, SHOULD BE LATER THIS YEAR SOMETIME, WE SHOULD BE LAUNCHING WITHIN A YEAR ARE PROBABLY LESS THAN A YEAR. WE SHOULD HAVE MORE UPDATES AT LEAST BY THE END OF THE CALENDAR YEAR IF NOT SOONER. FROM JOY, SHE ARRIVED LATE, DID NOT KNOW IF IT WAS ALREADY COVERED. COULD SHE GIVE STAFF MORE PERMISSION SUCH AS TO MARK AND -- DISCARD.

THAT IS SOMETHING WE CAN CONSIDER. WE COULD ALSO, I DON'T KNOW IF ONE OF THE THINGS WE MENTIONED IN THE Q&A SESSION WAS THAT SOME PEOPLE ARE NOT AWARE YOU CAN ACTUALLY HAVE MORE THAN ONE LIBRARY ADMIN. IF YOU HAVE STAFF WHO ARE PRIMARILY RESPONSIBLE FOR HANDLING DISCARDS THAT YOU WANT TO HAVE THAT ACTION -- ACCESS. WE CAN UPGRADE THEM TO A LIBRARY ADMIN FOR YOU. IF IT IS SOMEBODY YOU FEEL LIKE YOU NEED TO CHECK THEIR WORK, I WOULD RECOMMEND LEAVING THEM AS A LIBRARY USER. WE CANNOT UPGRADE UNTIL YOU'VE GOT MORE THAN ONE LIBRARY ADMIN IF YOU NEED THAT. IF WE NEED ANY SORT OF INTERMEDIATE -- WE ONLY HAVE THE TWO LEVELS RIGHT NOW IF WE NEED TO COME UP WITH SOMETHING INTERMEDIATE, THAT MAY BE SOMETHING WE CAN LOOK AT ON THE LINE. IF YOU ARE INTERESTED IN THE FEEDBACK AS WELL.

I DON'T SEE ANY MORE QUESTIONS IN THE CHAT, DID YOU WANT TO START WRAPPING UP?

YOU ARE ON MUTE.

I'M SORRY ABOUT THAT. ASHLEY JUST PUT THE SATISFACTION SURVEY IN THE CHAT, PLEASE CHECK THAT OUT. WE HAD SOME EXTRA QUESTIONS, NOT ON THIS TOPIC. I DON'T KNOW IF WE WOULD WANT TO TOUCH ON THAT. DO YOU THINK WE SHOULD GET INTO THAT, A COUPLE OF QUESTIONS SINCE WE HAVE A LITTLE BIT OF TIME?

WE STILL HAVE A LITTLE BIT OF TIME LEFT IF YOU WANT TO GO AHEAD AND TACKLE SOME OF THOSE QUESTIONS, I THINK THAT WOULD BE FINE.

OKAY. IF ANYONE THINKS OF ANY OTHER QUESTIONS, YOU CAN STILL PUT IT IN.

PLEASE PUT QUESTIONS ABOUT THE 1.1 IN THE CHAT, SINCE WE HAVE A LITTLE BIT OF TIME, WE HAVE SOME QUESTIONS THAT ARE A LITTLE OFF THE TOPIC BUT IMPORTANT. WE CAN CHECK THOSE. WE HAD A QUESTION, EIGHT, HOW TO SUBMIT AN ITEM WITH NO SUDOC STRIPPING LIST DATE OR ANOTHER REQUIRED FIELD FOR THOSE ITEMS, LOOSELY FOR EXAMPLE SHOULD THEY BE ENTERED ONE BY ONE IN THE EXCHANGER IS THERE ANOTHER OPTION, SOME WON'T HAVE A REQUIRED FIELD TO SUBMIT. THE ANSWER IS THAT YOU DO HAVE TO RULE OUT ALL THE REQUIRED FIELDS, THERE'S WORKAROUNDS TO HELP YOU OUT IF YOU DON'T HAVE A SUDOC NUMBER, YOU CAN CHOOSE UNDER CLASSIFICATION TO MAKE THE APPROPRIATE CHOICES THERE, IF YOU DON'T HAVE A SHIPPING LIST DATE ON THE WEB FORM, CLICK THE BOX I DON'T HAVE A DATE AND CHECK THE LEGAL DISCLAIMER OR ENTER IT IN A SPREADSHEET. WHEN 1.1 IS IMPLEMENTED, ENTERING NONE WILL BE SUFFICIENT. FOR LOOSELEAF'S, ON THE INPUT FORM, YOU CAN CHECK YES, RADIO BUTTON. TO SAY THE PUBLICATION HAS MULTIPLE PIECES, ENTER A RANGE WITH THE PUBLICATION START AND END DATES AND ENTER ADDITIONAL INFORMATION AS APPROPRIATE IN ADDITIONAL NOTES, ADDITIONAL NOTES IS A SEARCHABLE FIELD SO IF SOMEBODY IS DOING A SEARCH, AND ADVANCED SEARCH, THEY NEED AN OFFICE REPOSITORY, THEY

WILL PICK THAT UP. LET'S SEE IF WE HAVE ANY OTHER QUESTIONS. HOW LONG SHOULD ITEMS BE IN THE PENDING APPROVAL BY ADMIN STATUS? BASICALLY, THAT'S FOR AS LONG AS THAT PERSON WANTS TO WAIT TO MAKE A DETERMINATION, THAT IS AS LONG, YOUR ADMINISTRATIVE ADMIN, ADMINISTRATOR ACCOUNT HOLDER IN YOUR LIBRARY HAS TO TAKE ACTION ON THE PENDING OFFERS APPROVAL BY ADMIN'S, THEIR CHOICES ARE THAT THEY CAN CLICK SUBMIT TO REPOSITORY OR THEY CAN CLICK DELETE AND THEY CAN ALSO CLICK EDIT IF THEY WANT TO EDIT. AND THEN SEND IT TO THE REPOSITORY. THEY CAN DO THAT. THAT'S ALL THE EXTRA QUESTIONS. WE HAD ONE THAT WAS VERY USER SPECIFIC, I WILL TRY TO GET BACK TO THAT PERSON. I THINK THEY HAD ISSUES SPECIFICALLY FURTHER LIBRARY, I WILL GET BACK TO THEM. I HAVE YOUR CONTACT INFORMATION. SO I CAN DO THAT. ANY OTHER QUESTIONS ON 1.1?

I HAVE NOT SEEN ANY COME IN, JOE. OKAY.

I THINK WE HAD ONE, IS THERE A WORKAROUND FOR OFFERING, SORRY I THINK IT JUST MEANS OFFERING SECONDARY COPIES THAT ARE DUPLICATES WE HAVE HELD FOR MORE THAN FIVE YEARS? -- LESS THAN FIVE YEARS?

THAT SHOULD BE A REGULAR OFFER BECAUSE THE, IF I'M NOT MISTAKEN YOU CAN DO THAT BECAUSE IT MEETS THE REQUIREMENTS, DUPLICATES YOU CAN OFFER THOSE TO THE EXCHANGE. I DON'T BELIEVE THAT IS A PROBLEM. CORRECT ME IF I AM WRONG, LISA, DONALD, ANYONE. I THINK THAT SHOULD BE GOOD.

FOR THOSE, YOU SHOULD USE THE CHECKBOX TO INDICATE THAT YOU DON'T HAVE A DATE EVEN IF YOU DO HAVE A PUBLICATION RECEIPT DATE. IF YOU WANT TO YOU CAN PUT IN A NOTE THAT SAYS THAT IT'S A SECONDARY COPY. THAT'S THE ONLY WAY YOU CAN GET SOMETHING INTO THE SYSTEM THAT'S BEEN PUBLISHED WITHIN THE LAST FIVE YEARS, OR IF YOUR RECEIPT DATE IS WITHIN THE LAST FIVE YEARS. JESSE IS THE DON'T HAVE A SHIPPING LIST DATE IN ORDER TO GET THAT INTO THE SYSTEM.

THANK YOU. ANY OTHER QUESTIONS? NO? MAYBE I CAN GO INTO MY WRAP-UP COMMENTS AND STILL ALLOW FOR QUESTIONS IF THAT IS --

WE DO HAVE ANOTHER QUESTION WHICH IS WHAT ABOUT DATES FOR VARIABLE ITEMS THAT PREDATE SHIPPING DATES? WERE YOU GOING TO ANSWER?

I WAS GOING TO SAY SOME LIBRARIES HAVE STAMPED ITEMS ON THEIR RECEIPT WITH A RECEIPT DATE. IF YOU STAMPED IT, YOU CAN USE THAT DATE OR YOU CAN USE -- I DON'T HAVE A DATE. EITHER ONE WORKS.

WAIT A MINUTE OR TWO HERE. ANY OTHER QUESTIONS? WELL, MAYBE I CAN GO TO MY WRAP-UP COMMENTS, KEEP THOSE QUESTIONS COMING IF YOU HAVE THEM, PLEASE PUT THEM IN THERE. ALL RIGHT.
