OFFICE OF THE LAW REVISION COUNSEL



- An independent, nonpolitical office within the House of Representatives
- A team of 17 individuals including—
 - 7 attorneys who maintain the United States Code
 - 4 attorneys who prepare positive law codification bills
 - 3 support staff for technical, editorial, and clerical functions
 - 2 former employee contractors and 1 GPO detailee

WHAT IS THE UNITED STATES CODE?

- Codification of *general* and *permanent* Federal statutory law
 - Organized into 53 broad subject matter titles
 - Titles are of 2 types
 - Non-positive: Editorial arrangement of individual acts of Congress
 - Positive: Reorganized and restated title enacted by Congress
 - Currently 27 of 53 titles are positive law, but only account for 25% of content

HISTORY

- **Committee on Revision of Laws (1868-1946)**
 - **1874 Revised Statutes**
 - 74 titles
 - Repealed laws enacted up to December 1, 1873
 - **1878 Revised Statutes**
 - 2nd Edition to remedy problems in 1st edition
 - Underlying laws not repealed; subsequent legislation not incorporated
 - **1919-1920 Reorganization work begins**
 - 50 titles
 - Acts disassembled and recombined; substantial editorial involvement
 - Bills introduced in three Congresses passed House but failed in Senate

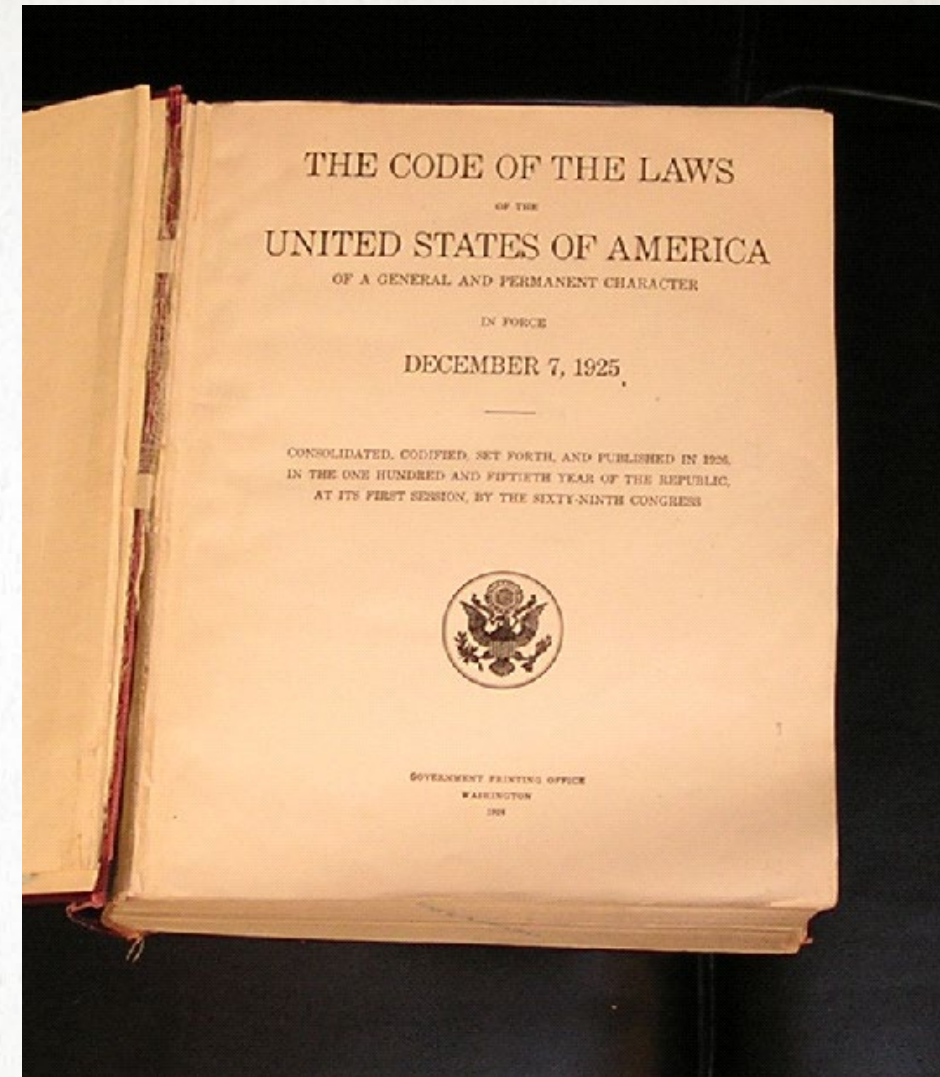

HISTORY

- **1926 United States Code**
 - United States Code was *adopted* but not *enacted*
 - Underlying statutes not repealed
 - Code recognized as prima facie evidence of law
 - Titles to be enacted one at a time into positive law
- **1946 Merger with House Judiciary Committee**
- **1974 Office of the Law Revision Counsel created**
 - Get a better handle on production of the Code
 - Speed up effort to enact titles into positive law



UPDATING THE U.S. CODE

- 5,000 to 8,500 pages of new legislation enacted in each Congress
- Integrating new law into the Code involves 4 steps:

Classification

Text preparation

Text execution

Publication

An Act

To amend title 28, United States Code, to modify the composition of the eastern judicial district of Arkansas, and for other purposes.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled,

SECTION 1. SHORT TITLE.

28/1 note new This Act may be cited as the "Divisional Realignment for the Eastern District of Arkansas Act of 2019".

28/83(a) SEC. 2. REALIGNMENT OF THE EASTERN DISTRICT OF ARKANSAS.

Section 83(a) of title 28, United States Code, is amended to read as follows:

"Eastern District

"(a) The Eastern District comprises three divisions.

"(1) The Central Division comprises the counties of Cleburne, Cleveland, Conway, Dallas, Drew, Faulkner, Grant, Jefferson, Lincoln, Lonoke, Perry, Pope, Prairie, Pulaski, Saline, Stone, Van Buren, White, and Yell.

Court for the Central Division shall be held at Little Rock.

"(2) The Delta Division comprises the counties of Arkansas, Chicot, Crittenden, Desha, Lee, Monroe, Phillips, and St. Francis.

Court for the Delta Division shall be held at Helena.

"(3) The Northern Division comprises the counties of Clay, Craighead, Cross, Fulton, Greene, Independence, Izard, Jackson, Lawrence, Mississippi, Poinsett, Randolph, Sharp, and Woodruff.

Court for the Northern Division shall be held at Jonesboro."

SEC. 3. EFFECTIVE DATE.

28/83 note new This Act and the amendment made by this Act shall take effect on the date of enactment of this Act.

- Enrolled bill from Clerk's Office
- Team of attorneys reads each bill start to finish
- Lead classifier makes final decisions
- Goal is thorough, but quick, review of new laws
- Typically finished classifying before public law number issued

CLASSIFICATION CHALLENGES

- Bills often cover multiple subject areas
- Drafters typically don't give much thought to how a law will appear in the Code
- Bills are often a mixed bag of
 - general and special provisions
 - permanent and temporary provisions
 - amendatory and freestanding provisions

NATIONAL PARK SERVICE

OPERATION OF THE NATIONAL PARK SYSTEM

For expenses necessary for the management, operation, and maintenance of areas and facilities administered by the National Park Service and for the general administration of the National Park Service, \$2,888,424,000, of which \$11,661,000 for planning and interagency coordination in support of Everglades restoration and \$110,980,000 for maintenance, repair, or rehabilitation projects for constructed assets and \$188,184,000 for cyclic maintenance projects for constructed assets and cultural resources and \$10,000,000 for uses authorized by section 101122 of title 54, United States Code shall remain available until September 30, 2025, and not to exceed \$15,000 may be for official reception and representative expenses: *Provided*, That funds appropriated under this heading in this Act are available for the purposes of section 5 of Public Law 95-348: *Provided further*, That notwithstanding section 9 of the 400 Years of African-American History Commission Act (36 U.S.C. note prec. 101; Public Law 115-102), \$3,300,000 of the funds provided under this heading shall be made available for the purposes specified by that Act: *Provided further*, [That sections 7(b) and 8 of that Act shall be amended by striking "July 1, 2024" and inserting "July 1, 2025".]

36/101 nt prec

In addition, for purposes described in section 2404 of Public Law 116-9, an amount equal to the amount deposited in this fiscal year into the National Park Medical Services Fund established pursuant to such section of such Act, to remain available until expended, shall be derived from such Fund.

These tables show where recently enacted laws will appear in the United States Code and which sections of the Code have been amended by those laws. The tables sorted in Public Law order may be used to identify the sections of the Code affected by a particular law. The tables sorted in Code order may be used to determine whether a particular section of the Code has recently been amended. The tables only include those provisions of law that have been classified to the Code. The text of recently enacted laws may be found through the Library of Congress CONGRESS.GOV web site.

The currency date for each section of the United States Code is displayed above the text of the section. If the section has been affected by any laws enacted after that date, those laws will appear in a list of "Pending Updates". If there are no pending updates listed, the section is current as shown.

When present, the list of pending updates provides the public law numbers of each law affecting the section in some way—either the text of the section, a statutory note set out under the section, or a table of contents preceding the section. Following the list of pending updates is a "View Details" link that provides more specific information about how each law has affected the section.

The Classification Tables can also be used to find the latest laws affecting the Code. The Classification Tables indicate which sections of the Code have been affected by recently enacted laws.

The text of public laws listed as Pending Updates or appearing in the Classification Tables can be found in a number of sources, such as the Government Publishing Office's govinfo.gov or the Library of Congress's CONGRESS.GOV database.
